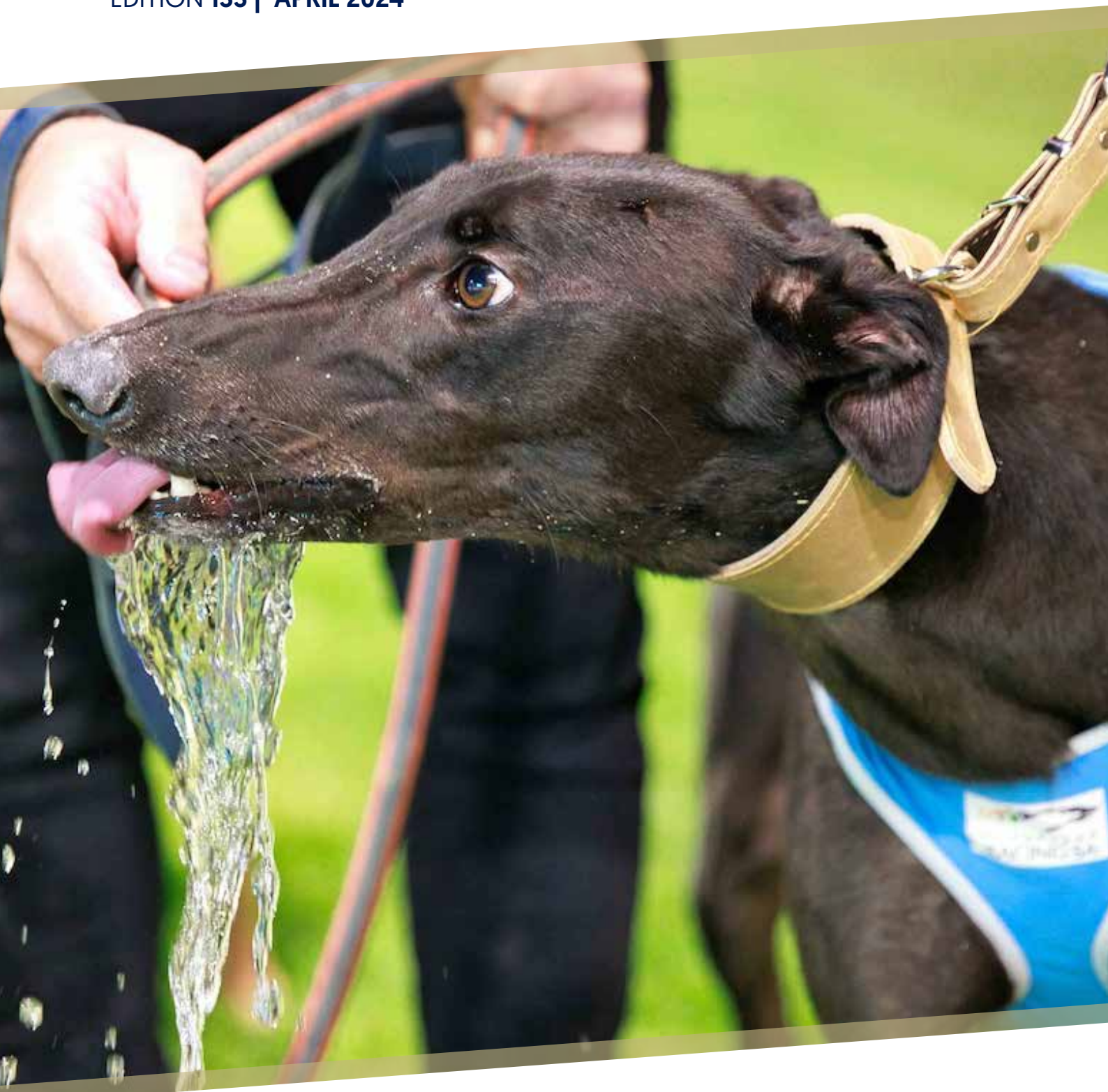

A MESSAGE FROM THE CEO

BRENTON SCOTT

THANK YOU

I begin this message by thanking each and all for the welcome and support that has been forthcoming during my first weeks in the CEO position.

Obviously, I have not been able to meet all industry stakeholders but I have made it my business to engage strongly with industry employees and club officials whilst also visiting all tracks and making myself as available as possible.

The feedback provided in the arising discussions has been gratefully received and has assured me that as a whole, we are committed to making the sport of greyhound racing as great and sustainable in South Australia as is possible.

I intend to operate with high visibility across our operations, including race meetings. I hope you find me approachable and open to a quality chat.

Born and bred in Adelaide, married (to Carole) and with three adult sons, I commenced my career in SA and spent seven years and various roles with the then SA Greyhound Racing Board. I have spent the past 28 years on the eastern seaboard, most recently with Racing Queensland as the greyhound code manager and immediately prior to that working with greyhound racing participants and the NSW Government to reverse legislation banning greyhound racing in NSW and to further determine a reform framework that underpins the operating model in that state today.

I am enjoying working in our wonderful state and I am very proud to be part of an industry that will, in the next two years, undertake all necessary initiatives to ensure SA greyhound racing embraces the required level of reform whilst laying a foundation for a successful future.

GOVERNMENT INQUIRY

Each of us are clearly aware of the importance that underlines a successful consideration of the recommendations arising from the Independent Inquiry into the Governance of the Greyhound Racing Industry.

The recommendations obviously involve change but they provide us with a wonderful opportunity to ensure all aspects of our industry oversight and practices meet gold star standards.

I assure you all that I am totally committed to managing the required reform professionally and with the intention of ensuring we meet and exceed expectations whilst also building a stronger, vibrant and resilient industry. **(continued next page)**

Our implementation of the recommendations will be overseen by an SA Government appointed Greyhound Industry Reform Inspector and that appointment is expected to be announced in the immediate future.

I am pleased to advise that, even prior to the appointment of the GIRI, GRSA management has been industrious in its readiness for the appointment, progressing to completion a significant percentage of the recommendations already.

FUTURE IN FOCUS SESSIONS

Communication and meaningful stakeholder engagement are key components in any industry seeking to manage change and build a stronger future. The GRSA decision to conduct a series of Future in Focus sessions aligns very much with this ideology.

The Future in Focus sessions have been presented with the following intentions:

- To provide the GRSA Board and management representatives with the opportunity to update industry participants on the progress of the Government Inquiry recommendations; and
- To provide industry participants with the opportunity to communicate directly with GRSA, ask questions and provide important feedback on key industry challenges to assist in shaping our future beyond the Inquiry.

At the time of writing, FIF sessions had been undertaken at both the Gawler and the Murray Bridge track. Attendance was good and some well thought out questions ensured some really positive discussion and valuable feedback.

INDUSTRY STRATEGY

The current GRSA Strategic Plan was prepared in 2019 and last reviewed in 2022. Since then, the industry has endured two major animal cruelty incidents and the Government Inquiry has been undertaken.

Given this, GRSA will undertake a refresh of the plan with a view to ensuring its objectives remain relevant, are added to where required and are appropriately prioritised so as to ensure the plan is fully aligned with current business needs.

The refresh will be completed by mid-June and will involve appropriate levels of input from participants, GRSA management and the Board, ultimately providing clarity and guidance to industry contributors over the next 18 months.

EXECUTIVE FOCUS

Mindful of the challenges before us, small changes have been made to the GRSA executive level management. Ultimately, the changes will ensure that key operational decisions will be made with appropriate executive input from racing, operations, finance, risk/compliance and

integrity/welfare.

In addition, the appointment of Ben Kavanagh as Chief Operating Officer is a targeted response to a gap analysis of current organisation output. Ben will play a key role in the further development of club and participant relations whilst leading marketing, hospitality and strategy.

Ben brings with him a wealth of knowledge from his experience working across various roles including as the head of AFL Victoria as well as CEO roles with the South Adelaide Football Club and Adelaide 36ers.

Ben is also well known in the greyhound racing industry having previously been a GRV employee and served as a GRSA board member and as interim Chief Executive Officer prior to my appointment.

GREAT RACING... IN ALL ITS FORMS

It has been a pleasure to attend some superbly presented feature race meetings in recent weeks with three stand outs being the Murray Bridge Cup [Sunday, March 17] the Easter Thursday meeting at Angle Park and the Mount Gambier Cup [Sunday April 15].

Adhana Rico [Cameron Forshaw] was all class in his Murray Bridge Cup victory while Riot Rooster [Ben Rawlings] won the Easter Match Race series and Like Wildfire [Tim Aloisi] the Easter Cup, both in dominant style. In the Mount Gambier Cup, Chapel Road [Kiah Hurley] scored with an exceptional front running effort.

Each of these meetings attracted excellent crowds and were great examples of our best racing being well presented, well marketed and eagerly received by the customer base. It would be remiss of me to not call out the excellent management efforts in each promotion and, in the case of Murray Bridge and Mount Gambier, the tireless contributions of the committees and other club volunteers.

At the other end of the scale, I attended a couple of Angle Park Saturday morning meetings where, quite obviously, attendance was significantly more modest. Nevertheless, it was lovely to see the joy participants still achieved when winning... reminding us all of the responsibility we have to provide, as best we can, a competitive racing opportunity for as many greyhounds as possible, despite varying capabilities.

On the go forward, the Anniversary Cup [Angle Park, Thursday, April 25] looms as great opportunity to witness our best greyhounds in competition. With cost effective, high quality dining and viewing facilities the equal of any Australian greyhound track, there are plenty of reasons to be in attendance as some of the nation's best greyhounds chase Group racing glory!

2024 MOUNT GAMBIER CUP

For Two Wells trainer Kiah Hurley the win of Chapel Road in last Sunday's Group 3 Cadillac Racing Mount Gambier Cup [512 metres] was a case of going one better after a length second-placing behind Adhana Rico in the recent Group 3 Murray Bridge Cup [455 m].

It's now history how Adhana Rico, in a bid to collect a Greyhound Racing SA \$10,000 bonus for winning both cups, was narrowly beaten in his Mount Gambier heat and failed to make the final, given there had been eight heats.

Also history is how Chapel Road shot away around the first turn in the final, opening up a handy break and leaving fellow Two Wells greyhound Paua Of Silence to do the chasing.

But in the run home it was Mighty Quinn who threw out the challenge, something he did gallantly when going down by two lengths in a winning time of 29.56 seconds. Finishing a further two lengths back in third spot was Paua Of Silence.

Odds-on favourite Uriel Bale, a brilliant heat winner the previous week in a track record 29.15 seconds, found himself in trouble on the first turn and from then on was never really a chance.

Let's not take anything away from Chapel Road and his trainer, though, who certainly put in the hard yards in a bid to win the Mount Gambier Cup – to the extent of making sure the black dog trialled at Tara Raceway.

"This is by far my biggest win and to be honest it hasn't really sunk in yet," an over the moon Hurley said. "I'm not sure how many times I watched the race replay on the way home.

"I have to say, though, the win was a real family affair with my partner Justin [Tribe] the backbone of the operation. Granny and my sister Jayde also are a great help.

"From a family point of view the only disappointment is that my Pa [John Hurley] didn't live long enough to also enjoy our greatest win."

By Bernardo out of 11-race winner Sunset Seniorita, Chapel Road was purchased after falling in a race at Sandown Park in November last year by a syndicate managed locally by Nick Lalli and Troy Maynard.

"At the time he was being trained by Andrew Xerri who suggested to Justin that Chapel Road would be a good purchase to race in SA," Hurley said.

"He was then off the scene for about five months with minor injuries before he raced in SA at Murray Bridge where he won a heat of the Murray Bridge Cup."



Hurley's first win at Tara Raceway was back in June 2021 with a greyhound called Sarcasmic – raced by Victorian-based Jeff Galea, whose son Ryan was represented in last Sunday's cup by Bern By.

It has to be said the 2024 Cadillac Racing Mount Gambier Cup meeting went off pretty well. Extensive promotion resulted in a top crowd – the best ever, some suggested.

And as far as the cup itself went, handlers looked resplendent in their white Mount Gambier souvenir tops which included the greyhound's name and "2024 Cadillac Racing Mt. Gambier Cup". The runners weren't forgotten, either, as their race rugs included the MGGRC logo and their names.

Recently appointed Greyhound Racing SA CEO, Brenton Scott, best summed up the day from a club point of view.

"On behalf of the GRSA chairman Grantley Stevens, director David Lewis and the management representatives of GRSA in attendance, I congratulate the committee, management, employees and volunteers of the MGGRC in relation to the promotion and presentation of the Mount Gambier Cup.

"It was truly a pleasure to attend the race meeting and to be part of what was genuinely a community celebration point. The effort, energy and care factor shown by those involved in the planning and execution of the event was obviously at the core of its success.

"GRSA is extremely keen to work with its club network to optimise outcomes in the interface between our sport and the general community. It is very clear that, in the case of Mount Gambier, a very high performance standard is already in place.

2024 EASTER RACE NIGHT

An annual highlight on the Angle Park Calendar each year is the Easter Thursday race meeting which once again featured the EASTAR Match Race Series and the Easter Cup over the 595m journey.

Featuring eight of SA's best chaser, the EASTAR Match Race Series was taken out by Ben Rawlings trained Riot Rooser who defeated Victa Marli in his match race and claimed the overall title with a time of 30.34.

Woodside Johnny for Graham Smith was second overall after defeating Whiskey Soda in a personal best time of 30.43

Other match race winners were Adhana Rico who defeated My Khaleesi and Fantastic Ada. who defeated Doonan.



The Easter Cup over the 595m journey was taken out by SA newcomer Like Wildfire who is a perfect six for six at Angle Park since crossing the border.

After clocking a quick time of 34.16 in his heat, Like Wildfire went even quicker in the final running a new personal best at the track of 34.06.

Magical Mystic for Bosko Stamenkovic was an excellent run for second while Zipping Neutron also for Tim Aloisi rounded out the podium.

Like Wildfire boasts a career record of 26 starts for 18 wins and his next assignment is 'The 715' feature race at The Gardens in New South Wales.

JUNE - The Run of the Month for June was the Ashlee Griffiths trained Cash On Delivery for his blistering run at Gawler on Friday, 9th June over the 400m journey where he went with in .02 of the track record. After being only .01 and .02 away from the record in May he again showed his brilliance by leading throughout in a sizzling 22.29 in winning by 6.50 lengths. He has been a dominate campaigner over the short course at

Gawler during the year winning 12 races.

JULY - The Run of the Month for July was the Tim Aloisi trained Zipping Neutron for his track record performance at Mount Gambier on Sunday 23rd July over the 732m journey where he ran 42.73 in winning by 11.75 lengths. After racing up on speed he took over during the later part of the event to race away in a powerful performance. He smashed the previous track record by .31 second in an amazing performance.

SEPTEMBER - The Run of the Month for September was the Des Hockley trained Nicola Rose for her amazing win at Gawler on Friday, 29th September over the 531m journey in a Grade 6 event. She went up with the lids from the inside box when the boxes flew open losing around 6 lengths from the field. She made ground through the field down the back straight, however, she was still 6 lengths off the lead off the back straight, she sprouted wings late to claim the leader and go on and win by a length in a solid 30.88. Visually one of the biggest runs seen in SA this year

OCTOBER - The Run of the Month for October was the Tim Aloisi trained Zipping Neutron for his brilliant win at Gawler on Monday, 23rd October over the 643m journey in a Heat of the Bothing Gawler Stayers Cup. Zipping Neutron began well from box 4 and raced near the lead during the early stages before he powered to the front mid race to open up an unassailable lead. He raced away from his rivals to win by over 5 lengths, however, the time recorded was breathtaking. He ran 36.92 which was only .11 outside superstar Bothing’s track record set in 2006 which the series is named after. By all reports he is the only greyhound to break the magical 37 seconds barrier since the track record was set 17 years ago

NOVEMBER - The Run of the Month for November was the Gavin Harris trained Lena Jinx for her sensational track record performance at Angle Park on Thursday, 16th November over the 730m journey in a Free For All staying event. Taking on the king of stayers in Zipping Neutron, she quickly jumped to the front in a small field, from there she gave nothing else a chance winning by over 7 lengths. The time had to be fast because “Neutron” could only manage third place so when the 42.29 was semaphored it made sense that she smashed the track record by around three lengths.

GOTBA COURSING KICKS OFF THIS WEEKEND

GOTBA at Virginia will hold their first Coursing meeting for 2024 this Sunday, 21st April. Further dates until the end of June are Sunday May 5th, Sunday May 19th, Sunday June 2nd and Sunday June 16th .

RACING AND TRIALLING FREQUENCY REMINDER

GRSA adopted a new local rule in regard to frequency of racing and trialling which was implemented on Wednesday, 1st February, 2023.

Rule 69A Racing and trialling frequency

[1] In this rule:

Race has the same meaning given to this term in R9 of the GAR.

Trial means a satisfactory trial, or a qualifying trial as defined in R9 of the GAR.

[2] A greyhound will only be permitted to start in [a] No more than a combined total of 2 race and trial starts in any 7-day period; and,

[b] No more than a combined total of 7 race and trial starts in any 28-day period.

[3] This sub-rule commences on a date to be fixed by Stewards' Notice.

The intent of this rule is to monitor and regulate the frequency of races and official trials of greyhounds, to ensure adequate rest time is given between events. The rule is similar to one in effect in Western Australia. We have automated the Ozchase Racing system to be able to monitor this rule. The rule is self-explanatory.

A greyhound must not start more than 2 times [races or trials combined] in any 7-day period. Further, a greyhound must not start more than 7-times [races or trials combined] in any 28-day period.

Any attempt to nominate a greyhound outside these parameters will be flagged by the OzChase system. If a greyhound gains a start from reserve deeming it ineligible under this rule for its next engagement or it competes in another state prior to racing back in SA then the greyhound will come out.

**Racing Administration staff will scratch these greyhounds acting under this rule without notification [the responsibility rests with the trainer to ensure they do not contravene this rule].

**For clarity if a greyhound races on Sunday, Wednesday then Sunday it will be eligible. The first day counts as day 1 and therefore resets on the Saturday.

LOW GRADE FEATURE SERIES AT ANGLE PARK

The next Low Grade Feature Series at Angle Park will be a Grade 5 for Male greyhound ONLY over the 530m with \$4,050 Heats on Thursday, 2nd May with the \$5,810 Final on Thursday, 9th May.

VACCINATION RULE FOR RACING IN SA

Trainers are reminded that Rule 25 [Minimum Vaccination Requirements] took effect Monday, 1st May, 2023. Vaccination Certificates must be received by GRSA prior to close of nominations for affected greyhounds to be considered eligible for nominating. Trainers are also reminded that they must not have their greyhound vaccinated within 5 days of racing. Should this occur, the greyhound will be scratched from its engagement.

2024 GROUP 3 HOWARD ASHTON HEATS – NOMINATIONS CLOSE MONDAY 9TH MAY

The major race for Breeders 2024 is the Group 3 Howard Ashton. Trainers are reminded that the \$3,700 Heats will be run on Thursday, 9th May.

These will be followed by the \$4,500 Semi-Finals on May 16th and the \$37,500 Final on May 23rd.

This race is for greyhounds that are eligible for Breeders 2024. Greyhounds didn't have to have compete in the Preludes to run in the Group 3 Howard Ashton.

SHANE MCQUEEN HEATS IN LATE MAY

The main 595m feature at Angle Park comes up on Thursday, 23rd May with the running of the \$6,315 Heats of the Shane McQueen. This series has always been well supported by the Industry with three or four Heats normally run. The \$14,275 Final will be held on Thursday, 30th May.

BAYROAD QUEEN STAYERS HEATS IN JUNE

The \$7,140 Heats of the Bayroad Queen Stayer's Cup will be run over 730m on Thursday, 13th June . The \$14,275 Final will be run on Thursday, 20th June .

GAWLER ANNIVERSARY CUP IN JUNE

MURRAY BRIDGE EMPTY OUT AREA

The Murray Bridge GRC request that if trainers wish to use the emptying out facilities at Murray Bridge they are required to pick up after their dogs, showing consideration for other users.

The ICG selection panel were very appreciative in the applications for this group and would encourage those unsuccessful or interested to consider applying again in the future.

BREEDING SUPPORT CLAIM RESTRICTION REMOVED

In July of 2022 after consultation with the ICG, GRSA introduced a restriction on the number of Breeders Support Claims that could be applied for in a 12 month period to assist with sustainable breeding. At the most recent ICG meeting, and after reviewing current and forecast breeding numbers it was agreed to remove this restriction effective immediately in support of our current breeders. There is no retrospectivity regarding claims that were not processed due to the policy at the time. Please contact Racing Manager, Shaun Mathieson for further information if required.

SA BRED UPDATE

The pool of money is \$45,000 per month.

These winners all receive a \$225 base payment with \$75 to the Owner & \$150 to the Breeder.

The SA Bred Bonus scheme is continuing to go over budget with the number of SA Bred winners increasing. For the month of July there were 203 winners, August 197, September 196, October 226, November 209, December 218, January 218, February 194 and March 179. This means that we are currently 40 winners over budget for this financial year.

CALL FOR SUBMISSIONS ON PROPOSED AMENDMENTS TO THE GAR

Greyhounds Australasia [GA] proposes amendments to the Greyhounds Australasia Rules [GAR] in the following areas:

- Ear tattoo rules removal;
- Breeding rules;
- Prohibited substances; and,
- Welfare and racing.

The next step in this process is consultation with industry and relevant, external stakeholders and calling for submissions on the proposed amendments.

SUMMARY OF PROPOSED AMENDMENTS

EAR TATTOO RULES REMOVAL

By July 2024, the requirement for ear tattoos for pups is proposed to end. GA and Controlling Bodies (including GRSA) are considering the expanded use of DNA fingerprints to further and better identify greyhounds. Microchips will remain the primary source of identification.

BREEDING RULES

GA seeks to consolidate various rules and policies, used by Controlling Bodies, into one set of rules to prescribe breeding (for example, number of litters and age of breeding females, fertility tests, veterinary certification and caesarean section). Adoption of a national approach to breeding will result in those provisions of our Local Rules being repealed (and adopting the national approach).

Further, GA seeks to strengthen rules and sanctions around exporting greyhounds and breeding units of semen.

PROHIBITED SUBSTANCES

GA seeks to prohibit the use of Bisphosphonates. Bisphosphonates are drugs that inhibit the normal biological mechanism for bone maintenance/repair, which can lead to increased bone fragility. Bisphosphonates can also cause retention of calcified cartilage in skeletally immature animals, leading to developmental orthopaedic disease.

Further, GA seeks to add ethinylestradiol and/or levonorgestrel to the exempted substances available for veterinary prescription for the control of oestrus in female greyhounds.

WELFARE AND RACING

GA seeks to amend the GAR to clarify rules relating to welfare and racing. This includes amendment of the rules relating to the definition of "presentation" and "presented". Presentation or presented means a greyhound is presented for an event as from the time commencing at the appointed scratching time of the event the greyhound is nominated for, and which continues until the time a greyhound is removed from the racecourse after the event unless directed by the Stewards pursuant to GAR 94[2]. Where a greyhound is presented for an event and

the Controlling Body requires a sample to be taken from the greyhound, presentation at the event is deemed to continue until the sample is taken notwithstanding the scratching of the greyhound.

GA also seeks to amend GAR 76 relating to measures imposed in the event of a greyhound being scratched from an event after the drawing of boxes. Under the current provisions of GAR 76[2] and GAR 76[4], the standdown measures imposed commence on the date of the event. In the scenario whereby a greyhound is scratched in the days between the box draw and the event, a loophole exists whereby a greyhound may compete in an alternate event as the stand-down does not commence until the day of the original event. For example, scratch on Tuesday from a Friday race, but race on the Wednesday before penalty commencement (Friday). The draft amendments to GAR 76, seek to close out such a loophole by ensuring that the stand-down commences at the time of scratching and continues for the period outlined from the day of the event.

Further, GA seeks to amend GAR 42 which looks to capture any veterinary episode, described within GAR 42, that occurs on a racecourse. The proposed rule amendment, part (d) of GAR 42, provides clarity concerning the location and application of a sanction to a greyhound that suffers a prescribed veterinary episode including seizure or collapse.

TREATMENT RECORDS AND MEDICATION

GRSA would like to remind participants to keep an accurate record of all vaccinations, antiparasitics and treatments administered to any greyhounds on their premises.

- It is recommended antiparasitic medication is given routinely, even when parasites are not present. Example treatments include Aushound, Simparica and Nexguard Spectra.

Medication prescribed by veterinarians MUST be administered in accordance with the veterinarian's direction and disposed of at the end of its course.

Medication administered to a greyhound that is not individually prescribed to that greyhound may incur a penalty.

Greyhound of the Month for March was Adhana Rico for trainer Cameron Forshaw, who had three starts for the month with two wins and a third, his highlight being victory in the Group 3 Murray Bridge Cup Final in the middle of the month.

The son of Fernando Bale and Bella Rico started the month off with a strong win in the Heats of the Murray Bridge Cup winning by 3 lengths in a handy 25.51. He then stepped out in the Final as the favourite, however, had to overcome box 5. He did this with ease, beginning brilliantly and leading in the initial stages. From there he was never headed running brilliant time in the lead and going on to win by 1 length in a slick 25.22. His next assignment was the Easter Match Race series where he started a raging hot favourite. He was drawn in the last match with a time of 30.34 to beat, he ran well, however, his time of 30.51 placed him 3rd in the feature head to head series.

At the end of the month Adhana Rico's record stood at 71 starts for 27 wins and 24 placings and earnings around \$205,000.



The Run of the Month for March was the Tim Aloisi trained Like Wildfire, for his win in the Easter Cup over the 595m at Angle Park on Thursday, 28th March.

The son of Goodesy and Freaky Tears has created a huge impression since arriving in SA and showed his brilliance in the middle distance feature. He began well and challenged for the lead in the early stages before running to the front on the first occasion. From there it was about times and margins as he raced away from his rivals for a terrific win. He won by 2.25 lengths in a brilliant 34.06.

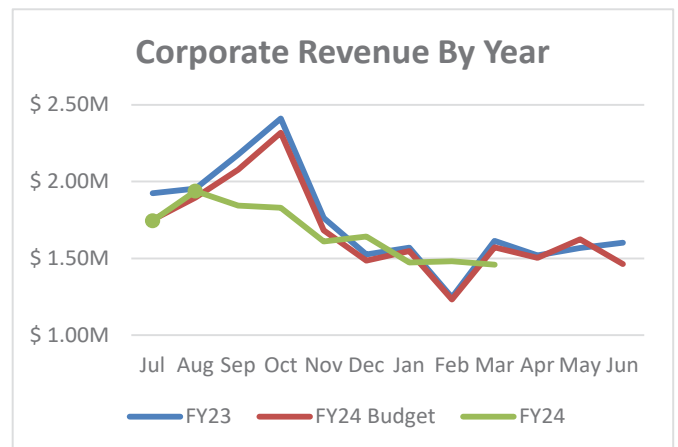
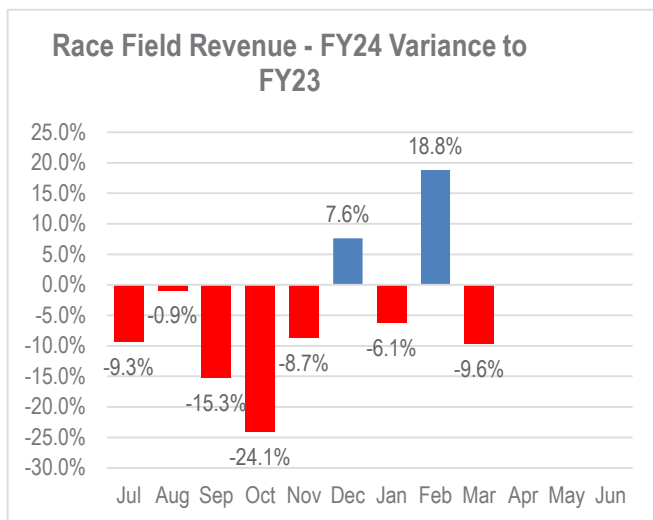

Greyhound Racing SA Limited (GRSA) wishes to advise participants that there is no Wagering Activity Payment (WAP) for the month of March 2024.

As participants are aware, the WAP calculation is based on the net wagering revenue generated each period. With wagering being 9.6% lower in March 2024 compared to the same month of the previous year, increased prizemoney totalling 12.5% in calendar year 2023 (January 2023 7.5% and December 2023 5%) it has resulted in there being no WAP payable.

As can be seen from the second chart below, overall wagering revenue year to date for financial year 2024 is down 7.2% on the previous year. GRSA is continuing to monitor revenue trends closely and notes that this reduction in revenue is being felt across most racing jurisdictions. It is considered the reduction is an indication of the negative impact that higher inflation and interest rates are having on the disposable incomes of the wagering public.



As listed in the calculation below total payments to participants exceeded the 50% WAP benchmark return and thus no payment will be made for March 2024.

Payment of placement fees

The \$60 placement fee is due at the time the placement form is submitted, payment can be made by either completing the card details on the form or by paying in cash. The placement form will only be processed, and the greyhound placed in GAP, once payment has been received.

Kind reminder from GAP:

Please submit a placement form if your greyhound has already passed the GAP first point assessment.

If you have not submitted the placement form within six months after the assessment, your greyhound will have to be re-assessed by GAP.

If your greyhound returned to racing or trialed after a successful assessment, it will have to be re-assessed after a 10-day downtime again. Thank you!

As previously advised, GAP have been increasing the number of assessments in the monthly schedule.

We continue to look to increase these further in order to offer a wider variety of times to meet participants varying requirements.

TRIALS

QUALIFYING AND SATISFACTORY TRIALS

Angle Park qualifying and satisfactory trials are held every Tuesday night between 6.50pm and 7.15pm. Qualifying will be for the following Monday meeting (drawn Thursday). Nominations close at 12.30pm on the Tuesday (for online nominations 11.59pm Monday).

Gawler qualifying and satisfactory trials are held every Thursday morning from 7am. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm Wednesday the day prior.

Murray Bridge qualifying and satisfactory trials are held fortnightly on a Wednesday night (between the end of the straight track trials and the beginning of the one turn track trials). Normal trials start at 4:00pm during non-daylight savings and 5:30pm during daylight savings. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm on Wednesday (for online nominations 11.50pm Tuesday).

ANGLE PARK

SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number or alternatively logon to trialbooker.com, create an account and book your own trials.

POLICY FOR TRIALLING AT ANGLE PARK, GAWLER AND MURRAY BRIDGE BEFORE THE RACE MEETING

Policy Background

This policy is to detail the procedure for trainers seeking greyhounds to trial before race meetings. This policy is effective from 2 May 2019.

Race Meeting Trial Policy

This policy is in place for the following race meetings:

Angle Park Monday, Gawler Wednesday and Sunday, Murray Bridge Tuesday, Friday, and Sunday.

Two fields from the boxes with a maximum of four (4) greyhounds. Trials may be conducted at any time during the race meeting from immediately after kennelling until after the last race, at Stewards' discretion.

The following lists the order in which greyhounds will be selected in the event if more than eight (8) greyhounds are nominated:

1. Reserves at the meeting that do not obtain a start
2. Trainers that have greyhounds engaged and are located more than 100km in distance from the track
3. Satisfactory trials

Procedure/criteria

1. For Angle Park Monday night, the trainer is to contact GRSA between 9am and 10am on Monday to nominate. Should the Monday be a public holiday bookings are to be made between 8am and 9am on the scratching number.
2. For Murray Bridge Tuesday & Friday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Murray Bridge Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
3. For Gawler Wednesday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Gawler Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
4. Other than reserve greyhounds, trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
5. Stewards will allocate the box for the greyhound.
6. Trials will be 515m, 530m & 531m in distance as first preference. Other distances considered depending on nominations.
7. Greyhounds currently under suspension are ineligible to trial unless they are undertaking a satisfactory trial to be cleared.
8. Greyhound registration cards must be produced at kennelling time.
9. Trainers with other greyhounds engaged can utilise the extra kennel space until such time they are ready to leave. Trainers with no other greyhounds engaged will be permitted to leave with Stewards permission.
10. At Murray Bridge, trials will only be available on the track that is prepared to race that day i.e. Friday meeting on the u-shaped track, trials will be on the u-shaped track only.

Please note: If there are 12 races at Angle Park, Gawler or Murray Bridge there will be NO trials.

The Angle Park Vet Clinic and/or swab kennels cannot be used to accommodate any additional greyhounds due to operational requirements of the Clinic and Stewards.

It is vital that trainers nominate to trial at these race meetings. If you are unable to nominate at these times, please contact GRSA as soon as possible as permission may be given at GRSA's discretion to accept bookings outside these times.

Exceptions to this policy

Thursday nights are kept available for interstate greyhounds to solo trial in a lead-up to SA Group races as well as local greyhound's trialling for Group racing interstate.

Upon request, local greyhounds will be allowed to solo trial in a lead-up to a feature race and they will take one of the eight (8) kennels available for trialling greyhounds ahead of the policy and sit separate to the four (4) dog trials. Races considered to be a feature are: Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals and any interstate Group race

Local greyhounds will be permitted to trial on a race night, where they are in preparation for a feature event, nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy. If a greyhound qualifies for a feature final and requires a trial in between, this will be conducted as a solo trial and will sit separately to the four (4) dog trials.

MOUNT GAMBIER SATISFACTORY TRIALS

Mt Gambier hold trials on Wednesday and Saturday mornings with Satisfactory trials ONLY being conducted on Wednesdays and need to be booked with Barry Shephard from the Club on 0419 824 512 no later than 12pm the day before.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shephard.

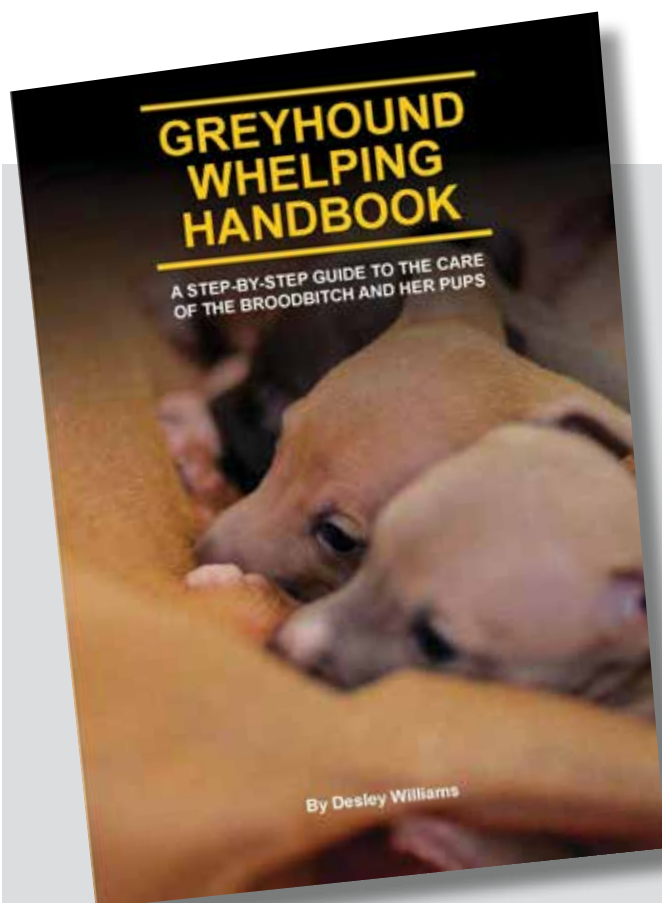

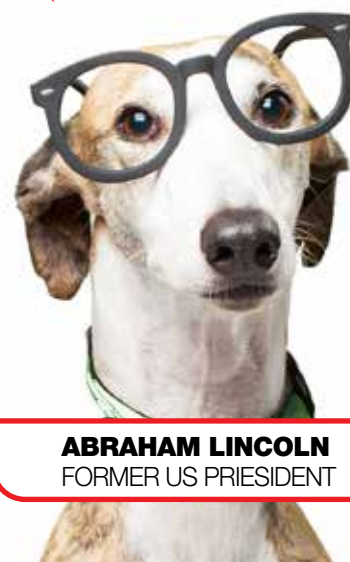
