CEO'S UPDATE

An announcement has gone out this afternoon which identifies the cuts that GRSA has made and will be making across the business, including staff stand downs and reductions, and changes to stakemoney. Putting to one side the recent issues that we've experienced in relation to the decreasing liquidity of UBET pools, the loss of meetings to hot weather, and the severity of the recent gastroenteritis outbreak – the bigger threats facing the sport in SA currently relate to the risk of a forced [temporary] shut-down and the potential longer-term damage to our revenue model as a result of the impact that Covid-19 restrictions may have on retail wagering activity.

GRSA has a strong balance sheet and has worked hard to achieve that over many years which means we can be resilient at times such as these. The first, and most important priority, is to preserve the opportunity that we have been afforded to continue racing. The changes that are coming in are an immeasurably better outcome than the implications of any forced closure of racing and we need to remember that, in this regard at least, we are relatively fortunate compared to many. All of our trainers and raceday staff are to be commended on their patience with the extreme measures which needed to be implemented to ensure that we could conduct racing safely.

The pending reductions are intended as temporary measures only and, as our circumstances rebound and we can see that the risk has reduced, the circumstances for both staff and participants will be reviewed and addressed simultaneously. There is no timeframe on when that will occur however.

This is a time for all of our people to recognise that we are all part of one unit, whether you are a 'big kennel' trainer, or the person who photocopies the form guides for race meetings, or the racecaller, we are all inextricably tied to the fortunes of our industry. This has obviously been a challenging couple of months with the changes to our weekly meeting schedule and the ongoing issues that all of us are facing in relation to social distancing and community isolation, but all of this will be behind us soon enough. In the meantime, we all need to remember that there is strength in unity, and that no-one is 'doing it easy' during this unprecedented moment in time.

GRSA MAKES TEMPORARY CHANGES IN RESPONSE TO COVID-19 RESTRICTIONS

Whilst GRSA unconditionally applauds the measures that have been taken at both a state and federal level to implement timely restrictions aimed at reducing the spread of COVID-19, the revenue model for racing in South Australia is being negatively impacted by those changes. During this challenging time, our organisation has continued to work closely with the State Government and we remain grateful for its efforts and the broader commitment of support that it has indicated with regard to the racing industry.

Of greatest concern is the extent to which retail UBET clients appear to have been unprepared for a shift to digital wagering platforms when the COVID-19 restrictions were introduced, noting that betting activity in pubs, clubs and casinos has typically accounted for 70% of GRSA's Product Fee payment. In response to the uncertainty that now confronts GRSA in the months immediately ahead, and then 'beyond COVID-19', the Board of GRSA has resolved for the following changes to be implemented from May 1.

All members of the GRSA Management team will accept a 20% reduction in remunerable hours down to 0.8FTE and participant stakemoney returns will be reduced overall by 15% in line with the following changes:

- All standard 'graded' meeting payments to winners and placegetters will reduce by 15%
- The current allocation to travel fees for trainers and starter fee payments will remain unaffected
- SA Bred payments will remain unaffected with the exception of the Maiden winner bonus reducing from \$1,000 to \$500 and the Group race super-bonus scheme being discontinued after FY22
- Feature race top-ups for series and events which are resolved in FY21 (i.e. date of final) will reduce by the equivalent of \$200,000 annually (a further announcement will follow)

These changes are intended as temporary measures and will be wound back (in concert) at a time when the Board views that as being an appropriate and responsible measure to take, but no date or timeframe has been identified. They come on top of a separate wave of staff stand downs due to the forced closure of GRSA's gaming and hospitality offers and other reductions relating to broader operational contraction, also within the context of COVID-19 restrictions. The Board's position is motivated by ensuring that the burden of current risks and impact is being shared across the breadth of the operation so that GRSA is best-placed to rebound within the context of a future recovery phase.

In the months ahead, GRSA aims to gradually return to a full schedule of eight weekly race meetings as state border restrictions are lifted and racing numbers improve. The Mount Gambier region has been particularly affected by the loss of participation from Victoria in recent weeks and GRSA is working closely with the Club to retain a viable weekly racing opportunity at that venue.

Weekly racing at Gawler will return to the Sky schedule in May, which should be welcome news for northern participants already dealing with the loss of trialling opportunities due to the Government's temporary closure of the Virginia straight track. Noting the current unavailability of that facility, the Coursing season has been deferred indefinitely. More broadly, with minor exceptions, existing participant licences will be rolled over for a 12-month period with no fees to be charged in the interim.

Further to recent consultation with the ICG and senior industry stakeholders, the Racing Manager and Grader have been afforded heightened discretion – with regard for the underlying spirit of the grading framework - to vary the approach they take to determination of field sizes, extensions of nomination, and other related decisions to maximise wagering revenue and protect opportunities to participate. In the same spirit, GRSA intends to respond fluidly to any opportunities which present within the Sky schedule, should such arise.

In noting that these are unprecedented times, GRSA remains committed to making the difficult decisions that are necessary to protect the future of the sport in this state. The approach that it is taking now will equip it to deal with any adversity that it may encounter in the weeks and months ahead and into the future.

Alfieri wins the second EASTAR Series

ANGLE PARK

The second running of the Eastar Match Race Series brought us another exciting night of racing with 8 of the State's fastest greyhounds going head to head in 4, 2 dog races on April 9th.

It was the Bill Wudarczyk trained Alfieri who come out on top with a blistering overall time of 29.54 for the 515m to claim the \$6,000 first prize, however, he had to wait right to the end in a nail biting finish.

In the first Match Race Alfieri took on Cairnlea Ebony for Petar Jovanovic and after a slow beginning and railing hard down the back straight Alfieri was able to race past Cairnlea Ebony and stretch away for a very quick 29.54 victory. The series favourite posted a very sharp time and most thought it would be hard for that time standard to be challenged.

The second match race was very exciting with the Ben Rawlings trained Two Times Twice taking on the up and coming Maddison Kaye for Des Hockley. As most expected Maddison Kaye showed her early brilliance to lead with Two Times Twice just in behind. Two Times Twice is very strong and angled for the inside run down the back but Maddison Kave held him off. Turning for home the run appeared for Two Times Twice who drove through and the pair settled down to fight out a neck and neck finish. Maddison Kaye held her more experienced counterpart for a great win in a flying 29.62 putting her in second spot overall.

The third match up saw the most even pair on paper, with Double By Design for Sharyn Gray taking on Wooden Tiger for Petar Jovanovic, both with very similar racing patterns. As the start was affected Double By Design jumped to the rails first with Wooden Tiger going up with the lids and missing the start, however, he did muster quickly. Like the second match race the run eventually came into the front straight for Wooden Tiger who was able to drive through for a narrow victory. His time was a very good 29.78 considering he missed the start and connections might be wondering what might have been had he gotten away cleanly.

There were only two chances left to beat Alfieri's 29.54 when It's A Riot for Ben







Rawlings and Boss McLaren for Don Foster matched up in the last two dog battle.

As the boxes flew open It's A Riot began brilliantly to lead easily to the first turn and rocketed into the back straight with Alfieri's time looking in danger. Boss McLaren was doing his best to keep up but he was just of the blistering pace It's A Riot was setting. It's A Riot was about 4 lengths quicker than Alfieri's time of the back straight, however, at only his second run back from illness race fitness was always going to play a part. It's A Riot was



brave to the line and stopped the clock in 29.6 something as the official time was about to be adjusted. The official number came up and his time of 29.58 was just outside Alfieri's time standard. He beat Boss McLaren and pushed Maddison Kaye back to third overall but Alfieri would be crowned our Eastar champion for 2020.

Alfieri is by Fernando Bale and Rhonda Rocks being bred by Bill, he is owned by Kirin Corby and Bill and now has won 21 races from 32 starts with 5 placings and career prizemoney of around \$50,000.

GAWLER TO COME BACK TO RACING ON FRIDAY 1ST MAY

The first meeting scheduled back at the Gawler venue is on Friday, 1st May. Participants are reminded that all rules and regulations currently in place for COVID-19 and Canine Gastroenteritis will continue and be enforced.

To manage the venue the Council have allowed for the gates to be locked during our race meetings being conducted so non-essential persons cannot enter. Participants and essential staff when arriving will be able to enter through gate 1, this is the furthest Eastern end gate only.

Staff at the venue will manage if persons wish to leave during the course of the race meeting.

TRIALS ON AT ANGLE PARK ANZAC DAY SATURDAY, 25TH APRIL

There will be trials at Angle Park on Anzac Day as normal on Saturday, 25th April.

2020 GROUP 3 HOWARD ASHTON

The major race for Breeders 2020 is the Group 3 Howard Ashton. Trainers are reminded that the heats will be run on Wednesday, 13th May.

These will be followed by the semi-finals on May 21st and the \$37,500 final on May 28th. Total prizemoney for heats and semis will be determined by the number of races run.

The race is for greyhounds that are eligible for Breeders 2020. Greyhounds didn't have to have compete in the preludes to run in the Group 3 Howard Ashton.

MOUNT GAMBIER TO RACE ON THURSDAYS UNDER RESTRICTIONS

The GRSA Board's strategic response to the management of both the canine and human coronaviruses that have been impacting greyhound racing operations across the State along with Mt Gambier.

The Board does not support ongoing movement on a weekly basis by Victorian trainers, regardless of whether they have secured an essential services exemption or not. A temporary prohibition on Victorian nominations for SA events remains in place. Separately, the Board resolved to quarantine the Mt Gambier region from the northern Adelaide tracks based on long-distance travel concerns [Covid-19 restriction] and in support of measures to manage the spread of canine gastroenteritis (in either direction) with Thursday being the only meeting conducted at this time.

GRSA has been liaising with the Club regarding just over the border trainers who have indicated their willingness to transfer dogs across to SA kennels. The Board resolved that to assist participation in the region to expediently transfer a number of Victorian greyhounds into SA trainership taking into account the current policy.

GRSA will continue to work with the Club regarding building their pool of greyhounds with the Thursday meetings to continue even if a 7 or 8 race program is released.



Hot Sophie claims award after a hot month

Greyhound of the Month for March was Hot Sophie for trainer Tony Rasmussen who had 4 starts for the month with 2 wins and 2 placings with the highlight being her brilliant win in the listed Murray Bridge Cup final.

The locally bred daughter of Fernando Bale and Cuddletime Tears started the month off with a solid win at Murray Bridge over the 455m where she was able to lead throughout. She then stepped out with the big boys in a heat of the Murray Bridge Cup and again showed brilliant speed to lead and was just run down in the shadows of the post by boom greyhound, Querencia. She qualified for a super strong final and started one of the outsiders but again she began very well to put herself right in the firing line. She lead the hot field up and her competitor's had every opportunity to run her down; however couldn't, and she went on to record a stirring win by a neck in a slick 25.42. Hot Sophie then ran a strong second at headquarters towards the end of the month.

At the end of the month Hot Sophie's record stood at 14 starts for 7 wins and 6 placings and earnings around \$26,000.



Sir Truculent triumphant with brilliant distance win

The Run of the Month for March was the Wally Harkins trained Sir Truculent for his brilliant win at Angle Park over the 731m on Thursday, 19th March in a Free For All event.

Blessed with loads of ability he put it all together on this night when he began well in the small field to land second early. He raced to the front mid race and then it was just a matter of how far the son of Worm Burner and Establish would win by. He careered away from his rivals to win by over 12 lengths running a sensational 42.76 for the staying trip.

This series has always been well supported by the Industry with three or four heats normally run. The Final will be held on Thursday, 4th June.

INTERSTATE GREYHOUNDS TRANSFERRING TO SOUTH AUSTRALIAN TRAINERS

GRSA currently recommends that all greyhounds being transferred into SA from Interstate are placed into relative isolation on a trainer's property for a period of 10 days. We understand that this is not always possible depending on the size and layout of each residence; however we are reliant on trainers managing the risks of each individual circumstance at their own property.

As we are seeing more and more trainers overcome the canine gastroenteritis virus impacting their kennels, it is still important to remember that many smaller trainers in the State are yet to experience an outbreak at their property. Therefore, it is still extremely important that trainers do not bring ill or possibly infected greyhounds to trial sessions and race meetings, which could increase the risks of further infections amongst the SA racing population.

Obviously the circumstances of some Interstate transfers could be considered to be higher risk, such as pups returning from break-in facilities, with others being lower risk such as greyhounds being transferred from rural hobby trainers. As such, GRSA will put faith in trainers to manage these situations on a case by case basis, which takes into consideration the likely risks associated with the transfer.

Trainers however should note the following – any greyhound that has recently competed interstate (raced or officially trialled), will be unable to compete in an SA event until 10 days have passed since that Interstate engagement.

NON ESSENTIAL PERSONS ONCOURSE AT RACE MEETINGS

GRSA reminds participants with children that due to the COVID-19 restrictions non essential persons and the public are not allowed oncourse which includes children.

Unfortunately during school holidays this can be difficult for some of our participants to manage, however, they need to make other arrangements for them.

GRSA appreciates the significant changes in place for the industry during this time and appreciates the efforts that are being made and continue to be made to abide due social distancing and restrictions.

MURRAY BRIDGE TRIALS

GRSA advise that from March there will no longer be an officiating staff available to clear greyhounds for Satisfactory trials and Qualifying Qualy trials on the fortnightly Tuesday nights at Murray Bridge.

GRSA will send an official to Murray Bridge on a monthly basis on a Friday morning trial session, which has both tracks trialling. This presents an opportunity to also include the Straight Track for Qualifying and Satisfactory Trials. The next trial session will be Friday, 15th May.

TRANSFERING GREYHOUNDS INTO SA WITH PROOF OF PURCHSE AND GRADING EXEMPTIONS

Participants are reminded of -

Any greyhounds purchased into SA ownership under the proof of purchase conditions to be trained in SA and seeking grading exemptions need to be in SA to receive grading exemptions before the 1st January 2020. On the 1st or after this date greyhounds have to come back to SA once purchased without any race starts Interstate to receive a grading exemption.

Owners are encouraged to contact the GRSA grader to assist with specific grades of greyhounds prior to purchase.

WINNING GRADE 6 RACES IN ORDER

GRSA reminds trainers to win their grade 6 events in order at a specific venue.

For the venues that allow two Grade 6 wins trainers need to win a Grade 6 over one distance and then a Grade 6 over the other distance. If a greyhound wins a Grade 6 and then a Grade 5 then they will lose their Grade 6 over the other distance at that venue.

RE GRADING FOR ALL TRACKS AND DISTANCES

Re grading will occur for all tracks and distances for Grade 3 or higher greyhounds.

A trainer can apply for a re grade after two unsuccessful nominations over the corresponding distance. If having met this criteria the responsibility is on the trainer to apply for a re grade prior to the close of nominations. Only one distance will be considered for a re-grade per meeting.

West On Bamboo causes upset to claim Easter Cup

It was a boilover of sorts when the very consistent West On Bamboo for trainer Damien Bates charged home from midfield in the fourth running of the \$7,750 Easter Cup final over middle distance at Angle Park to claim a well-deserved win on April 9th.

Her form didn't suggest she would start the outsider of the field, however, it showed what an outstanding line up was assembled for the 600m feature. The daughter of Collide and Revealed gave the ownership group of Tim Aloisi, Damien Bates, Matt Lehman and Mick McSorley another feature race win at headquarters.

As the start was affected Power Burner from the inside box for Maurie Kiley and Oakvale Magic from box 7 for Ken Trowbridge raced out to the early lead

Into the back straight and Power Burner sped away in the lead with Oakvale Magic back to second, Zipping Galon moved stylishly into third with West On Bamboo making ground on the rails into fourth. Off the back straight and Power Burner was going nicely in the lead, Oakvale Magic was holding second as Zipping Galon attempted to take a run to the inside but was balked halting his momentum, this allowed for the pack behind to close

including West On Bamboo who began to come into the race nicely. Turning for home and into the front straight it was a matter of where to look as the challengers came from far and wide.

They gobbled up Power Burner in the lead as West On Bamboo ran to the front, following her through was Cripps Dusty into second for Rob Harnas who came from nowhere to challenge while Toora Ziggy kept coming wide on the track into third and that's the way they finished. However there will be plenty of hard luck stories for all 8 finalists in what was a great race.

Presentation of Weight Record Cards

Some weeks ago, Stewards temporarily discontinued the requirement for participants to produce Greyhound Weight Records during the kennelling process.

The purpose of this initiative is to reduce the potential for transmission of Covid-19 through the handling of documentation between staff and participants.

For the purposes of Greyhound Australasia Rules R38, R39 and R40 and associated GRSA policy and procedures, the official weight for each greyhound in every race is recorded digitally within OzChase as it has been for many years. Participants are encouraged to maintain the Weight Record Card for their Greyhound and the official weights for each race meeting are published shortly after the kennelling process on the GRSA website.

Refer to below screenshot to find the day's weight.

For the purposes of GAR39 [Weight Variation] Stewards will refer to the last start weight recorded in OzChase. Greyhound Weight Record Cards and Identification Cards must still be brought to the track and produced when requested [for the purpose of, but not limited to, the recording of endorsements and satisfactory trials] and penalties will apply in the event you are unable to produce the documents.

As always, please contact Stewards if you are unsure of your obligations or have any questions.

This process will be revised when Government Covid-19 restrictions ease.

The Golden Rules

Since the introduction of cobalt and arsenic thresholds, all participants should be reminded – in their own best interests – that there are a number of Golden Rules that can help them to avoid making any such breaches (for prohibited substances generally) and which should be adhered to as principles of best practice:

- Always consult your vet to seek guidance in relation to any of the products that you are using, any associated risks and other relevant context
- Review the range of any feeds or supplements that you typically purchase and, wherever it is reasonable to do so, replace products containing substances that could contribute to a threshold breach under the rules [eg. cobalt] with alternative products
- Observe the instructions on any products that you use and adhere strictly to those directions (having regard for prescribed amounts, frequency of administration/ application, methodology for administering/applying)
- Ensure a greyhound is never administered any treatment on race day other than as relates to its feeding and drinking requirements [GAR83[A][1] treats this as a specific offence]
- Refrain from the use of injectable treatments (eg. Vitamin B12) to any extent that is practical, including ensuring a greyhound is not administered any injectables the day before an event

Our registered participants have the responsibility to ensure that greyhounds are presented to the track free of any prohibited substances. This information is offered as advice in good faith and should not be relied on as a defence in the event of a breach occurring.

Canine Gastroenteritis outbreak presents many challenges

GRSA is currently in the middle of one of the most difficult periods in recent memory. The dual crises of COVID-19 and canine gastroenteritis have presented huge challenges for the industry and put significant pressures on GRSA staff and participants.

Whilst the COVID-19 issue will certainly have longer term implications for the industry, it now appears that the local industry has seen the worst of the canine gastroenteritis outbreak.


The graph below demonstrates the percentage of the local greyhound population that has been impacted over the past seven weeks. It shows that in the second week of April the outbreak reached its peak, with 35% of the greyhound population impacted by the virus.

Interpretation of this data has been important for management in determining what actions to take in regards to the weekly racing schedule. Obviously it would've been impossible for the industry to maintain six weekly race meetings in the Adelaide region, with over one third of the greyhounds unable to race.

The good news is that greyhound numbers are quickly returning to normal, with the rate of new infections dramatically slowing over the last two week. This will foreseeably enable GRSA to return to the full Adelaide racing schedule of six weekly meetings in the second week of May.

A level of caution needs to remain in regards to the canine gastroenteritis virus, as the known number of kennels to have contracted the virus accounts for roughly 50% of the total greyhound population.

On this basis, GRSA will maintain the current bio-security measures in the short-term future in an attempt to suppress the virus in SA. Participants are asked to maintain their hygiene processes in their own kennels to ensure we don't see a second wave of infections. All of us should be focused on protecting the remaining 50% of kennels that are yet to be impacted by the virus.



Update on key projects underway

The GRSA board has given management the go-ahead to commence three key projects that have previously been advised to participants, these are:

- Angle Park Vet Clinic Relocation
- Murray Bridge Slipping Track
- GAP Kennels at Angle Park

Works have already commenced on all three projects, with an anticipated completion timeframe prior to the end of the financial year (by June 30).

GRSA asks for patience from participants and Vet Clinic customers whilst the construction works take place as their might be some minor disruption to access and elevated noise levels as part of the works.

Leading greyhound figure calls time on 40-year career

WILLIAMSTOWN local Jane McNicholl has been a familiar face around Greyhound Racing in South Australia, both on the track and behind the scenes for over 40 years working as a greyhound vet and breeder until her retirement this year.

Dr McNicholl was originally from Ireland before arriving in Australia in 1974, living in both Broken Hill and Kadina before settling in Williamstown in 1980, where she has enjoyed national success with her greybound breeding.

In addition to accomplishments as a breeder, Dr McNicholl has a similarly accomplished veteri-nary career, including lecturing




Latest updates from GAP

We have also been working on reducing the time between assessment and entry into the program. The following graph shows the average monthly waiting times in weeks.



Do you have a small dog?

Do you or someone you know have a small dog that could benefit from some socialisation and company during the day?

GAP SA is looking for small dogs to help with their green collar and first point assessments.

Your dog will be well looked after with plenty of pats and treats throughout the day. They will assist with either green collar assessments for dogs that have been living with foster carers or for greyhounds entering the program.

During assessments, greyhounds will be muzzled, on a leash and handled by an experienced assessor and handlers. All dogs will be walked around together in a secure testing area for approximately 5-10 mins to assess the greyhound's reaction to the small dog. If the greyhound is reacting well we will allow them to approach and sniff the small dog.

We are looking for dogs that are generally social and happy meeting other dogs and ones that walk well on a lead. Sessions are rostered at least a month in advance and are generally around two to four hours in length.

The meeting commenced at 10.06am

1 APOLOGIES

Lisa Rasmussen, Scott Wuchatsch, Sean Donnelly, Paul Preiss and Grahame Marshall were noted as apologies.

The Chairman reiterated the message provided to participants the previous evening. He noted staff, participants and their dogs were the most important factors and urged industry to consider their interactions to ensure everyone remains safe and well. The Chairman noted his confidence in GRSA's product and staff and suggested GRSA was currently profitable which placed the industry in a good position. The Chairman noted the increased anxiety within businesses generally but highlighted government's support of racing. He advised Management were prepared to make swift decisions regarding staff and interstate greyhound movements to the benefit of SA greyhound racing. The Chairman encouraged staff and industry to continue to work collaboratively and ensure regular communication.

Meeting commenced at item 4.1

The Group noted the recent lack of hock injuries and commended the associated good preparation of tracks.

3.4 300m Boxes at Gawler

The Group noted the update.

3.5 Industry Awards

The Group noted the update.

3.7 ICG Member

The Group noted the update. The CEO asked those group members with expiring terms to consider their future on the committee.

3.8 Transition to Online Nominations

The Group noted the update.

3.9 Correspondence from Lisa Rasmussen

The Group noted the update. The Group was supportive of pre fostering dogs.

3.10 Correspondence from Christine Costa

The Group appreciated the changes made for hot weather, including moving races etc. They suggested by doing this, it reduced their

stress and assisted by being more predictable. Panel members raised issue with the kennelhouse temperature and humidity, noting dogs were unable to cool down following racing. The lack of control of kennelhouse temperature and humidity in relation to hot weather policy was highlighted. It was noted other items in relation to cooling were a work in progress.

3.11 Dual Lure - Greyhound Racing Victoria (GRV)

The Group noted the update.

Action: The Chairman to speak to Victorian counterparts regarding dual lure moving forward.

3.12 Gawler 531m boxes - Closeness of crowd

The group noted the update.

4 AGENDA ITEMS

4.1 Response to Canine and Human Coronavirus (COVID-19) Strategy

The CEO provided background to discussion. Noted Chris Doyle's attendance at today's meeting.

Dr Doyle gave an overview of the canine coronavirus including advising of the 6-9 days shedding period following symptoms which has led to the current 14 day guarantine period to be moved out to 21 days. He suggested discussion was required around correct isolation time. Dr Doyle noted coronavirus has been present in the canine world for many years. He advised a vaccine has been available for a number of years, however this was not entirely effective and currently in short supply. He noted tests are currently being undertaken to determine where the virus originated from. Dr Doyle suggested the virus is not as detrimental as parvo. He further noted the available virus testing is reliable. Dr Doyle referred to the recent GA Vets and Analyst committee meeting where the return to racing time frame was discussed. He advised the opinion of the committee was that was with an incubation period of 1-6 days, duration average of 2-10 days and shedding of virus continuing up to 9-10 days after clinical signs had disappeared, a return 14 days after clinical signs had ceased was recommended. The Committee's unanimous opinion was that a practical solution would be that all affected dogs undergo a snap test (at jurisdictions costs) prior to returning to racing. Dr Doyle noted University of Melbourne were currently undertaking investigation in the strain of the virus. Dr Doyle suggested stopping spread of virus was best action.

Panel members questioned Tony Hinrichsen as to what medication he was using to treat gastro cases. Tony advised he was using Protex.

Panel members suggested faeces needed to be cleared up at trials, especially at Virginia as well as all tracks. It was further suggested saliva was a major issue in particular with the use of finish on lure.

Panel members questioned if all vets in SA had been advised of the outbreak.

Panel members highlighted the great work being done by GRSA to try and contain the virus, the precautions and measures implemented to minimise the spread at tracks and suggested continuing these measures. The Group was questioned if these measures were adequate and how long this should continue. It was noted that Virginia was lacking attention in particular relating to the removal of faeces, disinfection and social distancing of dogs. Panel members suggested signage enforcing removal faeces, monitor each other and to provide disinfectant spray bottles. It was suggested Colin Simes be considered to undertake cleaning at Virginia.

The Racing Manager suggested a national approach was required to the length of time out of racing.

Panel members suggested random testing at tracks. Management committed to undertaking this as soon as testing kits arrived.

The Group was unanimous that a mandatory test be undertaken after 14 days being clear of symptoms and no less than 21 days from first self-reporting, with self-testing being able to be done prior to this at the discretion of trainer. Approval to nominate would then be granted by the Chairman of Stewards.

The CEO noted GAP was ceasing to accept dogs in to the program. He questioned Dr Doyle as to what protocol would he suggest to safely re-accept dogs in to GAP. It was suggested dogs from non-affected properties could be snap tested and if negative, they could be accepted in to the program. The GAP Manager advised GAP were able to arrange one off assessments for trainers with between 1-5 dogs if required. The CEO committed to arranging a small working group to develop a GAP response plan. Panel members suggested vaccinating all small dogs used by GAP at assessments for coronavirus prior to utilising them (min. 8 days prior). The Integrity Manager questioned difference between third party adoptions, and not snap testing these. She suggested it was excessive to snap test all GAP dogs and this should be limited to identified properties only. It was concluded that any dog from non-affected properties would be snap tested prior to entering GAP.

Panel members questioned the mortality rate of the virus. Dr Doyle suggested some deaths had occurred interstate and majority were pups if anything.

The CEO advised monetary assistance would be considered by the Board due to the financial effect of the virus.

The Chairman questioned if there were concerns with any other tracks. It was noted Mt Gambier was well looked after and the group commended staff for their efforts. Consensus was Victorian trainers were not being proactive in prevention. Panel members suggested moving cancelled Mt Gambier meetings to other tracks.

The Chairman questioned movements of SA dogs returning from interstate. The Racing Manager advised there was a requirement to self-isolate dogs for 10 days prior to being allowed to race in SA. The Chairman suggested these dogs be snap tested prior to returning to race. Panel members noted the multiple movements between breakers, interstate trainers attending SA vets etc. Panel members suggested there was not sufficient awareness of the virus and severity of it. They suggested further clarity should be provided including the use of photographs and testimonials to demonstrate the severe affects.

The Chairman thanked Dr Doyle for his attendance and Dr Doyle then left meeting at 11.27am.

Action: Management to provide assistance to Virginia to ensure the track is safe for dogs by implementing the same cleaning standards as at other tracks.

Action: The Chairman to speak with GA regarding providing funding towards the University of Melbourne investigation in to the strain of canine coronavirus and vaccine.

Action: For the Chairman to push national approach to testing period.

Action: The Integrity Manager to provide the Australian Veterinary Association with any GRSA information/press releases regarding Canine Coronavirus

Action: Management to order additional snap tests (up to 300) immediately.

Action: Management to send complimentary message to Mt Gambier staff on efforts in curbing spread of canine coronavirus.

Action: The CEO to raise vaccination subsidy with Board at their next meeting

Meeting reverted back to item 3.1.

The Racing Manager noted the measures taken in regards to COVID-19. It was suggested industry generally supported non-necessary attendance at race meetings. The Chairman noted the importance of protecting staff.

Panel members sought clarification as to whether trainers with affected kennels was able to attend the track whilst canine virus was present in their kennels. The Integrity Manager advised that they were restricted and could not attend. Panel members suggested wash mats should be relocated. The Chairman of Stewards noted most likely transmission point would be from trainers not public. It was suggested mats to be located at foyer entry.

Action: Management to purchase additional mats for other entry points of building (including other tracks).

4.2 Hot Weather Review

The general consensus from the Group was that the suggestion to allow trainers to nominate their own greyhound to be included on heat stress register was valid and would be implemented. It was suggested that early kenneling was not being utilised as it was a waste of resources. The CEO suggested automatic early kenneling would be implemented at a temperature of 35oC. It was decided that should the temperature reach or look to reach 35oC at expected kenneling time then early kenneling would be implemented and advised via text message. This would be implemented for twilight and night meetings only. No early kenneling would be offered for day meetings as this was deemed unnecessary.

4.3 Greyhounds Doubling Up in Kennels

The CEO provided background to concerns raised and questioned the group as to the appropriate age for doubling up in kennels. Panel members suggested 14 months was appropriate and suggested this practice would also promote socialisation. The Integrity Manager committed to including this in the next rule rewrite.

4.4 Camera Above The Boxes – Angle Park

The Group discussed the current vision. Panel members suggested see through tops of boxes with camera above would be an innovative and beneficial idea. The CEO committed to including this on the next ICG agenda. The Racing Manager questioned the Group as to what they believed was the ideal vision. There was discussion around this. Panel members noted the Victorian vision and management noted the intent to do same in SA. The Chairman provided his opinion that due to quality of vision, vision from above boxes should be limited to replay only. The Group was in agreeance with this.

4.5 Rules Relating to Live Baiting and Use of Animals

Panel members noted variances between states and penalties. Panel members suggested an intermediate rule was required noting differences between offences and rule. Panel members suggested further education in training methods and techniques would be beneficial. The CEO noted discussion was required at GA regarding national approach to education.

4.6 GAP Admissions – Dental Hygiene and Other Matters

The GAP Manager noted current issues with dental hygiene of dogs being accepted in to the GAP program. She sought suggestions from Group as to how to educate industry on increased dental hygiene. Panel members noted barriers to giving bones to racing dogs. The Integrity Manager noted educative piece available from Jane McNicholl which has been placed on website and given out on kennel inspections.

Action: Management committed to regularly publishing and highlighting information on dental hygiene on website.

4.7 GOTY Voting Structure and Format

The Racing Manager suggested seven panellists provide a balanced outcome and noted the importance of a position on the panel. The Chairman suggested continuing with five members. The Chairman of Stewards suggested including Stewards on the panel due to their unbiased view, referencing the AFL and umpires voting for Brownlow. The Stewards representation was agreed as a potential outcome.

Discussion was had around the omission of Sennachie in this year's

awards and the criteria of nominations and determination of awards. It was suggested to recognise a National SA Bred Greyhound of the Year (which would be required to have been bred and primarily owned in SA) in addition to SA Greyhound of the Year. The criteria of this award would need to be finalised however Group were supportive of the inclusion of this award.

The Group also supported the inclusion of a short course award as well as retaining the Owner, Trainer award, City Strike Rate.

The CEO noted a review of eligibility around penalties would be undertaken. He suggested Management would consult the group during review period.

4.8 Distance Racing - 731m

The Racing Manager sought opinion from the Group of retaining four dog stayer races to the detriment of maiden and middle distance races. Panel members suggested Thursday night stayer feature races rather than splitting these over two nights. It was agreed that five dogs for 600m and four for stayer events would be implemented. The Group noted the need to eliminate the practice of trainers entering 3-4 dogs in events and then withdrawing. Management agreed to look in to this.

4.9 Weekly Trial Schedule & Closing of Nomination Times

The Group supported the recommended changes. The Racing Manager advised changes would be implemented from mid-April.

4.10 Industry Auction

The Chairman noted that in the current economic climate, it would not be possible for auction to go ahead this year. The Racing Manager committed to discussing with Panel members the possibility of re-enacting the following year.

4.11 Bedding Policy

The Group agreed that the bedding policy should be applicable to race meetings and at the discretion of trainer for trials.

Panel members suggested allowing the wash bay to be available during trials on hotter days. ANGLE PARK QUALIFYING TRIALS ON WEDNESDAY NIGHTS

Under the new schedule Angle Park Qualifying Trials will be run weekly on Wednesday night, for the corresponding Monday APM meeting (12 days later due to nominations). With 388m racing now available on Monday nights trainers can qualify for all distances.

Nominations close with GRSA at 12.30pm on the Wednesday of the meeting.

SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number or alternatively logon to trialbooker.com, create an account and book your own trials.

POLICY FOR TRIALLING AT ANGLE PARK, GAWLER AND MURRAY BRIDGE BEFORE THE RACE MEETING

Policy Background

This policy is to detail the procedure for trainers seeking greyhounds to trial before race meetings. This policy is effective from 2 May 2019.

Race Meeting Trial Policy

This policy is in place for the following race meetings:

Angle Park Monday, Gawler Tuesday and Friday, Murray Bridge Wednesday and Sunday.

Two fields from the boxes with a maximum of four (4) greyhounds will be conducted immediately following the completion of the kennelling procedure for the race meeting.

The following lists the order in which greyhounds will be selected in the event if more than eight (8) greyhounds are nominated:

- 1. Reserves at the meeting that do not obtain a start
- 2. Trainers that have greyhounds engaged and are located more than 100km in distance from the track
- 3. Satisfactory trials

Procedure/criteria

- 1. For Angle Park Monday night, the trainer is to contact GRSA by midday on Monday to nominate. Should the
 - Monday be a public holiday bookings are to be made between 8am and 9am on the scratching number.
- 2. For Gawler Tuesday & Friday, the trainer is to contact GRSA by 4.30pm the day before.
- 3. For Murray Bridge Wednesday, the trainer is to contact
 - GRSA by 4.30pm the day before. For Murray Bridge Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
- 4. Other than reserve greyhounds, trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
- 5. Stewards will allocate the box for the greyhound.
- 6. Trials will be 515m, 530m & 531m in distance as first preference. Other distances considered depending on nominations.
- 7. Greyhounds currently under suspension are ineligible to trial unless they are undertaking a satisfactory trial to be cleared.
- 8. Greyhound registration cards must be produced at kennelling time.
- Trainers with other greyhounds engaged can utilise the extra kennel space until such time they are ready to leave.
 - Trainers with no other greyhounds engaged will be permitted to leave with Stewards permission.
- 10. In the case of race at Murray Bridge, trials will only be available on the track that is prepared to race that day i.e. Sunday meeting on the u-shaped track, trials will be on the u-shaped track only.

Please note: If there are 12 races at Angle Park, Gawler or Murray Bridge there will be NO trials.

The Angle Park Vet Clinic and/or swab kennels cannot be used to accommodate any additional greyhounds due to operational requirements of the Clinic and Stewards.

It is vital that trainers nominate to trial at these race meetings. If you are unable to nominate at these times, please contact GRSA as soon as possible as permission may be given at GRSA's discretion to accept bookings outside these times.

Exceptions to this policy

Thursday nights are kept available for interstate greyhounds to solo trial in a lead-up to SA Group races as well as local greyhound's trialling for Group racing interstate.

Upon request, local greyhounds will be allowed to solo trial in a lead-up to a feature race and they will take one of the eight (8) kennels available for trialling greyhounds ahead of the policy and sit separate to the four (4) dog trials. Races considered to be a feature are: Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals and any interstate Group race

Local greyhounds will be permitted to trial on a race night, where they are in preparation for a feature event, nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy. If a greyhound qualifies for a feature final and requires a trial in between, this will be conducted as a solo trial and will sit separately to the four (4) dog trials.

GAP SA greyhounds are now even more affordable at only \$150.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shepheard.


