NOTES FROM THE CHAIRMAN GRANTLEY STEVENS

Dear Participants,

As recently shared, Greyhound Racing SA is thrilled to have secured highly respected and experienced racing administrator Brenton Scott as its next Chief Executive Officer. While Brenton does not officially commence until Monday 4th of March, we have had the chance to spend time together sharing information as he prepares and ensure we 'hit the ground running'. Brenton is particularly keen to get out and meet our participants trackside shortly after he commences, which I know you will all appreciate.

From a Government Inquiry perspective, we met with government recently. While the 2-year clock does not officially start ticking until the Greyhound Industry Reform Inspector (GIRI) commences around Easter time, government were not mincing their words when they reiterated our need to bring the recommendations quickly and professionally to life.

While there are some recommendations that we still seek some detail regarding, and others that may require transitional arrangements, some recommendations have already been actioned and many are about to commence. Participants are likely to notice these developments. For example, increased frequency and greater detail by our team with kennel inspections ensuring the welfare of our dogs is of the highest priority which is coming under increased scrutiny from government and the public. From an integrity perspective there has been an increase in sampling, including hair testing, out of competition, and prerace testing. I appreciate you all understand the importance of ensuring our industry meets contemporary community expectations. I thank you in advance for making sure we not just meet the required levels, but where possible, exceed them, as we all work together to ensure our industry not just survives the Inquiry, but come out the other end stronger.

The Murray Bridge Cup will be just around the corner by the next time I write to you. The event scheduled for Sunday 17th March is always a vibrant day with great entertainment and strong fields. The Murray Bridge track has been a great addition to our industry since opening in 2018. With first-class patron and training facilities and a straight track that will only see more activity through the Inquiry recommendations, GRSA is currently looking at further investment in the facility, possibly through the addition of a GAP and / or veterinary facility. I will keep you posted of developments in the space. Until then, I look forward to seeing you at The Dogs.

2024 GAWLER GOLDEN MAIDEN

Trainer Gavin Harris continued the blistering start to 2024 for his kennel with promising youngster Springvale Grace taking out the 2024 Gawler Golden Maiden Flnal on Sunday, January 28.

A large crowd was oncourse as part of GRSA's Family Fun in the Sun promotion, which is an annual event encouraging families on course with kids entertainment, live music, food trucks and face painting.

On the racing side, the Golden Maiden was the feature event on the 12-race program and an intriguing final was drawn following four heats run on Sunday, January 21. After being well supported in betting, Springvale Grace had no luck in her heat but hit the line well to qualify for the final. It was a different story in the final for Springvale Grace, who showed plenty of early speed to get a nice run through on the rail around the first turn.

While the Bosko Stamenkovic trained Sebea led, he shifted wide down the back allowing a beautiful passage through for Springvale Grace who hugged the rail to win in 31.37. The fast finishing Keep It Zipped finished second for Richard



Pearce while Sebea hung on to finish in third place. The Golden Maiden win continued an excellent run for Harris, with his kennel claiming the distance feature in the Festival of Fire series while also winning the recent John Gray series at Angle Park with Dashing Deb.

2024 SA ST LEGER FINAL

A strong 12-race program was run at Angle Park on Thursday 8th February with the feature race of the evening being the 2024 SA St Leger Final.

The Rawlings and Harris kennels held a strong hand in the final, combining to have seven of the eight runners. However, it was Fantastic Ada who took out the St Leger Final with an excellent run for trainer Liz Chegia to continue her excellent recent record.

From box five, Zinfandel Evie showed plenty of early speed to lead to the first turn, with Fantastic Ada able to get a nice run in behind and settling in second from box six.

With trouble in behind the leading pair, after Ferocious Ivy went wide and Peaky Boo cut to the rail, Zinfandel Evie was able to open up a three-length lead with Fantastic Ada a further two lengths clear of the chasing pack.

Fantastic Ada was able to close the gap, drawing level on the final turn before she pulled away on the straight and winning by two and a half lengths in 30.64.

Zinfandel Evie for Gavin Harris was able to hang on for second place just ahead of the fast-finishing Peaky Boo and My Khaleesi, both for Ben Rawlings who finished in third and fourth place respectively.

Speaking on the dais during the post-race presentation, Chegia kennel representative Steve Jones said they were feeling confident heading into the home turn that Fantastic Ada would be able to power home and win.

The SA St Leger success continues an excellent run of feature race wins for Fantastic Ada since crossing into South Australia in October.

She now boasts a career record of ten wins and five seconds and has claimed three feature events in that time including the Murray Bridge Country Summer Oaks and The Inferno in the Festival of Fire series while also making the final of the John Gray in January.

RACING AND TRIALLING FREQUENCY REMINDER

GRSA adopted a new local rule in regard to frequency of racing and trialling which was implemented on Wednesday, 1st February, 2023.

Rule 69A Racing and trialling frequency

(1) In this rule:

Race has the same meaning given to this term in R9 of the GAR.

Trial means a satisfactory trial, or a qualifying trial as defined in R9 of the GAR.

(2) A greyhound will only be permitted to start in(a) No more than a combined total of 2 race and trial starts in any 7-day period; and,

(b) No more than a combined total of 7 race and trial starts in any 28-day period.

(3) This sub-rule commences on a date to be fixed by Stewards' Notice.

The intent of this rule is to monitor and regulate the frequency of races and official trials of greyhounds, to ensure adequate rest time is given between events. The rule is similar to one in effect in Western Australia. We have automated the Ozchase Racing system to be able to monitor this rule. The rule is self-explanatory.

A greyhound must not start more than 2 times (races or trials combined) in any 7-day period. Further, a greyhound must not start more than 7-times (races or trials combined) in any 28-day period.

Any attempt to nominate a greyhound outside these parameters will be flagged by the OzChase system. If a greyhound gains a start from reserve deeming it ineligible under this rule for its next engagement or it competes in another state prior to racing back in SA then the greyhound will come out.

**Racing Administration staff will scratch these greyhounds acting under this rule without notification (the responsibility rests with the trainer to ensure they do not contravene this rule).

**For clarity if a greyhound races on Sunday,

Wednesday then Sunday it will be eligible. The first day counts as day 1 and therefore resets on the Saturday.

VACCINATION RULE FOR RACING IN SA

Trainers are reminded that Rule 25 [Minimum Vaccination Requirements] took effect Monday, 1st May, 2023. Vaccination Certificates must be received by GRSA prior to close of nominations for affected greyhounds to be considered eligible for nominating. Trainers are also reminded that they must not have their greyhound vaccinated within 5 days of racing. Should this occur, the greyhound will be scratched from its engagement.

BREEDERS 2024 PRELUDE (1) SERIES IN MARCH

The Breeders 2024 Prelude (1) series kicks off with \$3,700 Heats on Thursday, 7th March over the 530m.

The \$4,500 Final will be run on Thursday, 14th March. For SA Bred greyhounds paid up for Breeders 2024

• Nominations close with GRSA for the Heats at 9am on Monday, 4th March.

GROUP 3 MURRAY BRIDGE CUP ONE WEEK LATER IN MARCH

The Murray Bridge Cup series has been moved back one week in March 2024. The series was due to be run on Sunday, 3rd and 10th March, however, the Speedway across the road has one of their main meetings for the year now scheduled on 10th March, the same night as the Cup Final was due to be run. It is preferred that the greyhounds do not race at the same time as the speedway, especially in competition with the Clubs only Group 3 feature event of the year.

After consultation with the Murray Bridge GRC and Gawler GRC it was agreed to make the below changes –

- Gawler will now race on Sunday night, 10th March (Public Holiday)
- Murray Bridge will now race on Monday night, 11th March for the Heats (Public Holiday)
- Angle Park will now race on Friday, 8th March

Due to the movements above GRSA will also change

- Gawler to race on Friday, 15th March
- Murray Bridge to race on Sunday night, 17th

This will mean that the Heats of the Group 3 Murray Bridge Cup will be on Monday night, 11th March, and the \$36,000 Group 3 Murray Bridge Cup Final will be run on Sunday, 17th March.

MURRAY BRIDGE STRAIGHT TRACK HEATS FOR MURRAY BRIDGE CUP FINAL NIGHT

The Murray Bridge GRC and GRSA will conducted Straight Track Heats on Tuesday, 12th March with two \$3,000 Finals conducted as races 1 and 2 on Sunday, 17th March to align with the Group 3 Murray Bridge Cup around the one turn track.

The \$1,330 Heats on Tuesday will be over the 300m and 350m and be a Special Event, Non Penalty for the best greyhound nominated over each distance.

MURRAY BRIDGE AND MOUNT GAMBIER CUPS AT GROUP 3 LEVEL WITH BIG BONUSES

It will be a big couple of months of racing in March and April for the Murray Bridge and Mount Gambier Clubs when they conduct their Cup meetings.

These events are at Group 3 level and offer \$25,000 to the winner.

The \$3,000 Murray Bridge Cup Heats will be conducted on Monday, 11th March with the \$36,000 (Group 3) Final to be run on Sunday night, 17th March. Also on the Final nights program will be -

\$4,000 Murray Bridge Cup Consolation – 455m (Trainers must renominate)

\$5,000 Special Event Feature (N/P)- 680m

\$4,000 Special Event Feature (N/P)- 530m

\$3,000 Special Event Feature (N/P)- 395m

We will also run two Straight Track Finals on the night which will be over the 300m and 350m worth \$3,000 each (Heats run on Tuesday, 12th March).

MOUNT GAMBIER CUP IN APRIL

The \$3,000 Mount Gambier Cup Heats will be run on Sunday, 7th April with the \$36,000 (Group 3) Final on Sunday, 14th April. GRSA will link bonuses to both of these events, which will include a \$5,000 bonus if the same dog can win both the Murray Bridge Cup and Mount Gambier Cup and a \$5,000 trainer bonus if the same trainer can win both Cups (SA or

Interstate or different dogs].

SA OWNED GRADE 5 LOW GRADE FEATURE IN MARCH

The low grade series in March at Angle Park is a SA Owned Grade 5 series over 530m with Heats on Thursday, 14th March with the \$5,810 Final on Thursday, 21st March.

• Nominations close with GRSA for the Heats at 9am on Friday, 8th March.

595M EASTER CUP HEATS COMING UP ON 21ST MARCH

The \$6,315 Heats of the Mixed Easter Cup will be run over 595m for a \$7,750 Final on Thursday, 28th March. Trainers need to nominate for this event with all Grades considered.

• Nominations close with GRSA for the Heats at 9am on Monday, 18th March.

EASTER FEATURES AT GAWLER ON EASTER SUNDAY

Easter racing comes to Gawler in late March with both the Gawler Future Stars Final and Gawler Easter Sprint programmed on Sunday, 31st March.

The Gawler Future Stars Heats will be conducted for SA Bred greyhounds whelped in 2022 on Friday, 24th March over the 531m with a \$3,500 Final on Easter Sunday, 31st March. The Gawler Easter Sprint is for mixed greyhounds over the 531m worth \$5,000. (Trainers must nominate for this feature with all grades considered). It's going to be a terrific night of racing on the Sunday night over the Easter break.

• Nominations close with GRSA for the Future Stars Heats at 9am on Wednesday, 20th March.

LOCAL MATCH RACE SERIES "THE SA EASTAR" IN LATE MARCH

The SA Local Match Race series coined "The SA Eastar" will be held on Thursday night, 28th March [Easter] at Angle Park.

Eligibility for South Australian local greyhounds will be based around the Nationals conditions. They will need to be trained in SA 76 days out of the last 150 prior to the close of nominations.

Selection for this series will only be based around winning times at Angle Park. For greyhounds that have run over the 530m at Angle Park on any meeting since 1st November, 2023 their fastest winning time will be recognised and put them on the list for selection.

The head to head matches will be decided based on the final listing and nominations. Match 1 will be $1 \vee 4$, Match 2 will be $2 \vee 3$, Match 3 will be $5 \vee 8$ and Match 4 will be $6 \vee 7$. There will be no manual selection from the Grader. The top 4 seeded greyhounds will be rewarded with more prizemoney.

Winners of match races – Match $1 - 1 \lor 4$ \$4,500, Match $2 - 2 \lor 3$ \$4,000, Match $3 - 5 \lor 8$ \$3,500, Match $4 - 6 \lor 7$ \$3,000 There will be \$500 Runner's Up. Overall SA Eastar winner (based on overall times) - \$6,000, second \$2,500, third \$1,500.

Those greyhounds that have won at Angle Park since 1st November, 2023 are [Top 16 – subject to eligibility] GRSA will separate equal times to a third decimal point if required closer to the event– [updated 17/2/24]

"EASTAR" MATCH RACE TRIALLING

GRSA will allow trialling opportunities in a lead up to this series to be conducted on a race night with dates to be advised. These trials will be run between races at the discretion of the stewards. Trainers must book these trials with Greyhound Racing SA by 11.00am on the day.

Greyhounds will be eligible to trial at the total discretion of the Grader where a trainer may have to provide information in support of trialling. Local eligibility conditions still apply.

Each greyhound will only be allowed to trial once in an effort to improve their position or obtain a spot on the list.

STAYING EVENTS MOVED TO 5 RUNNERS AS A MINIMUM FROM JANUARY 2024

For a number of years GRSA has supported our staying ranks by running these events with a minimum of 4 runners. GRSA has tried to encourage this pool to grow at the expense of other events on a program, even with such small numbers. However, from January 2024 any staying event programmed will need to be a minimum of 5 runners to be considered in the program. This will affect the Angle Park 730m, Murray Bridge 680m and Mt Gambier 732m.

GRSA will continue to review processes in relation to the field size and scheduling.

LOW GRADE FEATURE SERIES AT ANGLE PARK IN APRIL

The Low Grade Feature Series at Angle Park in April will be an Open Maiden over the 530m with Heats on Thursday, 11th April and the \$5,810 Final on Thursday, 18th April.

BREEDERS 2024 PRELUDE (2) HEATS ON 4th APRIL

\$3,700 Heats of Prelude [2] for Breeders 2024 will be run on Thursday, 4th April at Angle Park.

The series is for all greyhounds eligible for Breeders 2024 with the \$4,500 Final to be run on Thursday, 11th April.

SA ANNIVERSARY CUP IN APRIL WORTH \$50,000

The \$5,810 Heats of the SA Anniversary Cup will be run over 530m on Thursday, 18th April. The \$50,000 Final will be run on Thursday, 25th April.

SA DISTANCE CHAMPIONSHIP IN APRIL

The \$7,140 Heats of the SA Distance Championship will be run over 730m on Thursday, 18th April. The \$15,250 Final will be run on Thursday, 25th April.

REGUPOL FLOORING FOR MOUNT GAMBIER KENNEL HOUSE IN APRIL

GRSA and the Mount Gambier Greyhound Racing Club have organised for contractors and their maintenance teams to install Regupol flooring in the Mount Gambier Kennel House from Monday, 15th April. Works will take a week and will have an affect on racing and trialling during this period.

A schedule of work and dates are below.

1. Work would begin on Sunday evening, 14th April with Maintenance clearing the kennels from the area after racing has concluded. [This is the Group 3 Mt Gambier Cup meeting]

2. Contractors would begin their work on Monday, 15th April with a view to have this completed by Friday, 19th April (Including the morning of Saturday, 20th April in case of slippage).

3. Maintenance staff would reinstall the kennels on Saturday, 20th April ready for racing on Sunday, 21st April.

4. Trials for the week will be cancelled including Saturday, 15th April due to staff availability.

5. The Race meeting on Thursday, 18th April will be cancelled.

Both Club and Authority have looked as these dates as the best option and least disruption to participants that starts after the Group 3 Cup series and is completed in a week with only one race meeting cancelled.

JUNE'S GRADING REVIEW PANEL MEETING OUTCOMES – MAIN POINTS

• GRSA will allow one extra Grade 6 over another distance for City A Thursday meetings bringing this into line with all tracks in SA. No retrospectivity regarding this change. Implemented

• GRSA has removed the condition where once a greyhound has won a Grade 5 or higher event on a City A meeting that the greyhound will lose all Grade 6 events at all other tracks. This means a greyhound could be a Grade 4 or Grade 3 over 530m on a Thursday City A meeting and will still be able to win Grade 6 events at other tracks. No retrospectivity regarding this change. Implemented

• GRSA will now allow a greyhound after winning a Grade 5 Masters event in faster time than the time standard to get back into Masters with 2 runs in a Grade 5 at the track and distance, it doesn't matter if they are placed or unplaced just so long as there are two starts out of Masters. This has been changed from being just unplaced to get back. Implemented

SA BRED UPDATE

The pool of money is \$45,000 per month.

These winners all receive a \$225 base payment with \$75 to the Owner & \$150 to the Breeder.

The SA Bred Bonus scheme is continuing to go over budget with the number of SA Bred winners increasing. For the month of July there were 203 winners, August 197, September 196, October 226, November 209, December 218 and January 218. This means that we are currently 67 winners over budget for this financial year.



BREEDING SUPPORT CLAIM RESTRICTION REMOVED

In July of 2022 after consultation with the ICG, GRSA introduced a restriction on the number of Breeders Support Claims that could be applied for in a 12 month period to assist with sustainable breeding. At the most recent ICG meeting, and after reviewing current and forecast breeding numbers it was agreed to remove this restriction effective immediately in support of our current breeders. 



Greyhound Racing SA Limited (GRSA) wishes to advise participants that there is no Wagering Activity Payment (WAP) for the month of January 2024.

As participants are aware, the WAP calculation is based on the net wagering revenue generated each period. With wagering being 6.1% lower in January 2024 compared to the same month of the previous year, increased prizemoney totalling 12.5% in calendar year 2023 (January 2023 7.5% and December 2023 5%) it has resulted in there being no WAP payable.

As can be seen from the second chart below, overall wagering revenue year to date for financial year 2024 is down 9.3% on the previous year. GRSA is continuing to monitor revenue trends closely and notes that this reduction in revenue is being felt across most racing jurisdictions. It is considered the reduction is an indication of the negative impact that higher inflation and interest rates are having on the disposable incomes of the wagering public.





As listed in the calculation below total payments to participants exceeded the 50% WAP benchmark return and thus no payment will be made for January 2024.

CLUB STALWART'S CITY OF MOUNT GAMBIER SENIOR CITIZEN OF THE YEAR AWARD

As far as the Mount Gambier Greyhound Racing Club (MGGRC) is concerned, Kevin "KD" Douglas is certainly a worthy recipient of the 2024 City of Mount Gambier Senior Citizen of the Year award.

After all, his MC work over a number of years – both complementary and complimentary – always added to the special days and nights conducted by the MGGRC. His ability to interact with all people was simply outstanding.

But it goes much further than that. A keen racegoer, when Covid restrictions were in place he found the only way he was going to be able to attend the local greyhound meetings at Tara Raceway was to complete the mandatory licence requirements and become a catcher.

Then he would be able to help out trainers requiring a catcher for their greyhounds. However, he was also looking for a worthwhile way of utilising his Thursday afternoons in Tara Raceway's catching area surrounded by slobbery greyhounds all seeking one last look at the lure.

KD came up with the format known as "Catch for Cash" whereby any trainer whose greyhound he caught could, if he or she so desired, place a gold coin in the charity jar. Soon he found many others were also willing to donate their nominal catching fees to the jar.

Later, together with regular participants, KD decided to expand the concept and make a charity-based competition out of it. A local charity would be chosen every couple of months and be promoted.

It was decided on a twice-weekly tipping competition, to be known as the Tara Tipsters – participants competing only for bragging rights but donating to KD's charity jar.

From humble beginnings of a participant group of half a dozen or so, there are now more than 20 involved on a regular basis (some participating remotely). At the end of each series, a Tara Tipsters race is conducted with representatives from the local charity attending and receiving a donation.

Following KD's "Catch for Cash" original concept of a gold coin donation, more than \$20,000 has now been donated to local charities by the Tara Tipsters.

KD's work also extends to the Quaran Care group, who are regular attendees at the Tara Raceway.

Quaran Care is an organisation that partners with support workers with a passion to empower people to improve the quality of their lives with the people having a range of disabilities incuding Down Syndrome, Autism, Anxiety and Learning and Physical Disabilities.

"Going back a couple of years, it's probably fair to say that many regular local greyhound racing participants were initially taken aback a little by this new group of visitors. Perhaps some felt a little uneasy, not knowing what to say, how to say it and how close to get," KD said.

"A group of six to eight young people with carers had arrived unannounced at the greyhound track and sat in the well-appointed clubrooms, not knowing others and us not knowing them.

Quaran Care Disability Support Services had arrived at Tara Raceway and with care and passion the relationship was ready to bloom. But this didn't occur naturally.

Regular racegoers did not know what to say or even how to say something. However, after a few visits the flowers did grow. With quiet introductions and a few extra words the relationship started to grow.

KD took an educated chance and broke the barrier. Once the ice was broken, regular racegoers became more understanding and less intimidated. Quaran Care clients also became very comfortable with their new-found surroundings to the extent they are now regulars at Thursday afternoon race meetings with several of them engaging with trainers who now have a better understanding of our new guests.

KD was formally acknowleged at the City of Mount Gambier 2024 Citizen of the Year awardees at the Australia Day Breakfast and Awards event at the Cave Garden on Friday, January 26.

Greyhound of the Month for January was Fiorano for trainer Ashlee Griffiths, who had two starts for the month with one win and one second, his highlight being the listed SA Sprint Championship Final.

It was a tight month of voting, with Fiorano just edging out kennel mate Adhana Rico and the Ron Schadow trained Victa Marli. The son of Black Magic Opal and Zipping Sassy started the month off with a solid second in the Heats of the SA Sprint before stepping out in the Final as one of the favourites. He was able to jump to the front early in the listed feature and ran brilliant time in the lead to stave off all challengers and win by a neck in 30.41 for the 530m journey.

At the end of the month Fiorano's record stood at 38 starts for 15 wins and 7 placings and earnings around \$67,000.



The Run of the Month for January was the Gavin Harris trained staying star Lena Jinx, for another fantastic performance at Angle Park on Thursday, 18th January over the 730m journey in a Free For All event.

She already has the Angle Park track record to her name, however, she became the only greyhound to beat the 42.50 time on two occasions. She ran a brilliant 42.37 in winning by 17.25 lengths in demolishing her competitors and only .08 outside her track record.

RACING REPORT

TRIALS

QUALIFYING AND SATISFACTORY TRIALS

Angle Park qualifying and satisfactory trials are held every Tuesday night between 6.50pm and 7.15pm. Qualifying will be for the following Monday meeting (drawn Thursday). Nominations close at 12.30pm on the Tuesday (for online nominations 11.59pm Monday).

Gawler qualifying and satisfactory trials are held every Thursday morning from 7am. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm Wednesday the day prior.

Murray Bridge qualifying and satisfactory trials are held fortnightly on a Wednesday night (between the end of the straight track trials and the beginning of the one turn track trials). Normal trials start at 4:00pm during nondaylight savings and 5:30pm during daylight savings. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm on Wednesday (for online nominations 11.50pm Tuesday).

ANGLE PARK

SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number or alternatively logon to trialbooker.com, create an account and book your own trials.

POLICY FOR TRIALLING AT ANGLE PARK, GAWLER AND MURRAY BRIDGE BEFORE THE RACE MEETING

Policy Background

This policy is to detail the procedure for trainers seeking greyhounds to trial before race meetings. This policy is effective from 2 May 2019.

Race Meeting Trial Policy

This policy is in place for the following race meetings:

Angle Park Monday, Gawler Wednesday and Sunday, Murray Bridge Tuesday, Friday, and Sunday.

Two fields from the boxes with a maximum of four (4) greyhounds. Trials may be conducted at any time during the race meeting from immediately after kenneling until after the last race, at Stewards' discretion.

The following lists the order in which greyhounds will be selected in the event if more than eight (8) greyhounds are nominated:

1. Reserves at the meeting that do not obtain a start

2. Trainers that have greyhounds engaged and are located more than 100km in distance from the track

3. Satisfactory trials

Procedure/criteria

- 1. For Angle Park Monday night, the trainer is to contact GRSA between 9am and 10am on Monday to nominate. Should the Monday be a public holiday bookings are to be made between 8am and 9am on the scratching number.
- For Murray Bridge Tuesday & Friday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Murray Bridge Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
- 3. For Gawler Wednesday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Gawler Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
- 4. Other than reserve greyhounds, trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
- 5. Stewards will allocate the box for the greyhound.
- 6. Trials will be 515m, 530m & 531m in distance as first preference. Other distances considered depending on nominations.
- 7. Greyhounds currently under suspension are ineligible to trial unless they are undertaking a satisfactory trial to be cleared.
- 8. Greyhound registration cards must be produced at kennelling time.
- Trainers with other greyhounds engaged can utilise the extra kennel space until such time they are ready to leave.
 Trainers with no other greyhounds engaged will be permitted to leave with Stewards permission.
- 10. At Murray Bridge, trials will only be available on the track that is prepared to race that day i.e. Friday meeting on the u-shaped track, trials will be on the u-shaped track only.

Please note: If there are 12 races at Angle Park, Gawler or Murray Bridge there will be NO trials.

The Angle Park Vet Clinic and/or swab kennels cannot be used to accommodate any additional greyhounds due to operational requirements of the Clinic and Stewards.

It is vital that trainers nominate to trial at these race meetings. If you are unable to nominate at these times, please contact GRSA as soon as possible as permission may be given at GRSA's discretion to accept bookings outside these times.

Exceptions to this policy

Thursday nights are kept available for interstate greyhounds to solo trial in a lead-up to SA Group races as well as local greyhound's trialling for Group racing interstate.

Upon request, local greyhounds will be allowed to solo trial in a lead-up to a feature race and they will take one of the eight (8) kennels available for trialling greyhounds ahead of the policy and sit separate to the four (4) dog trials. Races considered to be a feature are: Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals and any interstate Group race

Local greyhounds will be permitted to trial on a race night, where they are in preparation for a feature event, nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy. If a greyhound qualifies for a feature final and requires a trial in between, this will be conducted as a solo trial and will sit separately to the four (4) dog trials.

MOUNT GAMBIER SATISFACTORY TRIALS

Mt Gambier hold trials on Wednesday and Saturday mornings with Satisfactory trials ONLY being conducted on Wednesdays and need to be booked with Barry Shepheard from the Club on 0419 824 512 no later than 12pm the day before.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shepheard.

Thinking of making changes to your kennels?

Some changes to your kennels may need Council approval.

You also need to sign the application.

 Note that making an application does not guarantee acceptance. The TIRS covers defined bone, tendon or ligament injuries that result in surgery. Please see the TIRS policy on the GRSA website for detailed information.



3 ACTION LIST

The Group noted the action list as presented.

The IFM provided an update in regard to the installation of power outlets in trainers carparks at Murray Bridge and Angle Park noting the extent of the underground works required for the project. Members suggested less outlets were required due to the number of participants who now own vans with their own power. It was suggested nine poles with 2 GPO outlets per pole.

The item of longer transitions to Murray Bridge catching pen was raised, specifically relating to the straight track. It was noted movement of the catching pen location was limited. The CFO and IFM intend to canvas trainers' opinions. Members noted comparison with Capalaba to Murray Bridge and suggested it was no longer. Members suggested any issues would be associated with those dogs that had not trialed on the straight track. The general consensus from group was that the item could be removed from the action list as it was not determined to be an issue. Members suggested there were still issues with dogs that had not trialed on the track. Members suggested a drag lure would resolve issue. Members suggested this would form the outcomes of the inquiry recommendations and that the topic of lure would be included in a larger piece of work. Management committed in the meantime to maintaining sand levels to assist with slowing up in the pen and will continue with canvasing of participants for any issues.

The IFM advised that the project to increase noise on the lure was due to be completed in approximately three weeks and involved upgrades to the electronic lure.

Ther GM Risk & Compliance provided an update on the status of hand slipping returning. He noted an additional staff member was required and the manual implementation of the policy would be more complex and that an electronic lure would assist the process. The GM Risk & Compliance outlined the new process for trials, noting collection of data of those on track (names only) and providing a record that those persons have received a safety briefing.

The WRM provided an overview of the current GAP waitlist. The Chair questioned the groups thoughts on imposing a levy or fee for interstate dogs to enter the SA program. Members noted the responsibility for owners in rehoming needs to increase.

The Chair requested the assistance from Club committees to suggest criteria and thresholds for entry in the GAP program to be presented to the Board for consideration in order to assist to reduce the waiting list. Members noted their observations with lack of information and process around ownership. It was noted this information was currently available on the GRSA website. The WRM noted newly created literature regarding rehoming that was available and committed to distributing to clubs. It was suggested short workshops would be beneficial to participants.

4 AGENDA ITEMS

4.1 Independent Inquiry into the Governance of the Greyhound Racing Industry In South Australia

Dual Lure

The COS outlined their thoughts on the use of finish on lure, as compared to use in Victoria and NSW. He suggested a dual lure with finish on lure would may be viable. It was noted previous trials of a dual lure in SA was not supported by industry and that if finish on lure is retained, a dual lure was not possible. Members suggested if we are going to use a dual lure, the Victorian dual lure design was optimal but agreed that where a follow on lure is used that it be a single lure. It was recommended that GRSA continue to work with the government on the best way to approach this recommendation. Management committed to investigate interstate lure designs for levels of safety. The COS to investigate further with GRV.

Kennel Sizes on Premises

The Chair noted this inquiry recommendation and advised that GRSA would work with government and industry to achieve an outcome acceptable to all parties. Members suggested demonstrating improved environmental and enrichment conditions of kennels would be a benefit to the flexibility of this recommendation. Members noted restrictions with council building regulations that may affect the implementation of recommended kennel sizes.

Racing schedule/racefields and opportunities

The Chair noted the inquiry recommendation of increased G-Six events and straight track racing. The RM noted the structure required to include dual track race meetings at Murray Bridge. It was noted 342m with 8 dog fields was not preferred, this distance could benefit from 6 dog fields. He further noted factors including the number of current G-Six races, corporate wagering operator expectations and that increased 6 dog fields could lead to a viable Tuesday night opportunity. Members noted the need to consider increased straight track racing and that this could be facilitated by the installation of lights at the track. It was noted a hybrid meeting possibly would not allow for sufficient circle track racing opportunities at Murray Bridge. Members noted the need to alleviate issues presented in recommendations and to provide solutions to issues presented. The COS noted the importance of straight track racing. He suggested increased prizemoney will provide increased opportunities and attractiveness to participants. He noted straight track racing should be the ultimate priority with investigation of methods of better product delivery including camera angles and potentially a camera that followed greyhounds up the track (similar to Spidercam used in AFL).

GAP Facility at Murray Bridge

The Chair noted an upcoming meeting with the Murray Bridge Council to discuss development of the property

Surgical Al

The Chair discussed the inquiry recommendation of banning Surgical AI (SAI) and suggested evidentiary support of SAI would be preferred to assist with any argument supporting the procedure. The members discussed barriers and issues with being unable to access SAI, for example, SAI increases the availability of sires enabling breeders to make the best choice for their mating.

4.2 Various Items

Finish on lure at Angle Park

Some members noted benefits of finish on lure. Some members requested once the lure is pulled away after the race and the greyhounds have entered the catching pen safely, the lure is slowed to a stop to disengage the greyhounds chasing and looking for the lure. The RM clarified the position of management and the Board in regard to finish on lure. It was suggested by the members that a survey on the topic, of trainers, could be conducted in the future to better understand opinions. The group agreed to defer further discussion on topic.

Return of the buffet at Chasers

Management provided an update noting a final proposal will be presented to Board for determination with consideration to costs, profitability, alternative options with the intent of attracting more people to the track.

Members commended the marketing team on the Fun in the Sun events.

Future of WAP

The CFO noted current wagering revenue figures and noted that participants should not expect WAP moving forward. He advised he was available to speak with participants or clubs for clarification.

4.3 Breeding and Breeding Survey

The RM provided an overview of survey responses and requested any feedback from the group. Members questioned if there would be benefit to reintroduce incentives for third litter. The RM suggested an increase to incentives directed at sire may be beneficial. Members suggested a choice of where any incentive applies may assist. It was noted available space in kennels to breed is issue, as well as lack of rearing facilities. The RM suggested initially as an encouragement to remove breeder support restrictions which would lead to increased confidence. He advised he would send suggested amendments to group for feedback. Members questioned a GRSA breeding plan. It was advised that the GM Integrity and Welfare was presenting a plan to Board.

Members questioned if lower breeding levels would lower the GAP waiting list. The WRM noted an increase in younger, unraced dogs to the program. Members suggested greyhounds entering the program be analysed to determine any trends with particular trainers. The WRM acknowledged this was beginning to occur. Members suggested larger breeders from previous years have realised their lack of capacity and therefore have not bred subsequent litters. The RM suggested there was the possibility of SA returning to being a large importer of dogs, creating another market. Members saw positives with decrease in breeding.

5.0 OTHER BUSINESS

The Chair provided an update on the appointment of CEO, with an expected announcement to follow shortly.
