Trainers wishing to receive prizemoney on behalf of the owner must obtain consent from the owner in accordance with GRSA policy, by having the owner authorise the payment below.

In accordance with GRSA Local Rule 69a (SA) (5) – “the payment of any prizemoney or the delivery of any trophy awarded in relation to a greyhound to either the registered trainer or the owner of that greyhound shall be a complete and sufficient discharge to the club conducting a greyhound race meeting”.
