# A hot night of racing for the Festival Of Fire

## ■ ANGLE PARK

**A huge program of racing greeted punters on December 23rd with the inaugural Festival Of Fire with 6 feature races providing many highlights on a brilliant night of racing at Angle Park.**

With a healthy crowd on-course enjoying the last of the 4 Nights of Christmas events, The Flame kicked off the first of the 6 features with a great field contesting the \$14,350 event over the 595m trip. In an exciting race, Victa Jess claimed the win for trainer Clint Tregrove over Victa Emma in the last strides of the race with a fantastic final burst in a time of 34.65.

Frankie Boy then gave Clint Tregrove a double in the next feature, The Blaze over the 730m trip. Frankie Boy didn't have it all his own way with Barbados Express beginning well and holding the lead before the favourite found room through the field to overrun the leader on the home straight and win in 43.24.

The next feature on the night was The Bonfire worth \$21,600 over the 595m trip and it was reserve runner Mallee Magic who gained a start in box 1 for trainer Tony Rasmussen and used the gun draw to his advantage beginning brilliantly. The field chased the early leader but he was off and gone leading all the way to an impressive 34.34 win with the strong Victa Haydn finishing fast in second place.

The first feature over the 530m was next with The Spark and it was an early Christmas present for Clint Tregrove as he claimed his 3rd feature of the night with Kingsville Flyer. In another exciting finish, Kingsville Flyer produced a fast finish to just get his head in front of Kim Johnstone's Brief to win in 30.79 to claim the \$10,000 winner's cheque.

The Inferno was next and provided another quality field to contest the 530m trip with Kirin Corby's Harbor Blues the favourite in box 1 and he didn't let favourite backers down hugging the rail, pinching a break and leading all the way to a 30.48 win. Springvale Maddi chased hard to finish in second a length behind the leader.

The final Festival Of Fire feature, the \$20,000 to the winner Ashes over the 530m and it was a high quality field that greeted the judges. Stout Monelli was the punter's choice in box 7 and he began brilliantly for trainer Tim Aloisi ahead of Sunset Toxic for Ken Gill and Always Ho Ho for Ray Fewings. It was a hotly contested race with Stout Monelli holding off the chasing pack by a length for most of the trip while Victa Grosso began to move up as well on the outside and loomed large on the last turn. However, Stout Monelli did not falter and pushed to the line strongly to win in 30.30 ahead of Victa Grosso who put in a customary strong finish while Sunset Toxic finished third for Ken Gill.

# Aloisi ends year on a winning note

## ■ ANGLE PARK

**The 2021 Kate's A Scandal Xmas Sprint was run at Angle Park on December 30th with Stout Monelli for Tim Aloisi taking out his second feature event in the space of 7 days after claiming the inaugural Ashes Feature the week prior. Stout Monelli banked another \$10,000 for connections in a brilliant display of speed and stamina at headquarters.**

In a select field of five of the best sprinters in the state, the son of Barcia Bale and Corona Monelli started a well-supported favourite in the time honoured feature. Stout Monelli began well from box 6 to push forward to the first turn. He joined Fantastic Victor for Ossie Chegia and Victa Grosso for Tony Rasmussen in a line of three just off Fly For Trix for Jane McNicholl who pushed hard along the rails to gain the initial lead. Foresaken for Neil Mann dropped in behind the group of four as they charged to the first turn.

Out of the front straight and due to some crowding Fantastic Victor and Foresaken were put out of play leaving the big three in the market as the only winning chances left. Into the back straight and Fly For Trix was out in the lead with Stout Monelli in second and making ground to his inside while Victa Grosso looked to follow Stout Monelli. Off the back straight and Stout Monelli had hit the front from Fly For Trix while the big danger was looming as Victa Grosso was hot on his heels. Into the front straight and Stout Monelli was flying in the lead as Victa Grosso came to his outside to issue a challenge however Stout Monelli kicked on in the home straight to go on and win in comfortable fashion by 1¾ lengths from Victa Grosso who tried hard with a further 2½ lengths back to Fly For Trix. His time was a slick 30.33 for the 530m journey with the Thursday nights heats of the SA Sprint Championship his next target. Stout Monelli is owned and trained by Tim and now boasts the impressive record of 43 starts for 23 wins and 14 placings with earnings just over \$211,000.

The race is named in honor of one of the best sprinters ever to come from South Australia. Kate's A Scandal was owned by Gayle Brown and trained by Howard Gray and in 1981 she was considered the best sprinter in the country.

# STOUT MONELLI FINISHES OFF YEAR WITH AWARD

**Greyhound of the Month for December was Stout Monelli for trainer Tim Aloisi who was undefeated for the month, winning all of his three starts and two features along the way.**

The son of Barcia Bale and Corona Monelli started the month off after a six week break with a brilliant win first up in a heat of the Ashes Festival of Fire series at Angle Park. He ran 30.25 in a gritty win and looked every part of the class sprinter that took him to third behind superstar Aston Rupee in the SA Match Race series last September. He then stepped out in the \$20,000 to the winner final and was even more dominant winning as he liked by 1¼ lengths in a slick 30.30. With only one more feature left in 2021, Stout Monelli was in a select group of five sprinters for the Kate's A Scandal Xmas Sprint and again he won as he liked by 1¼ lengths in 30.33 proving he is very hard to get past in his races and that he is right back to his very top.

At the end of the month Stout Monelli's impressive record stood at 43 starts for 23 wins and 14 placings and earnings just over \$211,000.



# VICTA HAYDN CLAIMS ROTM WITH HUGE 595M WIN

**The Run of the Month for December was Victa Haydn for trainer Tony Rasmussen after his brilliant performance over the 595m at Angle Park on Thursday, 2nd December.**

Blessed with speed and strength the son of Fernando Bale and Victa Victoria surprisingly was able to lead from box 4 and at the winning post on the first occasion, as his lead began to grow, most onlookers started to look at the clock as to what time he would run. Victa Haydn kept getting further and further in front of his rivals and raced away for a dominant win by 7½ lengths. His time of 34.07 was only .01 outside of the fastest time on the track set by start stayer Sir Truculent.

GRSA administers the event for the Gawler Club, so all payments are to be made to GRSA. If you have already made the one off payment then there is nothing more to do, however, if you only made the first payment the second lot of payments are due on Friday, 28th January 2022 with the third and final payment due on Friday, 1st April 2022.

The paperwork will be posted early next week so keep a look out for them in your letterbox.

## LOCAL MATCH RACE SERIES “THE SA EASTAR” IN APRIL

The SA Local Match Race series coined “The SA Eastar” will be held on Thursday night, 14th April (Easter) at Angle Park.

Eligibility for South Australia local greyhounds will be based around the Nationals conditions. They will need to be trained in SA 76 days out of the last 150 prior to the close of nominations.

Selection for this series will only be based around winning times at Angle Park. For greyhounds that have run over the 530m at Angle Park on any meeting since 1st November, 2021 their fastest winning time will be recognised and put them on the list for selection.

The head to head matches will be decided based on the final listing and nominations. Match 1 will be 1 v 4, Match 2 will be 2 v 3, Match 3 will be 5 v 8 and Match 4 will be 6 v 7. There will be no manual selection from the Grader. The top 4 seeded greyhounds will be rewarded with more prizemoney.

The overall winner of the local Match Race series will be offered a spot in the State of Origin Match race series (SA V Vic) in September so long as it is nominated and eligible to represent SA subject to changes.

Winners of match races – Match 1 – 1 v 4 \$4,500, Match 2 – 2 v 3 \$4,000, Match 3 – 5 v 8 \$3,500, Match 4 – 6 v 7 \$3,000

## GRSA SKY WEEKLY SCHEDULE CHANGED FROM 1st DECEMBER 2021

From the start of December 2021, the Sky weekly schedule of greyhound racing in South Australia changed. The first two Sundays of any month will routinely be scheduled at Murray Bridge with the remaining Sundays being allocated to Gawler.

The primary reason for the change was about providing both of those Clubs with an accessible weekly timeslot which helps them to cultivate a strong base of local patronage.

In regard to trialling at these clubs, when we race at Gawler on the Friday they will trial on the Thursday before. When we race at Gawler on the Sunday they will trial on the Friday before. Murray Bridge trialling dates will remain unchanged.



## KURT DONSBERG CHANGE OF ATTENDANCE DUE TO RACE SCHEDULE

With the change in the race schedule from December our Oncourse Photographer, Kurt Donsberg has restricted his attendance at the Murray Bridge Straight Track on Tuesdays unless there are Feature Heats and Finals conducted and focus on the Friday and Sunday events at Gawler and Murray Bridge.

Those wishing to take a photo when Kurt is not in attendance after the event please liaise with the stewards on the day/night.

## COMMENTS ON NOMINATIONS MARKED "ONLY"

A few years ago the Grading Review Panel agreed that some trainers were using the comments box to influence the grading of fields in particular Grade 5 Only for all their greyhounds.

The panel previously resolved that "Only" would be disregarded over all distances and the grading left to the Grader. [Masters Only or Juvenile Only will be accepted as this is for a specific type of race]

If trainers put "Only or no start or leave me out" then the grader will grade as normal and if a greyhound would be graded into a mixed event based on race wins then he will leave them out based on the trainers request. The more information provided to the Grader allows for him to accommodate those requests.

## WINNING GRADE 6 RACES IN ORDER

GRSA reminds trainers to win their grade 6 events in order at a specific venue.

For the venues that allow two Grade 6 wins trainers need to win a Grade 6 over one distance and then a Grade 6 over the other distance. If a greyhound wins a Grade 6 and then a Grade 5 then they will lose their Grade 6 over the other distance at that venue.

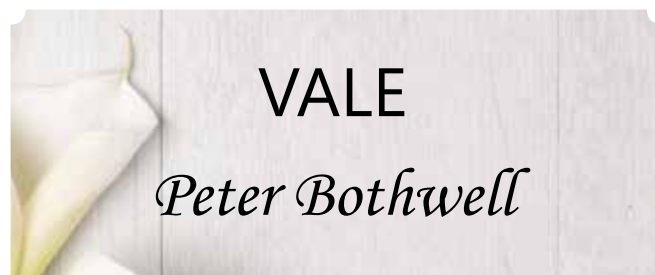
## RE-GRADING FOR ALL TRACKS AND DISTANCES

Re-grading will occur for all tracks and distances for Grade 3 or higher greyhounds.

A trainer can apply for a re-grade after two unsuccessful nominations over the corresponding distance. If having met this criteria the responsibility is on the trainer to apply for a re-grade prior to the close of nominations. Only one distance will be considered for a re-grade per meeting.

## COVID-19

**We saw in the new year with the challenge of increasing community transmission in SA, after the borders opened on 23 November 2021.**

I thank you for your patience while we try our best to respond to this next phase of the pandemic. The goal is to keep as operational as possible, juggling community safety with our ability to provide adequate resources. You will see from the popular news media that how governments deal with transmission sometimes changes throughout a given day, so it is a challenge to keep up. What seems to be emerging now is a going back to basics – masks and social distancing. Please keep in mind the following tips when out and about –

- Use QR-code check-in [or at least manual forms]
- Wash hands often
- Avoid touching others [no handshakes, kissing]
- Maintain social distancing [1.5m]
- Where possible, limit your duration of contact [< 15min. ideal]

- Spend more time outdoors [avoid low ventilation areas]

## CLOSE CONTACTS

**GRSA assesses possible exposures when the need arises. We greatly appreciate information from anyone who is impacted.**

The important information to assess a close contact [on a case-by-case basis] is –

1. Were you a household member with a COVID-19 case during their infectious period [see below]?
2. Did you have close personal interaction with a COVID-19 case during their infectious period [see below]? What this means is, was your exposure –
  - a. for 15 minutes or more [cumulative]; AND,
  - b. during that period, both you AND the case DID NOT wear [a properly fitted] mask; AND,
  - c. you were in close proximity [< 1.5m]; AND,
  - d. were you indoors?
3. Have you been notified by SA Health that you are a close contact?
4. Has the location of the exposure been designated by SA Health as an exposure site [including publication on [www.sahealth.sa.gov.au](http://www.sahealth.sa.gov.au)]?

The infectious period is the period commencing 2 days prior to the onset of symptoms, or a positive COVID-19 PCR test result [whichever is earlier] and ending 10 days after their first positive COVID-19 PCR test result.

A close contact must –

- \* Immediately quarantine for 7-days since they had contact with the case or were at the exposure location.
- \* Get an initial PCR test.
- \* Get a PCR test again on day-6 if initial test negative [a negative day-6 PCR test is required to be released from quarantine].
- \* Get a PCR test immediately if symptoms develop [be mindful of symptoms for up to 14-days].
- \* Not attend high risk settings or COVID Management Plan events for 14-days after exposure.
- \* Wear a surgical mask when around others.
- \* Avoid contact with vulnerable people, avoid non-essential activities where possible and avoid shared spaces and maintain physical distancing on days-8 to-14 after exposure.

These close contact requirements are now the law of South Australia. GRSA cannot revoke or vary these requirements.

## MURRAY BRIDGE TRACK

**Management and the Murray Bridge maintenance team have had a review of the presentation of the 1-turn track for the race meeting on Sunday 2nd January.**

There was a general consensus that the presentation of the track, which was too heavy, particularly on the rail, was not up to the very high standards that the team place on themselves.

Whilst there were some mitigating circumstances, including key staff being on annual leave, this should certainly not impact the way our tracks are presented for trials and on race day.

To the credit of the Murray Bridge team, they worked hard during the week and the presentation of the track for the race meeting on Sunday 9th January was excellent, back to the standard we all expect.

Learnings have been gained from this experience and the team will use these to ensure that regardless of the circumstances, that the track is presented consistently into the future.

The 1-turn track was harrowed this week and from all reports has come up very well.



## SYNTHETIC LURE USE TO COMMENCE

**GRSA will commence using the new synthetic lure at Angle Park, Gawler and Murray Bridge on Monday 31 January, 2022 for all race meeting and trial sessions.**

The Mt Gambier club started using the new lure at the race meeting last Sunday without issue and the material stood up well to the finish on races conducted on the day.

Management is still in the process of sourcing material that can be provided to trainers to assist in the education of greyhounds, similar to the type they were previously supplied.

It is expected that this stock will be available towards the end of the month and GRSA has made a commitment to change over lures previously supplied to trainers free of charge.

# NOTES OF INDUSTRY CONSULTATIVE GROUP (ICG) MEETING

HELD IN THE BOARDROOM OF GRSA, 55 CARDIGAN STREET, ANGLE PARK

ON FRIDAY 16 DECEMBER 2021 AT 10.00AM

The meeting commenced at 10.04am.

## 1 APOLOGIES

Matthew Corby, Ray Fewings

The Chairman welcomed the new panelists. He noted the CEO's resignation and indicted the recruitment process was moving forward with an expected appointment in April 2022. He committed to continuing the clear communication to industry.

## 2 NOTES FROM PREVIOUS MEETING

Noted.

## 3 BUSINESS ARISING FROM PREVIOUS MEETING

### 3.1 Updates from Minutes

The Group noted the update. Discussion around Angle Park kennelhouse drainage which the Group noted had improved. Current status of emptying out yards projects at Murray Bridge, Gawler and Angle Park, working through ideas to overcome challenges. The Chairman advised the unfeasibility of reintroducing buffet to Angle Park. The Group noted current issues with Thursday night hospitality service. The panel noted issues with kitchen closing at 9pm not allowing enough time to order and receive desserts. Management acknowledged issues and committed to working with hospitality to address these.

Some members noted their objection to singling out the elevation of 350m straight track racing, suggesting both distances should be equal. The Chairman noted all prizemoney will be assessed in Feb/March 2022 and recommendations brought back to ICG for comment.

### 3.2 Management of Gastro and Participant Impacts

The IM questioned the Group whether there would be appetite in exploring options for compensation to kennels affected by Gastro. Some members suggested, as one of those affected kennels, they would have appreciated any compensation, indicating \$4 per dog per day would be sufficient. The COO questioned if this amount would incentivise trainers to notify of outbreaks. Some members suggested some trainers no matter the money would still not notify. The Chairman suggested \$5 per dog per day for any affected kennels would be fair and sufficient. Members questioned the reliability of OzChase and whether all dogs would be accounted for. The IM suggested the Animal Welfare team would do a kennel visit to confirm numbers at the time of outbreak. It was suggested that the scheme be expanded to other communicable diseases such as parvo.

It was suggested that it could be expanded to anything that the group would consider dangerous and impactful.

## 4 AGENDA ITEMS

### 4.1 Transition to Synthetic Lure

The SPM presented the proposed synthetic lure as well as the dual lure. Members indicated their support for the new synthetic lure and suggested they would purchase some from GRSA [at approx. \$25] however did not support the double lure. Members suggested the double lure did not serve any purpose. Members suggested a double arm would not work with finish on lure at Mt Gambier. Members suggested the lure needed to be larger, with more white on top of lure as well as a contrasting colour on hood that was stationary. The Group suggested a blue hood with white band and low to the ground as possible. It was noted any issues with changes to lure should be raised through this Group to be addressed as necessary. Members suggested increasing tassels to nine. It was suggested to introduce the new design to trials in early January and then to racing mid-January.

### 4.2 Barking Muzzles

Vet Jane McNicoll joined the meeting regarding Barking Muzzles. The group discussed this topic and felt there were some positives and negatives. Management was to consider their next approach to this issue.

Action: Management to discuss next approach to this topic.

### 4.3 Treatment of Pannus

The IM provided background to the issue and sought the Group's input on the introduction of a policy. Jane McNicholl agreed with not allowing breeding from affected greyhounds, noting it was an inherited trait. The Group agreed treatment should be allowed and for trainers to declare treatment. Jane McNicholl agreed that the amount of medication absorbed would not be performance enhancing, however suggested the introduction of a threshold. The Chairman requested the issue be raised at national level around restrictions with breeding with pannus.

Action: The IM to draft policy on treatment of pannus which would include requirement of vet proof as well as thresholds.

Jane McNicholl left the meeting at 11.17am.

### 4.4 Sustainable Breeding Levels

The Chairman provided background to the topic.

Some Members believed there had been an increase to local breeding due to shortage nationally. Members questioned if restrictions would be imposed on breeders' rebate with number of litters. The RM advised there was no restriction at present. Members suggested restricting rebate would allow for restriction of breeding. The Chairman noted the relationship with breeding and GAP.

The RM noted steady increase of breeding numbers over five years, and it's maybe time to consider changes to breeding restrictions. The COO noted that management are considering how to equitably apply litter thresholds to different size kennels [in the event that some form of restriction becomes necessary]. Members suggested



some larger operations were scaling back so there was a need to increase breeding. Members suggested need for responsible breeding. The Chairman noted and appreciated all comments.

#### **4.5 Lure Noise**

The SPM provided background to issues, noting suggestion lure could not be heard from outside boxes. the SPM noted statistics did not support this however would introduce if group requested. Members suggested additional noise was essential. Members agreed Angle Park lure was very quiet. Management agreed to trialing various options and presenting to group for their opinion.

#### **4.6 Limited Monthly Starts**

The RM sought the Group's feedback on any proposed restrictions. Members questioned if coursing would be included. Members suggested straight track should be excluded. Members agreed with limiting monthly starts. Consensus from Group was that 455m+ should not be racing more than six times per month on circle track. Members suggested dogs only racing 300m could be increased to eight per month. Some Members voiced their concerns on the effect on Mt Gambier suggesting it would severely hurt nominations. Members suggested restricting by total distance raced. The RM noted challenges with managing any restrictions. It was noted the topic had been flagged with ICG and committed to retaining it on the agenda.

#### **4.7 Pups Within the Context of Syndication**

The RM advised the CEO's opinion that there was a greater opportunity with pups for syndicates. Members suggested further to this opportunity to purchase brood bitches. It was noted there was no guarantee with pups. The COO noted issues with syndication process, advised of potential solution moving forward. The Chairman advised Management will monitor national situation and work towards using pups in future.

#### **4.8 Extended Kenneling – Injury Prevention**

The Group noted the update. Some members questioned if potential to have option available to have water containers in kennels at kenneling, referencing NSW rule utilising bottled water. The Chairman requested the COS to investigate and implement an option to provide water to dogs whilst in kennels.

#### **4.9 Appeal Process for Marring and Failing to Chase**

The IM detailed changes to process. The Group noted the update.

#### **4.10 Greyhound of the Year/Outstanding Achievement Awards**

The RM noted current nominations. Members wished to nominate a couple of worthy recipients as options. The RM requested any further nominations to be forwarded to him ASAP. He sought feedback from the group on conditions of some awards, noting this was an opportunity to restructure awards. It was noted SA Syndicate of the Year had the potential to restrict award to syndicates of 5 or more. Owner/Trainer award potential to alter, ie registered for less than 5 years, as well as including Rising

Star award. It was suggested the Strike Rate award to include all tracks. It was noted Gawler Track Star is the only Club acknowledge separately. Suggested each club have a Track Star award. Further suggested to highlight 100 winners for trainers per season, ie 100 Club as well as Overall State strike rate award. The RM to look to implement more so for next year as this year is almost completed.

### **5. OTHER BUSINESS**

#### **5.1 Track Injury Rebate Scheme – Including Trials**

The IM acknowledged the potential for inclusion of trials under scheme which will be put to the Board for consideration. Members highlighted increased veterinary costs which the Chairman acknowledged and advised improvements to scheme will be considered by Board at next meeting to accommodate for these increases.

#### **5.2 Mt Gambier and Murray Bridge Cups – Group 3 Status**

The RM suggested it would be optimal to have Mt Gambier, Gawler and Murray Bridge Cups at Group 3. The Chairman suggested the Board would be supportive of this. Some members noted their objection to this approach suggesting was not appropriate for Mt Gambier to be classed as Group 3, preference was to be increasing lower grade prizemoney. Other members noted Mt Gambier recent cups and their success with quality fields and what would be relatively small increase in prize pool to raise to Group 3. The Chairman advised the status of all these races should be at Group 3 level and would consider this in the prizemoney budget

#### **5.3 Bullying Incidents**

Some members highlighted incidents of bullying continuing to occur at track, some of which had been reported to the Chief Steward. The IM advised those reported are being addressed. Some members suggested the current environment at the track is toxic and needs to be addressed.

#### **5.4 Auction Series**

Members requested consideration to the auction series in next financial year. Members will provide a request in writing to be presented to Management.

#### **5.5 Chasers Air Conditioning**

Members requested the air conditioning upstairs at Chasers [Punters Bar end] be looked at.

#### **5.6 Research**

Members questioned if a formal process for targeting research existed. The IM advised this is topic is on GA's agenda.

Members further requested mobile phones be allowed in parade area to allow for live parading. The COS committed to investigating the opportunity.

# WAP payment update for November 2021

Greyhound Racing SA Limited (GRSA) advises that the Wagering Activity Payment (WAP) for the month of November 2021 amounted to \$84,000.

It is much lower than recent months and is a consequence of a 27% reduction in net wagering revenue from October to November. As forewarned in previous months, wagering revenue had been showing signs of softening as COVID restrictions lifted in New South Wales and Victoria; an outcome that appears to be manifesting now. GRSA will continue to monitor and report on wagering trends in future WAP announcements.

## Distribution of WAP Payments between Trainers and Owners

GRSA would like to remind all participants that receive a WAP that the payment is the equivalent of prizemoney.

If you are currently responsible for distributing prizemoney to another party then the same approach applies to WAP payments.

From GRSA's perspective the position in relation to third parties is reflective of OzChase records and is as follows:

- If GRSA have been notified of an ownership split [which is recorded in OzChase] then you DO NOT need to make a payment to owners for the WAP because GRSA will do this automatically; however
- If you ordinarily forward on payments to owners on your own accord, then you DO need to do the same for the WAP. Each remittance will include the name of the dog for which the WAP is being made.

### Example to help participants understand the WAP they receive

It is not uncommon for GRSA to receive requests for more information in relation to how the WAP is calculated for their particular dogs(s). The example below is provided to assist in the general understanding of the calculation.

### Assumptions:

In this example, assume the owner/trainer received **\$1,000** in prizemoney for any/all races for the month.

In this the total prizemoney (paid to all participant) is **\$700,000**.

In this example, the total WAP is **\$50,000**.

In this example, the owner/trainer would receive a WAP of **\$71.43**, calculated as:

$$\text{\$1,000} \div \text{\$700,000} \times \text{\$50,000} = \text{\$71.43}$$

### Participants should note that:

- WAP is not payable for any prizemoney received in relation to feature races [where total stakes are above \$5,000];
- Trainers' fees and other bonus payments are not included in the calculation of the share of the WAP; and
- It is a requirement that a greyhound has to have raced and received prizemoney during a month to be eligible to receive the WAP payment for that month.

# Salt and Pepper in strong form at Gawler

## ■ GAWLER

**Greyhound racing was at Gawler on Friday 7th and we were treated to a strong eleven race program.**

Two out of the eleven races were over the longer distance of 643 meters. Wizardry Things won the first race over that distance comfortably for trainer Troy Murray. Salt And Pepper took out the second race over the longer distance for trainer John Sargent. She found the lead early from box two and was nearly run down by the race favourite Zipping Nebraska but she held on to win by a very small margin. This was Salt And Pepper's third win from her last five starts. All three of those wins have been over 643 meters at Gawler. She has now had the 53 starts for 7 wins and she is really developing into a nice longer distance greyhound.

Winning trainer John Sargent stated that he "always believed this greyhound could win over any distance if she jumps well. She always finishes off her race strongly". John mentioned that "her last couple of months have been exceptional. She turned three years old in October so she is starting to get a bit more mature which may of helped her get the hang of jumping from the boxes more consistently". When asked about his plans going forward with Salt And Pepper John stated "that it's all about

shopping around and finding the right race for her. Now that she has won her grade 6 race it makes it a little harder. I still think she can win races over 500 if she jumps well".

Also on Friday afternoon we saw three trainers secure doubles. The first two races on the program went to Lewiston trainer Kevin Bewley. Off Switch led all of the way in race one for Kevin running a time of 23.31 and then kennel mate Escape Inn followed it up in race two

running a time of 23.30. Ben Rawlings also managed to score a double with both winners coming from the 531 meter boxes. Snakebita Diva ran 31.59 while Threaten made it two in a row running a time of 31.22. Clint Trengove was the third and final trainer to get a double on Friday when he took out race six with Gypsy Boy who ran a time of 22.98. Its Smudgy took out the final race for Clint and she ran a time of 22.71.

# GAP kennelling fee payment process change

Please note that as of 1st August 2021 the GAP kennelling payment process has changed for a trial period of three months.

The changes are as follows:

Instead of making a weekly payment of \$33 per dog, the new kennelling fee will be a flat amount of \$50 per dog, irrespective of the time period the greyhound will spend at the GAP kennels.

Participants who would like their greyhounds placed in the GAP kennels will be requested to pay the \$50 at the time when the placement form is filled in and the \$60 placement fee is paid.

This means that for greyhounds that are to be kennelled with GAP an upfront payment of \$110 will be requested. After that, participants will not need to make any additional payments for their dogs in the GAP kennels. Noting that prior to foster care dogs spend an average of 4 weeks in kennels, this change is expected to generate a saving of \$82 per dog for participants.

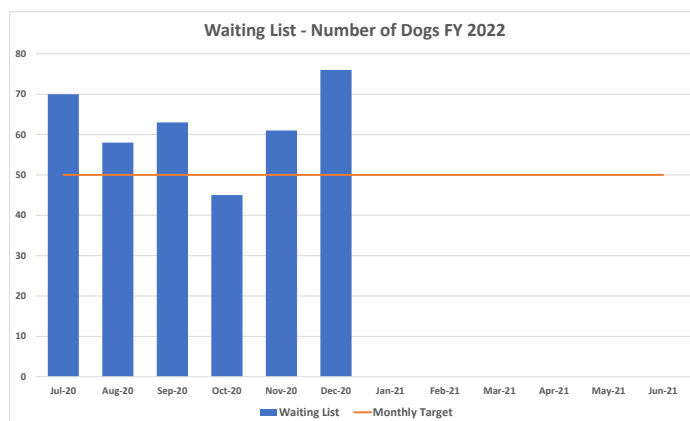
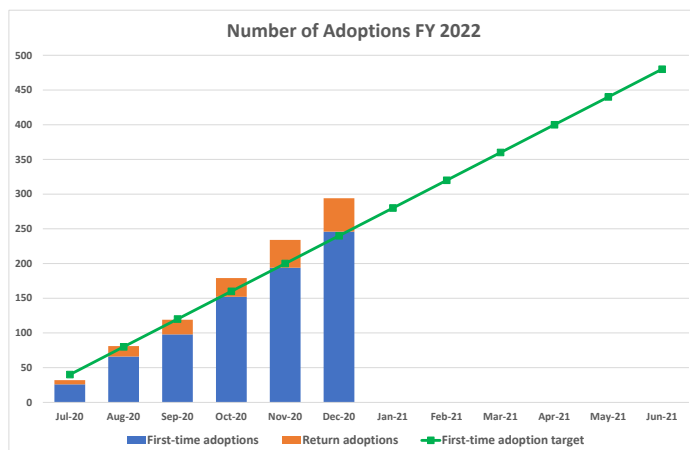
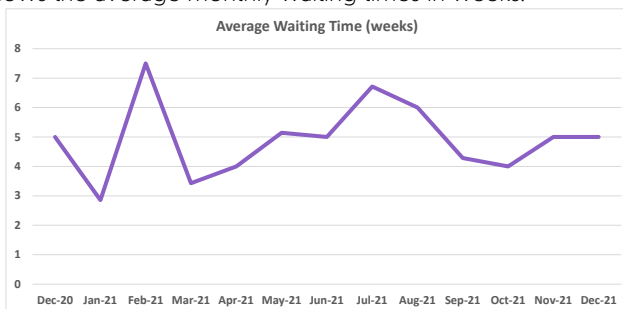
# Latest updates from GAP

# Rookie trainer lands his first winner

**It was only 12 months ago that Branholme owner-trainer Laughlan McLean was at Tara Raceway with his first greyhound – Granny Said Go.**

And while she ran a few placings, he soon opted to move her on to another kennel in order to spend more time with a black dog pup by Aston Dee Bee that he had purchased from NSW.

That pup, whelped in May 2020 and now racing as Diego, made his debut over 305 metres at the Mount Gambier track on Sunday, 9th January. In a dashing display, he soon rounded up the Progreyhoundtips.com Maiden Stake field, before racing away for a 5¾ lengths win in 18.12 seconds.

For McLean this was his first win, the 36-year-old attributing much of the success to his mentor – well known greyhound man Phil Lenehan of Toolong.

"It was purely by chance that one night, prior to becoming actively involved, I bumped into Phil at the Warrnambool dogs. He's been a tremendous help ever since," said McLean.

"And when I told him I was looking for a pup he suggested I give serious consideration to Aston Dee Bee as a sire. Later, I purchased Diego as a pup through an advertisement posted on Greyhound Data.

"Since then it's been a real hands-on exercise. He came down by road from Sydney and I picked him up at Geelong. Then I reared and broke-in Diego myself prior to taking on the training."

Diego's dam is eight-race NSW winner It's A Shame, a daughter of Collision x Ritza Rita, and a litter sister to Rita's Boy who won

24 races and \$140,000 in stakemoney.

And McLean will soon be making another trip to Geelong, to pick up a pup from It's A Shame's second litter, this time by Ritza Lenny.

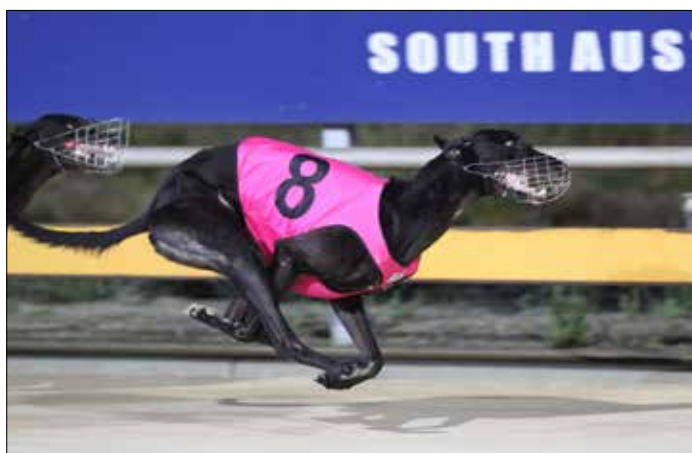
# Brook starts off year with treble at the Bridge

# TRIALS

## QUALIFYING AND SATISFACTORY TRIALS

Angle Park qualifying and satisfactory trials are held every Tuesday night between 6.50pm and 7.15pm. Qualifying will be for the following Monday (drawn Thursday) meetings. Nominations close at 12.30pm on the Tuesday (for online nominations 11.59pm Monday).

Gawler qualifying and satisfactory trials are held every Friday morning from 7am. Qualifying will be for the Sunday meeting (drawn the following week).

Nominations close at 12.30pm on the Thursday.

Murray Bridge qualifying and satisfactory trials are held every Wednesday night between 6.50pm and 7.15pm. Qualifying will be for the following Friday (drawn Tuesday). Nominations close at 12.30pm on Wednesday (for online nominations 11.59pm Tuesday).

# ANGLE PARK

## SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

## BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number or alternatively logon to trialbooker.com, create an account and book your own trials.

## POLICY FOR TRIALLING AT ANGLE PARK, GAWLER AND MURRAY BRIDGE BEFORE THE RACE MEETING

### Policy Background

This policy is to detail the procedure for trainers seeking greyhounds to trial before race meetings. This policy is effective from 2 May 2019.

### Race Meeting Trial Policy

This policy is in place for the following race meetings:

Angle Park Monday, Gawler Wednesday and Sunday, Murray Bridge Tuesday and Friday.

Two fields from the boxes with a maximum of four (4) greyhounds. Trials may be conducted at any time during the race meeting from immediately after kenneling until after the last race, at Stewards' discretion.

The following lists the order in which greyhounds will be selected in the event if more than eight (8) greyhounds are nominated:

1. Reserves at the meeting that do not obtain a start
2. Trainers that have greyhounds engaged and are located more than 100km in distance from the track
3. Satisfactory trials

#### **Procedure/criteria**

1. For Angle Park Monday night, the trainer is to contact GRSA between 9am and 10am on Monday to nominate. Should the Monday be a public holiday bookings are to be made between 8am and 9am on the scratching number.
2. For Murray Bridge Tuesday & Friday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times.
3. For Gawler Wednesday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Gawler Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
4. Other than reserve greyhounds, trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
5. Stewards will allocate the box for the greyhound.
6. Trials will be 515m, 530m & 531m in distance as first preference. Other distances considered depending on nominations.
7. Greyhounds currently under suspension are ineligible to trial unless they are undertaking a satisfactory trial to be cleared.
8. Greyhound registration cards must be produced at kennelling time.
9. Trainers with other greyhounds engaged can utilise the extra kennel space until such time they are ready to leave.  
Trainers with no other greyhounds engaged will be permitted to leave with Stewards permission.
10. In the case of race at Murray Bridge, trials will only be available on the track that is prepared to race that day i.e. Friday meeting on the u-shaped track, trials will be on the u-shaped track only.

Please note: If there are 12 races at Angle Park, Gawler or Murray Bridge there will be NO trials.

The Angle Park Vet Clinic and/or swab kennels cannot be used to accommodate any additional greyhounds due to operational requirements of the Clinic and Stewards.

It is vital that trainers nominate to trial at these race meetings. If you are unable to nominate at these times, please contact GRSA as soon as possible as permission may be given at GRSA's discretion to accept bookings outside these times.

#### **Exceptions to this policy**

Thursday nights are kept available for interstate greyhounds to solo trial in a lead-up to SA Group races as well as local greyhound's trialling for Group racing interstate.

Upon request, local greyhounds will be allowed to solo trial in a lead-up to a feature race and they will take one of the eight (8) kennels available for trialling greyhounds ahead of the policy and sit separate to the four (4) dog trials. Races considered to be a feature are: Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals and any interstate Group race

Local greyhounds will be permitted to trial on a race night, where they are in preparation for a feature event, nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy. If a greyhound qualifies for a feature final and requires a trial in between, this will be conducted as a solo trial and will sit separately to the four (4) dog trials.

### **MOUNT GAMBIER SATISFACTORY TRIALS**

Trainers are advised of a change to the booking of Satisfactory Trials at Mt. Gambier. Mt Gambier hold trials on Tuesday and Saturday mornings with Satisfactory trials ONLY being conducted on Tuesdays and need to be booked with Barry Shephard from the Club on 0419 824 512.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shephard.

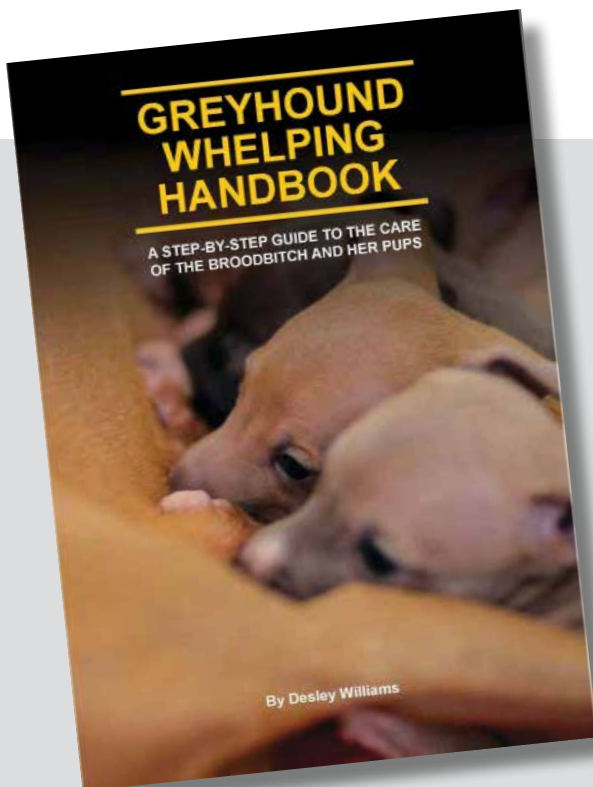
