A MESSAGE FROM THE CEO BRENTON SCOTT

Greyhound Industry Reform Inspector

As participants are no doubt aware, the SA Government has appointed Sal Perna AM as the Greyhound Industry Reform Inspector.

Mr. Perna is a former Victorian Racing Industry Integrity Commissioner who also prepared a report that successfully provided guidance to the Victorian greyhound racing industry as it emerged from animal cruelty issues in 2015.

The SA Government has now confirmed that Mr. Perna will commence duties from July 1, 2024. His role will involve overseeing GRSA's implementation of the recommendations arising from the Independent Inquiry into the Governance of the Greyhound Racing Industry, authored by Graham Ashton AM and published in November 2023.

I am looking forward to working with Mr. Perna to initially outline the work GRSA has already undertaken in progressing the recommendations and, further, to engage positively as our industry embraces the required industry reform that will underpin a strong and resilient future.

Strategic Plan

The GRSA refreshed Strategic Plan remains on schedule for publication in mid-July. The plan was last reviewed in 2022 and the current refresh allows us – as a united industry – to assess and confront the unique challenges before us.

Every effort has been made to include participant input as the new plan has been shaped. Indeed, all participants were invited to contribute to an electronic survey and I thank those that took the time to provide valuable input.

A stakeholder workshop was also conducted earlier in June and the objectives and actions of the plan were discussed and challenged in detail. The workshop was externally facilitated (Marc Makrid and Associates) with Board, management, club and participant attendees.

I thank all attendees for the efforts applied, in particular the club nominated representatives Petar Jovanovic and Bob May and Industry Consultative Group representatives Gavin Harris and Christine Costa.

Kelly Rourke resignation

Kelly Rourke, General Manager of Integrity and Welfare, resigned from GRSA earlier this month in order to pursue other opportunities. Kelly had been with GRSA since April 2023.

Executive oversight of integrity will, in the immediate future, transfer to Derek Kordick in addition to his responsibilities as General Manager, Risk and Compliance. Derek's policing, compliance and legal background will be put to great use as GRSA continues to develop its integrity framework to best practice standards. Executive oversight of welfare will, for at least the interim, be absorbed within my CEO responsibilities. Welfare is obviously a central point of judgement as the industry's future form is agreed and aligned with community expectations.

I am looking forward to working with the extremely hard working welfare and Greyhound As Pets teams and participants as we continue development of GRSA's welfare framework, appropriately balanced with oversight, enforcement and strong levels of participant self-compliance.

Coursing and Breeding stimulus

It was pleasing to announce this week a prizemoney increase for coursing meetings and a significant boost to the Breeders Support Programme.

The increases to both are covered on pages 4 and 5 in this edition of Kennel Capers.

Coursing is directly connected to greyhound's racing oldest form of racing competition and the prizemoney injection underscores GRSA's commitment to preserving the sport. With prizemoney now on a sound foundation, it is hoped nominations and interest now also grow.

I had the pleasure of attending a coursing meeting at Virginia last Sunday and it was clear that the competing greyhounds enjoyed the experience thoroughly. The same seemingly applied to participants with regard to the informality and old school comradery that prevail at these gatherings.

Particularly pleasing to be increasing the support to our breeders. Confidence in the future of our industry starts with breeding and the rebate increase should reinforce with breeders that GRSA deeply respects the fundamental contribution they make to our industry.

Lovely to see industry stalwart Ron Schadow recognised so significantly on his recent 90th birthday with GRSA posting a video tribute and naming a race after him.

A gentleman in every sense of the work, Ron epitomises the quintessential Australian. Possessing an incredible appetite for hard work, he has lived a full life loving the land, his family and his greyhounds.

It has been a privilege to be a small part of Ron's life since the late 1970's.

Appropriate that mention is made of the interview undertaken by GRSA Director Ray Fewings at Ron's presentation. A great and engaging chat – and best of all, Ray booked Ron in for an encore performance in 10 years' time, a challenge Ron gleefully accepted. Bravo!

Graham and his late wife Jenny were dinky di greyhound folk who cared for their dogs well and quietly enjoyed their share of success. Greg enjoyed success as an owner (Go Harvey Go being his best) but was better known for his contribution as a bookmaker at smaller Non-TAB race meetings across SA. Another making a vital contribution to this way of life we call greyhound racing.

SA Breeders Support Programme set for big boost

South Australian greyhound breeders are set for a significant boost with rebates under Greyhound Racing SA's Breeding Support Programme to increase, effective immediately.

Under the current programme, breeding support is capped at \$2800 but the total now claimable under the programme will escalate to \$5500 per litter to further demonstrate GRSA's recognition of the importance of the SA breeding industry.

Breeders claiming under the new rebate will not only be able to claim for greater amounts but also for wider variation of breeding costs including stud fees, veterinary and transport, vaccination costs and whelping costs.

The rebate will apply to all SA bred and whelped litters where the mating took place on or after April 1, 2024.

While acknowledging that breeding activity in SA had reduced significantly in the past 12 months, GRSA CEO Brenton Scott said the increased rebate had reaffirmed GRSA's commitment to local breeding.

"While there are a variety of reasons for the recent downturn in breeding, GRSA is very keen to demonstrate its support for the local breeding industry," Scott said. "SA boasts a long and successful breeding industry, and to this day, we continue to produce an excellent proportion of quality breeding outcomes.

"GRSA wants to continue supporting breeders that are showing confidence in the future that GRSA and participants are collectively building.

"We believe that the increased breeding support will allow breeders to make the best possible breeding decisions and hopefully incremental improvements to overall quality will also materialise."

Existing support, on and above the \$5500 rebate, will also continue including no fees for whelping or litter registration and a \$180 rebate for DNA costs for breeding females.

While the rebate applies to litters conceived on or after April 1, 2024, GRSA will also reward each of the breeders that have supported the industry in the current financial year with a one-off bonus payment of \$1000 for any litter whelped during FY24, prior to the new \$5500 rebate applying.

"We understand the challenges breeders have confronted during the past 12 months and this bonus payment is another way of acknowledging their vital contributions to our industry," Scott said.





Coursing to receive prizemoney injection

Greyhound Racing SA in conjunction with the GOTBA are pleased to announce that there will be an immediate boost to prizemoney for coursing, beginning from the second half of the 2024 season.

The prizemoney injection will ensure that eightdog coursing events align with prize money for time-graded track events while there will be significant increases for the Oaks, Derby and timehonoured Waterloo Cup.

Total prizemoney for the Waterloo Cup with rise from \$4000 to \$8000 while the Oaks and Derby will increase from \$2650 to \$5000.

CEO Brenton Scott said that the prizemoney boost reinforces GRSA's commitment to support participants and create opportunities for greyhounds at all levels.

"We are pleased to announce this boost in prizemoney for coursing, further reinforcing our commitment to create continued opportunities for all of our participants," Scott said.

"Coursing at Virginia and the Waterloo Cup has a rich history in our sport and the additional prizemoney will ensure that it remains an important part of our racing calendar."

As part of the prizemoney overhaul, the entry conditions for the coursing Oaks ad Derby will also change slightly with the whelping date for entry now moving to on or after June 1, 2022 to align with the eligibility criteria for the Oaks and Derby conducted on the track at Angle Park. In addition, nomination eligibility requirements for the Oaks, Derby and Waterloo Cup will require that greyhounds contesting these events must have competed at one coursing meeting in 2024.

The increase in prizemoney will take immediate effect, beginning with the coursing meeting on Sunday, July 14. Further coursing meetings will be staged on Sunday, August 11 and Sunday, September 8 followed by the Oaks, Derby and Waterloo Cup meeting later in September.

New Prizemoney (Beginning 14th July 2024)

4 dog coursing events – first \$350, runner up \$110 (Up from first \$265, runner up \$90)

8 dog coursing events – first \$525, runner up \$160 (up from first \$380, runner up \$120)

Waterloo Cup – first \$6,000, runner up \$1,600, thirds \$200

Oaks – first \$3,700, runner up \$1,000, thirds \$150

Derby – first \$3,700, runner up \$1,000, thirds \$150

Entry conditions for Derby, Oaks and Waterloo Cup: Must have had 1 start at any Coursing venue during 2024 to be eligible for the Waterloo Cup, Oaks or Derby.

Bonus – If the winner of the Derby, Oaks or Waterloo Cup is a greyhound that has raced at two Virginia Coursing meetings during the 2024 season, a \$500 bonus will apply.





Yoda Lady Trimuphs in Group 3 Howard Ashton Final

Yoda Lady delivered trainer Lauren Harris her first victory in the Group 3 Howard Ashton Final (530m) at Angle Park, finishing strongly in the closing stages.

The daughter of Blazin Wildfire and Galactic Athena sustained an unbroken winning streak in the three-week SA bred-only series, clinching the \$25,000 top prize while racing for-Steve and Lee Bartholomew achieving an impressive sixth straight win and demonstrating an outstanding performance.

Beginning the race as the \$2.25 favourite from box 2, Yoda Lady was not the fastest off the mark, but displayed impressive mid-race speed and worked her way through from the back half of the field to catch up with the early leader, Zinfandel Evie for Cherylee Barber, and won by one and a half lengths in 30.85 seconds.

"Absolutely thrilled. She performed exceptionally well," trainer Lauren Harris told GRSA's Luke Marchioro.

"I must admit, I was initially concerned when she missed the start, but she quickly secured a strong position early in the race and powered through to the finish line. It was indeed an impressive performance."

Yoda Lady achieved her ninth win in 19 races, bringing her total stakes earnings to \$42,470. "The more Yoda Lady competes at Angle Park, the more she improves her performance," Harris said.

"She has shown significant strength, able to take the lead or come from behind, as seen here, which is promising for the future."

Harris attributed the victory to the Bartholomew family as well, who bred and raced the current Group 3 champion.

2024 GAWLER BREEDERS HEATS ON SUNDAY JUNE 30

After the Group 3 Howard Ashton Final, the final race for the Breeders 2024 eligible greyhounds will be the Gawler Breeders Heats over 531m which will be run on Sunday, 30th June with the Final on Friday, 5th July.

Nominations for the Heats close on Wednesday, 26th June with GRSA at 9.00am.

LOW GRADE SERIES' AT ANGLE PARK

The next Low Grade Feature Series at Angle Park will be a Grade 5 Series over the 530m with \$4,050 Heats on Thursday, 4th July and the \$5,810 Final on Thursday, 11th July.

• Nominations for the Heats close Monday, 1st July at 9.00am.

There will also be a low grade series in late July at Angle Park for Mixed Masters over the 530m with \$4,420 Heats on Thursday, 18th July with the \$5,810 Final on Thursday, 25th July.

2024 MOUNT GAMBIER ANNIVERSARY CUP WORTH \$8,000 ON 21st JULY

One of the main feature meetings for the Mount Gambier GRC is programmed on Sunday, 21st July where the \$8,000 Exchange Printers Anniversary Cup Final for Open greyhounds will be run over the 512m. This meeting will also feature the \$3,000 John Reid Memorial Maiden Final over 512m and the \$4,500 Eric Lewis Memorial Feature Open over the 732m along with other events.

Heats for both the Anniversary Cup and John Reid Maiden will be run on Sunday, 14th July with both weeks likely to have some terrific racing.

Nominations for the Heats close on Tuesday, 9th July with GRSA at 9.00am.

2024 GAWLER CLASSIC HEATS ON WEDNESDAY JULY 24

The first part of the series for the Classic 2024 eligible

greyhounds will be the Gawler Classic Heats over 400m which will be run on Wednesday, 24th July with the \$3,300 Final on Wednesday, 31st July.

Nominations for the Heats close on Friday, 19th July with GRSA at 9.00am.

2024 NATIONAL CHAMPIONSHIPS IN SOUTH AUSTRALIA THIS YEAR

The GCA National Championships are just around the corner. The National Finals this year will be held locally at Angle Park and are to be conducted on Saturday, 24th August.

Both the National Sprint and National Distance Finals are at Group 1 level worth \$85,000 to the winner.

The State series' for SA will be held at Angle Park on Thursday, 1st August for the Sprint Heats over 530m with the State Final of the Sprint and one-off Final over 730m of the Distance on Thursday, 8th August.

In an effort to support this series ALL States will be conducting their Finals on the same night to be run within a two hour period.

• Nominations will close at the normal time with GRSA which will be at 9am on Monday, 29th July

A reminder to all trainers of the clause which requires a greyhound to have been domiciled in South Australia for a period of not less than 76 days out of the 150 days immediately prior to the nomination closing date to be eligible to represent SA.

For the Sprint series going back is on Wednesday, 15th May 2024.

For the Distance due to South Australia running as a one off final going back is on Wednesday, 22nd May 2024.

NATIONAL STRAIGHT TRACK CHAMPIONSHIP AT MURRAY BRIDGE

The National Straight Track Championship this year will be held locally at Murray Bridge on Saturday morning, 24th August with around \$28,000 to the winner – so all the National Finals will be held on the same day.

This year SA will have two SA dogs represent the State in the series with QLD, NSW, VIC and SA challenging for the title.

With the Straight Track series being in SA with the circle and the other States, our Heats will be held at Murray Bridge on Tuesday, 6th August with our Final on Tuesday, 13th August. Prizemoney for the SA Straight track Final will be \$10,000 to the winner aligned with the other three States.

It is important that trainers are aware that these series' for the circle and straight track are run around the same time so please be mindful of this when nominating and the qualifying criteria.

• Nominations close with GRSA at 9am on Friday, 2nd August (this will allow the opportunity if greyhounds get run out over the 530m in the Heats for the Sprint series a chance to nominate for the Straight)

TUESDAY NIGHT MEETINGS ON THE CALENDAR

Greyhound Racing South Australia (GRSA) announced the introduction of Tuesday night meetings at Angle Park, which started last month. The Tuesday night meetings are designed to meet demand, providing more racing opportunities for lower class greyhounds within SA.

The meetings are time graded, with 10 races of six dog fields. The meetings operate in tandem with Saturday morning race meetings which will target greyhounds of the same class with the racing distance at both race meetings restricted to 342m. The Tuesday meetings will provide a further outlet for greyhounds that are nominated for the Saturday mornings and are not provided with a starting opportunity. Greyhounds falling into this category will be granted preference rights if nominated for the subsequent Tuesday night meeting.

With Saturday morning and Tuesday night meetings being restricted to 342m nominations, opportunities for 530m time graded greyhounds will be programmed for other Angle Park dates. Trainers are encouraged to familiarise themselves with the details for the Tuesday night meetings, changes to the Saturday morning meetings and updated trialling times for Angle Park.

ANGLE PARK TO TRIAL ON WEDNESDAY NIGHTS

Please be advised that with Angle Park to race on Tuesday nights trials have shifted to Wednesday nights. The starting times remain the same at 6pm with the booking process and times the same as normal. Please be mindful that Bingo utilise most of the Chasers Restaurant on this night so please be aware of this while oncourse.

SATISFACTORY TRIALS BOOKED IN BY 12.30PM

GRSA advise those trainers wishing to book a Satisfactory trial at any of our trial sessions need to do so by 12.30pm the day of the night trial session or 12.30pm the day before the morning trial session. This will ensure GRSA can staff this appropriately.

WEIGHTED POINT SCORE TABLE

For grading purposes the Weighted Points Scale comes into effect along with the Order of Preference which is based around performances at tracks across Australia. Below is how this is calculated -

All greyhounds have a WPS calculated based upon the WPS table. There is no age criteria on the start dates when calculating the WPS. The WPS must be calculated on the greyhound's last 5 Race starts. If the greyhound has not

competed in 5 Races, the pro-rata WPS will be applied.

Pro-rata WPS

Greyhounds that have not yet competed in five [5] starts are allocated points on a pro-rata or an average over five [5] starts with a weighting of 80% applied to the "pro-rata" points.

To calculate the points of a greyhound that has not competed in five [5] starts:

1. divide the greyhound's total points by the amount of starts it has competed in

2. multiply the new average by the difference between 5 and the number of actual starts and apply the 80% discount weighting

3. add the result to the actual points earned from the greyhound's starts.

Examples for working out the points of greyhounds using this method:

One Start = 36 points 36 / 1 = 36; 36 x 4 = 144 x 0.8 = 115; 115 + 36 = 151 points

Two Starts = 46 points 46 / 2 = 23; 23 x 3 = 69 x 0.8 = 55; 55 + 46 = 101 points

Four Starts = 84 points 84 / 4 = 21; 21 x 1 = 21 x 0.8 = 16; 16 + 84 = 100 points



COMMENTS ON NOMINATIONS MARKED "ONLY"

A few years ago the Grading Review Panel agreed that some trainers were using the comments box to influence the grading of fields in particular Grade 5 Only for all their greyhounds.

The panel previously resolved that "Only" would be disregarded over all distances and the grading left to the Grader. [Masters Only or Juvenile Only will be accepted as this is for a specific type of race]

If trainers put "Only or no start or leave me out" then the grader will grade as normal and if a greyhound would be graded into a mixed event based on race wins then he will leave them out based on the trainers request. The more information provided to the Grader allows for him to accommodate those requests



GRSA was saddened to hear the news that bookmaker Greg McAtee had passed away recently. GRSA passes on our condolences to his family during this time.

SEEKING GRADING REVIEW PANEL POSITIONS – APPLICATIONS CLOSE FRIDAY 5TH JULY

With some of the Grading Review Panel members no longer on the panel, GRSA is now seeking applications from Industry persons who are interested in joining the Grading Review Panel. The Grading Review Panel looks at all things grading in South Australia and how rules and policies can provide a fair and balanced system. Members work in a group environment and are required to have a strategic and balanced view in regard to the best outcomes for everyone in the industry.

Listed below are the specific categories that are up for nominations.

- Mature Professional Trainer
- Semi- Professional Trainer
- Breeding Background
- Young Professional Trainer
- Pathway/Hobbyist
- Wagering Background
- Ownership Background
- Club Representative

Should you fall under one of these categories and would like to join the Panel please apply in writing to myself at shaun.mathieson@grsa.com.au advising the attributes you could bring to the Panel. Applications close on Friday, 5th July 2024 which will then be considered by the GRSA Board for appointment. The appointment will be for a 2 year term which could be extended if agreed upon, with the Panel meeting 2 to 3 times a year, however, there will be general correspondence during this time which will take place via email. The next meeting scheduled for the Grading Review Panel will be in July 2024.

RACING AND TRIALLING FREQUENCY REMINDER

GRSA adopted a new local rule in regard to frequency of racing and trialling which was implemented on Wednesday, 1st February, 2023.

Rule 69A Racing and trialling frequency

(1) In this rule:

Race has the same meaning given to this term in R9 of the GAR.

Trial means a satisfactory trial, or a qualifying trial as defined in R9 of the GAR.

[2] A greyhound will only be permitted to start in [a] No more than a combined total of 2 race and trial starts in any 7-day period; and,

(b) No more than a combined total of 7 race and trial starts in any 28-day period.

[3] This sub-rule commences on a date to be fixed by Stewards' Notice.

The intent of this rule is to monitor and regulate the frequency of races and official trials of greyhounds, to ensure adequate rest time is given between events. The rule is similar to one in effect in Western Australia. We have automated the Ozchase Racing system to be able to monitor this rule. The rule is self-explanatory.

A greyhound must not start more than 2 times (races or trials combined) in any 7-day period. Further, a greyhound must not start more than 7-times (races or trials combined) in any 28-day period.

Any attempt to nominate a greyhound outside these parameters will be flagged by the OzChase system. If a greyhound gains a start from reserve deeming it ineligible under this rule for its next engagement or it competes in another state prior to racing back in SA then the greyhound will come out.

**Racing Administration staff will scratch these greyhounds acting under this rule without notification (the responsibility rests with the trainer to ensure they do not contravene this rule).

**For clarity if a greyhound races on Sunday, Wednesday then Sunday it will be eligible. The first day counts as day 1 and therefore resets on the Saturday.

WINNING GRADE 6 RACES IN ORDER

GRSA reminds trainers to win their grade 6 events in order at a specific venue.

For the venues that allow two Grade 6 wins trainers need to win a Grade 6 over one distance and then a Grade 6 over the other distance. If a greyhound wins a Grade 6 and then a Grade 5 then they will lose their Grade 6 over the other distance at that venue.

RE-GRADING FOR ALL TRACKS AND DISTANCES

Re-grading will occur for all tracks and distances for Grade 3 or higher greyhounds.

A trainer can apply for a re-grade after two unsuccessful nominations over the corresponding distance. If having met this criteria the responsibility is on the trainer to apply for a re-grade prior to the close of nominations. Only one distance will be

considered for a re-grade per meeting.

CANCELLING TRIALS

If Trainers have booked trials for a session and decide not to come with all of their booked greyhounds, it would be appreciated if they could notify GRSA so amendments can be made.

If this is at short notice then there is not much that could be done, however, if trainers know their confirmed numbers during normal business hours then please advise GRSA.

MURRAY BRIDGE EMPTY OUT AREA

The Murray Bridge GRC request that if trainers wish to use the emptying out facilities at Murray Bridge they are required to pick up after their dogs, showing consideration for other users.

DAYLIGHT SAVING – MURRAY BRIDGE TRIALS

A reminder to ALL participants that daylight savings has ended, so please be sure to check kennel times and start times of events to ensure nothing is missed.

As it is non daylight savings Murray Bridge has reverted to a 4:00pm start.

VACCINATION RULE FOR RACING IN SA – REMINDER

Trainers are reminded that Rule 25 [Minimum Vaccination Requirements] took effect Monday, 1st May, 2023. Vaccination Certificates must be received by GRSA prior to close of nominations for affected greyhounds to be considered eligible for nominating. It is also imperative that once the greyhound has been vaccinated the paperwork is lodged by yourself as soon as possible. Trainers are also reminded that they must not have their greyhound vaccinated within 5 days of racing. Should this occur, the greyhound will be scratched from its engagement or if paperwork lodged after an engagement and discovered the greyhound raced inside the 5 days then the matter will be referred to the stewards.

SA BRED UPDATE

The pool of money is \$45,000 per month.

These winners all receive a \$225 base payment with \$75 to the Owner & \$150 to the Breeder.

The SA Bred Bonus scheme is continuing to go over budget with the number of SA Bred winners increasing. For the month of July there were 203 winners, August 197, September 196, October 226, November 209, December 218, January 218, February 194, March 179, April 197 and May 203. This means that we are currently 40 winners over budget for this financial year.

EFFECT OF PENALTY ON INDUSTRY PARTICIPANT

Recent Town Hall forums raised the question of the effect of penalties on training greyhounds. Greyhound racing is guided by the Greyhounds Australasia Rules [GAR] and the Local Rules for Greyhound Racing of Greyhound Racing SA Limited [LR]. This is a mouthful that we sometimes refer to as the "rules of racing". Various rules work together to give a picture of how controls and barriers to racing work.

Rule 178 of the GAR prescribes disqualification, suspension, warning off or being declared a defaulter. A suspension stops persons conducting any activity associated with greyhound racing. A disqualification is a more serious sanction that also prevents the person attending premises associated with greyhound racing. Being warned off or a defaulter has the same effect as being disqualified. In fact, being a defaulter (not paying a fine) is an offence in itself under the GAR.

Further, as a registered person, you cannot associate with a person who is disqualified or warned off, for the purposes of greyhound racing.

It is important to also note rule 93A of the LR. This relates to the restriction of keeping greyhounds on the premises of a registered person who is under a disqualification, suspension, warning off or being declared a defaulter. The rule is:

[1] In this rule, a "property to train greyhounds" means a property or premises at which a registered person keeps (unless retired as a pet), trains or races greyhounds and, for the avoidance of doubt, includes rearing farms, whelping and breaking-in facilities.

[2] Unless otherwise approved by the Controlling Body, no registered person may train, keep [unless retired as a pet] or race any greyhounds at any property or premises which are deemed by the Controlling Body as being or as having been the property to train greyhounds of a person who has had their registration ceased as a result of having been disqualified, warned off, suspended or declared to be a defaulter for a breach or potential breach of the Greyhounds Australasia Rules or Local Rules [of any Controlling Body].

What this means is: Registered Person A resides and keeps (non-retired) registered greyhounds at their kennels at Smallville. Registered Person B resides at the same kennels and keeps (nonretired) greyhounds there as well. Registered Person A becomes disqualified (for whatever reason and period). Registered Person B cannot keep their greyhounds at the Smallville kennels, nor can they have transferred into their custodianship any of Registered Person A's greyhounds. Exceptions to this need to be approved by GRSA.

Also, long term, being disqualified, warned off or declared a defaulter may affect future registration. Please refer to rule 175 of the LR for the full list of barriers to entry to the sport.

TREATMENT RECORDS

The GRSA Welfare Team would like to advise participants that, due to consistent non-compliance across the industry, treatment records not up to date at inspection will incur an on-the-spot penalty of \$50. Consecutive offenses will receive further penalties.

For clarification regarding what to include in your records, please see GAR 151 (1-6), as well as pages 18-19 of the GRSA Animal Welfare Policy.



YODA LADY TRAINER: LAUREN HARRIS

Greyhound of the Month for May was Yoda Lady for trainer Lauren Harris, who was undefeated in May winning all three of her starts, with the highlight being victory in the Group 3 Howard Ashton Final towards the end of the month.

The daughter of Blazin Wildfire and Galactic Athena was a recent addition to the Harris kennel after being sent up from the South East from owners Steve and Lee Bartholomew.

Yoda Lady started the month off in the Heats of the Howard Ashton and quickly stamped herself as one of the favourites for the series with a dominant Heat win, winning by 3 lengths in 30.60 over the 530m journey. She repeated the dose in the Semi-Final running even faster, a slick 30.59 in winning by 2 lengths.

She stepped out in the Final chasing her sixth win in a row and after having to chase hard during the middle stages, her class prevailed with an over the top victory.

She won by 1½ lengths in a solid 30.85 and showed plenty of determination to get to the line first in the prestigious event.

At the end of the month Yoda Lady's record stood at 19 starts for 9 wins and 8 placings and earnings around \$42,000.



The Run of the Month for May was the Richard Pearce trained Rico Nismo, for her win in a Special Event over the 595m at Angle Park on Thursday, 9th May.

The daughter of Hard Style Rico and Gemma Nismo began fairly from her inside draw and during the early and middle stages of the event it looked like she might run a nice placing behind leader Fantastic Spike, who was high balling in the lead. However, Rico Nismo clicked into another gear mid race to come with a wet sail and claim Fantastic Spike right on the line for a stirring win by a head in a blistering 34.20. The time was so fast that Rico Nismo had to have run amazing sectionals to get close to Fantastic Spike let alone win.

After the event and reviewing the times, Rico Nismo ran the fastest final split over the 595m than any greyhound has run since Angle Park was redeveloped a number of years ago. Over 595m the 12.39 run home for Rico Nismo can be compared to the likes of Stout Monelli, Like Wildfire and Ravers Army who have only got home in 12.70 in their very fast wins. When Stout Monelli ran the 595m track record of 33.68 he got home in 12.78.

To compare this 12.39 run home time over the 530m the best performers have been Victa Damian 29.86 track record (run home 12.38), Aston Rupee 29.95 (run home 12.40), Like Wildfire 30.35 (run home 12.41). So for Rico Nismo to run as fast in the final section over 595m as the best we have had over 530m suggest it was a brilliant performance to win.

There are numerous G1 stars bred on the Fernando/Cosmic Rumble cross highlighted by champions like Simon Told Helen, but includes too many other to name here. But, this mating will link Serena Fly High (dam of Tommy) and your bitch herself and they are bred along almost identical lines.This mating introduces a 3x3 duplication of Bit Chili along the direct damline on both sides of the pedigree. This cross is very conducive to the MALES in this mating being the standout racetrack performers.

Token Prince will also be duplicated along the direct damline on both sides of this pedigree.

But another very interesting aspect of this mating is that it brings in a cross, but well back in the pedigree, of littermates Hot Rumble and Velvet Fire who are incestuously in-bred. These two have been combined with great success in the past (generally through Collision the half brother to Spiritual Rumble). They are found in the great racetrack performers and proven broodbitches Go Jessies Girl and Go Mini Mouse. This is the direct damline of G1 stars Pantera Nera and Dam Slippery (Qld GOTY). AND, this mating brings in a very powerful cross of the famous half brothers Big Daddy Cool and Brett Lee. Putting Tangelo Fire to Tommy Shelby will bring in so many proven and wonderful crosses, I would implore you to undertake this mating at some stage of your bitch's career."

Kind reminder from GAP: Please submit a placement form if your greyhound has already passed the GAP first point assessment.

If you have not submitted the placement form within six months after the assessment, your greyhound will have to be re-assessed by GAP.

If your greyhound returned to racing or trialled after a successful assessment, it will have to be re-assessed after a 10-day downtime again. Thank you!

As previously advised, GAP have been increasing the number of assessments in the monthly schedule.

We continue to look to increase these further in order to offer a wider variety of times to meet participants varying requirements. The following graph depicts the number of assessments that have been occurring on a monthly basis.

Payment of placement fees

The \$60 placement fee is due at the time the placement form is submitted, payment can be made by either completing the card details on the form or by paying in cash. The placement form will only be processed, and the greyhound placed in GAP, once payment has been received



TRIALS

QUALIFYING AND SATISFACTORY TRIALS

Angle Park qualifying and satisfactory trials are held every Tuesday night between 6.50pm and 7.15pm. Qualifying will be for the following Monday meeting (drawn Thursday). Nominations close at 12.30pm on the Tuesday (for online nominations 11.59pm Monday).

Gawler qualifying and satisfactory trials are held every Thursday morning from 7am. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm Wednesday the day prior.

Murray Bridge qualifying and satisfactory trials are held fortnightly on a Wednesday night (between the end of the straight track trials and the beginning of the one turn track trials). Normal trials start at 4:00pm during nondaylight savings and 5:30pm during daylight savings. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm on Wednesday (for online nominations 11.50pm Tuesday).

ANGLE PARK

SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number or alternatively logon to trialbooker.com, create an account and book your own trials.

POLICY FOR TRIALLING AT ANGLE PARK, GAWLER AND MURRAY BRIDGE BEFORE THE RACE MEETING

Policy Background

This policy is to detail the procedure for trainers seeking greyhounds to trial before race meetings. This policy is effective from 2 May 2019.

Race Meeting Trial Policy

This policy is in place for the following race meetings:

Angle Park Monday, Gawler Wednesday and Sunday, Murray Bridge Tuesday, Friday, and Sunday.

Two fields from the boxes with a maximum of four (4) greyhounds. Trials may be conducted at any time during the race meeting from immediately after kenneling until after the last race, at Stewards' discretion.

The following lists the order in which greyhounds will be selected in the event if more than eight (8) greyhounds are nominated:

1. Reserves at the meeting that do not obtain a start

2. Trainers that have greyhounds engaged and are located more than 100km in distance from the track

3. Satisfactory trials

Procedure/criteria

- 1. For Angle Park Monday night, the trainer is to contact GRSA between 9am and 10am on Monday to nominate. Should the Monday be a public holiday bookings are to be made between 8am and 9am on the scratching number.
- For Murray Bridge Tuesday & Friday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Murray Bridge Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
- 3. For Gawler Wednesday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Gawler Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
- 4. Other than reserve greyhounds, trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
- 5. Stewards will allocate the box for the greyhound.
- 6. Trials will be 515m, 530m & 531m in distance as first preference. Other distances considered depending on nominations.
- 7. Greyhounds currently under suspension are ineligible to trial unless they are undertaking a satisfactory trial to be cleared.
- 8. Greyhound registration cards must be produced at kennelling time.
- Trainers with other greyhounds engaged can utilise the extra kennel space until such time they are ready to leave.
 Trainers with no other greyhounds engaged will be permitted to leave with Stewards permission.
- 10. At Murray Bridge, trials will only be available on the track that is prepared to race that day i.e. Friday meeting on the u-shaped track, trials will be on the u-shaped track only.

Please note: If there are 12 races at Angle Park, Gawler or Murray Bridge there will be NO trials.

RACING REPORT

The Angle Park Vet Clinic and/or swab kennels cannot be used to accommodate any additional greyhounds due to operational requirements of the Clinic and Stewards.

It is vital that trainers nominate to trial at these race meetings. If you are unable to nominate at these times, please contact GRSA as soon as possible as permission may be given at GRSA's discretion to accept bookings outside these times.

Exceptions to this policy

Thursday nights are kept available for interstate greyhounds to solo trial in a lead-up to SA Group races as well as local greyhound's trialling for Group racing interstate.

Upon request, local greyhounds will be allowed to solo trial in a lead-up to a feature race and they will take one of the eight (8) kennels available for trialling greyhounds ahead of the policy and sit separate to the four (4) dog trials. Races considered to be a feature are: Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals and any interstate Group race

Local greyhounds will be permitted to trial on a race night, where they are in preparation for a feature event, nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy. If a greyhound qualifies for a feature final and requires a trial in between, this will be conducted as a solo trial and will sit separately to the four (4) dog trials.

MOUNT GAMBIER SATISFACTORY TRIALS

Mt Gambier hold trials on Wednesday and Saturday mornings with Satisfactory trials ONLY being conducted on Wednesdays and need to be booked with Barry Shepheard from the Club on 0419 824 512 no later than 12pm the day before.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shepheard.





The meeting commenced at 10.12am.

1 APOLOGIES

Nicolle Rantanen Reynolds, Danielle Chegia, Gavin Harris and Ben Kavenagh noted apologies.

The RM confirmed the current ICG panel and recent changes. He advised that Jason Newman had resigned from his position, effective immediately. The RM proposed that for those new and re-elected Members to the panel (Gavin Harris, Kim Johnstone, Christine Costa, Petar Jovanovic, Danielle Chegia and Deb Isaacson), due to delay in their appointment/reappointment, that their terms be extended until June 30, 2026. Further to this, The RM proposed that those members with terms expiring on June 30, 2024 (Ryan Tugwell, Greg Moore and Keaton Bond) be extended until September 30, 2024 to allow sufficient time for the application process to be undertaken. All members were supportive of this approach.

2 NOTES FROM PREVIOUS MEETING

The Minutes from the ICG Meeting held on Tuesday January 23, 2024 were noted as a true and correct record.

3 ACTION LIST

The Group noted the action list as presented.

4 AGENDA ITEMS

4.1 CEO Induction & Overview

The CEO provided an introduction to himself as well background to operational undertakings since his commencement.

4.2 Stakeholder Engagement Sessions

The CEO highlighted the recent Future in Focus sessions, their purpose and outcomes. He noted that approximately 150 individuals attended over the four sessions, providing a good cross section of industry. He further noted the discussions held were open and professional and management would be looking to hold such sessions on a six-monthly basis going forward. The main feedback received from the session was around welfare, integrity, racing, breeding, lifecycle management, prizemoney, participant demographics, behaviour and communication.

4.3 Independent Inquiry into the Governance of the Greyhound Racing Industry In South Australia

The CEO advised the group of the appointment of Sal Perna to the position of Greyhound Industry Reform Inspector and provided an update on the status of the inquiry recommendations.

4.4 Strategic Plan Refresh

The CEO provided background to the planned process in relation to the Strategic Plan refresh. He requested the group determine a nominated person to participate in the process. Members suggested two people from the group would be beneficial due to diversification which was agreed. The Group nominated Petar Jovanovic and Christine Costa.

4.5 Breeding

The CEO noted current breeding levels compared to historically and highlighted a Board approved increase to breeding support to be introduced for 12 months. The CEO invited comments from the Group around the support and its best application. The RM noted feedback from the breeder's survey centered around suggested increases to sire payments to aid better selection. Increased veterinary costs were noted and suggested increases to pup payments would be beneficial. Members noted whelping costs and suggested payments for bitches once inseminated would be beneficial. Members noted rebates directed towards sires would be beneficial to ensure quality pups. The CEO committed to reworking the breeders support conditions and application with an expected announcement date shortly.

4.6 Members/Industry submission

Modification of Inside Rail Fence

The Group were supportive of extending the inside rail chain mesh fence. Further to this the Chief Steward would liaise with all lure drivers to ensure education of changes and committed to them providing sufficient time for the gate to close. Members suggested the fence should be positioned where lure is pulled away. The CEO committed to management undertaking recommendations,

DACO Requirements and Local Government Seminars

Management provided information regarding changes proposed to Government and noted none of which have been approved or committed to so no further comment was available. Management advised that GRSA was continuing to work very closely with DACO and providing a submission in response to proposed changes. Management reinforced that GRSA was unable to provide further information until after the consultation period and once the proposal had gone through parliament.

Vaccination Rule

The RM noted currently Victoria did not currently apply the national rule (moratorium in place) in regard to C5 vaccinations while SA did. However, the Chief Steward had advised that Victoria will be implementing the national rule in October 2024. The CEO noted the national rule did provide an option to vary the vaccination process so long as the greyhound is vaccinated to a C5 equivalent protection, and this is supported by veterinarian certification. Members noted this could be achieved via titer testing. Members suggested the vaccination rules did not follow current world best practice for vaccination. The current vaccination rule / protocols are dependent on the greyhound's birth date, which complicates the time of year which kennel cough vaccine is most effective, prior to winter. Under the current protocol the greyhounds are vaccinated at all different times of the year, leaving greyhounds vulnerable and catching kennel cough waiting for their vaccine date, which compromises the biosecurity of the property and the population of greyhounds in South Australia. The CEO noted prior to implementation of the rule, public consultation was undertaken, and implementation was based on veterinary advice. Members noted the optimal process for pup vaccinations was a three-shot process. The CEO and Chair committed to further raising at next GA CEO meeting.

DNA of All Greyhounds

The RM noted the Chief Steward had advised that GA will not be mandating DNA of all greyhounds and that when ear branding is ceased, each jurisdiction will look at their own alternate methods of identification such as nose print recognition as the second form of identification behind microchipping.

Grading of Injuries

The RM noted advice from the Chief Steward was that it was best to contact the stewards department with any queries. Members requested confirmation of what level of injury is reportable. The CEO noted the Members comments and committed to providing greater information regarding trainer obligations around GA Rule 122 at the next meeting.

Track Maintenance Timing and Communication.

Management provided an update and clarified the track maintenance schedule. They highlighted a national track diagnostic project being undertaken as well as training programs for track staff. They noted as part of this work, maintenance schedules are to be developed.
