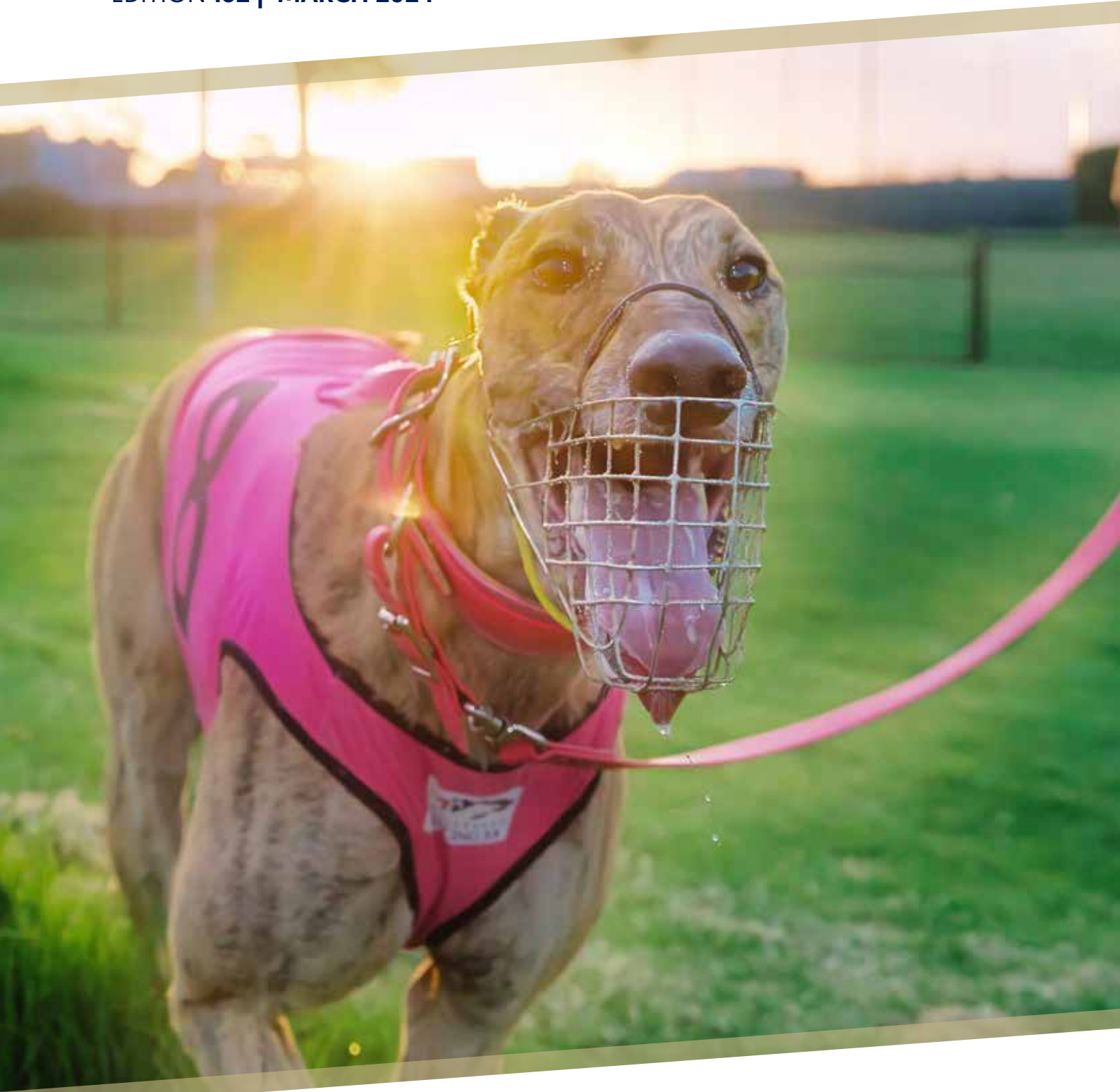

2024 SA LAUNCHING PAD

Peaky Boo for trainer Ben Rawlings has punched its ticket to the Launching Pad Heats at Sandown in Victoria after taking out the SA Launching Pad Final at Angle Park on Thursday 29th February.

After clocking 30.29 last week, Peaky Boo entered the Final as the red-hot favourite but didn't have things his own way from his box seven draw.

The speedy Peace Belle for Robyn Mackellar led early with a 5.24 first split with Lockaba Rocket, Senna Wick and Shipway also matching Peaky Boo early.

Peace Belle held the lead around the turn and into the back straight before Peaky Boo drew level before turing into the home straight, found the front and was able to win by a length in 30.82.

Peace Belle held on to second place with an excellent run while Lockaba Rocket for Wendy Sebastyan ran into third spot. It was career win number five for Peaky Boo and his fourth win in five starts in South Australia.

Speaking on the dais post-race, trainer Ben Rawlings said he was pleased his young chaser was able to take out the race under pressure.

"I didn't know how I thought he would go," Rawlings said.

"He did it well, he had to work around dogs and you sort of forget that it is only his ninth start and he is still learning and working out how to go around dogs."

"He is obviously high speed when he is on the lure by himself,



but he did well to get around the field and win the race."

With his fourth win in five starts, Peaky Boo is looming as a chaser on the rise in South Australia and Rawlings said he will go into Sandown confident after taking out a difficult race to qualify.

"You go into a race like this [SA Launching Pad Final], and you know its not going to be a walk over," he said.

"With him still learning, it is good that he can race in these races where he has to go in and outside of dogs and learn how to race.

"I am thrilled to have him, he's a handful. He is learning and he is still immature, but he is pretty good and some good people are involved so to have a good dog like this, it's really exciting."

2024 MURRAY BRIDGE CUP

Adhana Rico has continued his brilliant run of feature race success since crossing into South Australia taking out the 2024 Group 3 Daish Irrigation and Fodder Murray Bridge Cup on Sunday March 17.

Trained by Cameron Forshaw, Adhana Rico overcame a tricky box five draw and a red-hot field to produce an excellent performance in winning the race in 25.22.

The early speed battle loomed pivotal in the race and Adhana Rico was able to match it pace early with Chapel Road, who was the pre-race favourite.

After crossing over, Adhana Rico was able to open an advantage into the straight and while Chapel Road continued to push on, it was unable to close the gap to Adhana Rico who won by a length.

Chapel Road, for trainer Kiah Hurley was able to hold second while Wild Banker for Mount Gambier based trainer Tracie Price ran into third place.

The Group 3 Murray Bridge Cup success continued an excellent run for Adhana Rico since coming to SA in September last year.

The SA star finished fourth in the Adelaide Cup while also winning the Gawler Gold Cup and the time-honoured Kate'A Scandal Xmas Sprint.

Speaking during the post-race presentation, Forshaw said he knew the beginning was going to be crucial and he was proud of Adhana Rico's beginning.



"He just did what he had to do on the night," Forshaw said.

"It's all we could have asked for, he came out nicely and got on with it and he was away. He has been super since he has come over to us and we can't ask for much from him."

RACING AND TRIALLING FREQUENCY REMINDER

GRSA adopted a new local rule in regard to frequency of racing and trialling which was implemented on Wednesday, 1st February, 2023.

Rule 69A Racing and trialling frequency

[1] In this rule:

Race has the same meaning given to this term in R9 of the GAR.

Trial means a satisfactory trial, or a qualifying trial as defined in R9 of the GAR.

[2] A greyhound will only be permitted to start in [a] No more than a combined total of 2 race and trial starts in any 7-day period; and,

[b] No more than a combined total of 7 race and trial starts in any 28-day period.

[3] This sub-rule commences on a date to be fixed by Stewards' Notice.

The intent of this rule is to monitor and regulate the frequency of races and official trials of greyhounds, to ensure adequate rest time is given between events. The rule is similar to one in effect in Western Australia. We have automated the Ozchase Racing system to be able to monitor this rule. The rule is self-explanatory.

A greyhound must not start more than 2 times [races or trials combined] in any 7-day period. Further, a greyhound must not start more than 7-times [races or trials combined] in any 28-day period.

Any attempt to nominate a greyhound outside these parameters will be flagged by the OzChase system. If a greyhound gains a start from reserve deeming it ineligible under this rule for its next engagement or it competes in another state prior to racing back in SA then the greyhound will come out.

**Racing Administration staff will scratch these greyhounds acting under this rule without notification [the responsibility rests with the trainer to ensure they do not contravene this rule].

**For clarity if a greyhound races on Sunday, Wednesday then Sunday it will be eligible. The first day counts as day 1 and therefore resets on the Saturday.

VACCINATION RULE FOR RACING IN SA

Trainers are reminded that Rule 25 [Minimum Vaccination Requirements] took effect Monday, 1st May, 2023. Vaccination Certificates must be received by GRSA prior to close of nominations for affected greyhounds to be considered eligible for nominating. Trainers are also reminded that they must not have their greyhound vaccinated within 5 days of racing. Should this occur, the greyhound will be scratched from its engagement.

GAWLER MATTING AT 400M BOXES

The GRSA Maintenance team will be replacing the mat at the 400m starting boxes on Tuesday, 2nd April. There should be no interruption to racing or trialling.

ANGLE PARK TRACK GRADE ON SATURDAY 6TH APRIL – NO TRIALS THAT WEEKEND AT VENUE

GRSA has confirmed that the Angle Park track will be graded on Saturday, 6th April due to the availability of the contractor and staff. It requires two days so there will be NO trials on Saturday, 6th April or Sunday, 7th April.

GROUP 3 MOUNT GAMBIER CUP HEATS ON SUNDAY 7TH APRIL WITH BIG BONUSES ATTACHED TO FINAL

The \$3,000 Cadillac Racing Group 3 Mount Gambier Cup Heats will be run on Sunday, 7th April with the \$36,000 [Group 3] Final on Sunday, 14th April.

Also on the Cup final program will be -

\$4,000 Exchange Printers Mt Gambier Cup Consolation – 512m [Trainers must renominate]

\$2,200 The Produce Store Maiden Feature – 512m

• Nominations for Heats close with GRSA at 9am on Tuesday, 2nd April.

With Adhana Rico for trainer Cameron Forshaw taking out the Group 3 Murray Bridge Cup if this greyhound can also win the Mount Gambier Cup Final connections will get a \$5,000 bonus and if Cameron can win the Mount Gambier Cup with any of his greyhounds, he will get a \$5,000 trainer bonus.

LOCAL MATCH RACE SERIES “THE SA EASTAR” ON MARCH 28

The SA Local Match Race series coined “The SA Eastar” will be held on Thursday night, 28th March (Easter) at Angle Park.

Eligibility for South Australian local greyhounds will be based around the Nationals conditions. They will need to be trained in SA 76 days out of the last 150 prior to the close of nominations.

Selection for this series will only be based around winning times at Angle Park. For greyhounds that have run over the 530m at Angle Park on any meeting since 1st November, 2023 their fastest winning time will be recognised and put them on the list for selection.

The head to head matches will be decided based on the final listing and nominations. Match 1 will be 1 v 4, Match 2 will be 2 v 3, Match 3 will be 5 v 8 and Match 4 will be 6 v 7. There will be no manual selection from the Grader. The top 4 seeded greyhounds will be rewarded with more prizemoney.

Winners of match races – Match 1 – 1 v 4 \$4,500, Match 2 – 2 v 3 \$4,000, Match 3 – 5 v 8 \$3,500, Match 4 – 6 v 7 \$3,000 There will be \$500 Runner’s Up. Overall SA Eastar winner (based on overall times) - \$6,000, second \$2,500, third \$1,500.

ANGLE PARK SATURDAY 30TH MARCH – SCRATCHING TIME ON THURSDAY PRIOR

In a few weeks time it will be Easter and we will race on the Saturday morning with the normal Angle Park meeting. As the Friday before is Good Friday and a public holiday the scratching’s for this meeting will be done at 3pm on Thursday, 28th March to accommodate staff and participants.

REGUPOL FLOORING FOR MOUNT GAMBIER KENNEL HOUSE IN APRIL

GRSA and the Mount Gambier Greyhound Racing Club have organised for contractors and their maintenance teams to install Regupol flooring in the Mount Gambier Kennel House from Monday, 15th April. Works will take a week and will have an effect on racing and trialling during this period.

A schedule of work and dates are below.

1. Work would begin on Sunday evening, 14th April with Maintenance clearing the kennels from the area after racing has concluded. [This is the Group 3 Mt Gambier Cup meeting]
2. Contractors would begin their work on Monday, 15th April with a view to have this completed by Friday, 19th April (Including the morning of Saturday, 20th April in case of slippage).
3. Maintenance staff would reinstall the kennels on Saturday, 20th April ready for racing on Sunday, 21st April.
4. Trials for the week will be cancelled including Saturday, 15th April due to staff availability.
5. The Race meeting on Thursday, 18th April will be cancelled.

Both Club and Authority have looked as these dates as the best option and least disruption to participants that starts after the Group 3 Cup series and is completed in a week with only one race meeting cancelled.

EASTER FEATURES AT GAWLER ON EASTER SUNDAY

Easter racing comes to Gawler in a few weeks with both the Gawler Future Stars Final and Gawler Easter Sprint programmed on Sunday, 31st March.

The Gawler Future Stars Heats will be conducted for SA Bred greyhounds whelped in 2022 on Sunday, 24th March over the 531m with a \$3,500 Final on Easter Sunday, 31st March. Also on Easter Sunday will be the Gawler Easter Sprint for mixed greyhounds over the 531m worth \$5,000. [Trainers must nominate for this feature with all grades considered]. It's going to be a terrific night of racing on the Sunday night over the Easter break.

GOTBA COURSING TO START IN APRIL

GOTBA at Virginia will hold their first Coursing meeting for 2024 on Sunday, 21st April.

• **Nominations close with GRSA at 9am on Wednesday, 17th April. Further dates will be released shortly.**

BREEDERS 2024 PRELUDE (2) SERIES IN APRIL

The second Prelude of Breeders 2024 Prelude (2) will be run with \$3,700 Heats on Thursday, 4th April over the 530m at Angle Park.

The \$4,500 Final will be run on Thursday, 11th April. For SA Bred greyhounds paid up for Breeders 2024. These races are no longer trophy presentation events to be consistent with the other preludes conducted.

• **Nominations close with GRSA for the Heats at 9am on Monday, 1st April.**

OPEN MAIDEN LOW GRADE FEATURE IN APRIL

The low grade series in April at Angle Park is an Open Maiden series over 530m with \$2,785 Heats on Thursday, 11th April with the \$5,810 Final on Thursday, 18th April.

SA ANNIVERSARY CUP IN APRIL WORTH \$50,000

The \$5,810 Heats of the SA Anniversary Cup will be run over 530m on Thursday, 18th April. The \$50,000 Final will be run on Thursday, 25th April.

• **Nominations close with GRSA for the Heats at 9am on Monday, 15th April.**

SA DISTANCE CHAMPIONSHIP IN APRIL

The \$7,140 Heats of the SA Distance Championship will be run over 730m on Thursday, 18th April. The \$15,250 Final will be run on Thursday, 25th April.

STAYING EVENTS MOVED TO 5 RUNNERS AS A MINIMUM FROM JANUARY 2024

For a number of years GRSA has supported our staying ranks by running these events with a minimum of 4 runners. GRSA has tried to encourage this pool to grow at the expense of other events on a program, even with such small numbers. However, from January 2024 any staying event programmed will need to be a minimum of 5 runners to be considered in the program. This will affect the Angle Park 730m, Murray Bridge 680m and Mt Gambier 732m.

GRSA will continue to review processes in relation to the field size and scheduling.

BREEDING SUPPORT CLAIM RESTRICTION REMOVED

In July of 2022 after consultation with the ICG, GRSA introduced a restriction on the number of Breeders [Support Claims that could be applied for in a 12 month period to assist with sustainable breeding. At the most recent ICG meeting, and after reviewing current and forecast breeding numbers it was agreed to remove this restriction effective immediately in support of our current breeders. There is no retrospectivity regarding claims that were not processed due to the policy at the time. Please contact Racing Manager, Shaun Mathieson for further information if required.

SA BRED UPDATE

The pool of money is \$45,000 per month.

These winners all receive a \$225 base payment with \$75 to the Owner & \$150 to the Breeder.

The SA Bred Bonus scheme is continuing to go over budget with the number of SA Bred winners increasing. For the month of July there were 203 winners, August 197, September 196, October 226, November 209, December 218, January 218 and February 194. This means that we are currently 61 winners over budget for this financial year.

Greyhound of the Month for February was Peaky Boo for trainer Ben Rawlings, who had four starts for the month with three wins and a third, his highlight being the SA Final of the Launching Pad series and booking his spot across the border at Sandown in the rich Group 2 series.

The son of Tommy Shelby and West On Poppy started the month off in blistering fashion, winning his Heat of the time honoured SA St Leger in a flying 30.41, and then ran a handy third in the Final without having much luck as a short priced favourite. He then stepped out in the Heats of the SA Launching Pad creating a huge impression in winning by almost 10 lengths in a brilliant 30.29 for the 530m journey. As a very short priced favourite in the Final he was made to work hard for the win but found the line in first place, winning by a length in 30.82 and booking his spot in Victoria.

At the end of the month Peaky Boo's record stood at 9 starts for 5 wins and 1 placings and earnings around \$15,000.



The Run of the Month for February was the Nicole Price trained flyer Boots, who has gone to another level as a short course sprinter highlighted by his track record performance at Gawler on 28th February.

The son of Aston Dee Bee and Mrs. Sharp was able to lead throughout and win by 4 lengths, however, his time was amazing running a blistering 22.23 which bettered the previous best of 22.27 jointly held by Avid Tyson [2014] and Toby West [2022].

^ **Prizemoney** includes payments to winners, places and unplaced of all South Australian races. Following feedback from participants in December 2020, additional money for feature races is averaged over the year.

Distribution between Trainers and Owners

GRSA would like to remind all participants who receive a WAP that the payment is the equivalent of prizemoney. If you are currently responsible for distributing prizemoney to another party (e.g. owners) then the same approach applies to WAP payments.

From GRSA's perspective, the position in relation to third parties is reflective of OzChase records and is as follows:

- If GRSA have been notified of an ownership split [which is recorded in OzChase] then you **DO NOT** need to make a payment to owners for the WAP because GRSA will do this automatically, however;
- If you ordinarily forward on payments to owners of your own accord, then you **DO** need to do the same for the WAP. Each remittance will include the name of the dog for which the WAP is being made.

Example to help participants understand the WAP they receive

It is not uncommon for GRSA to receive requests for more information in relation to how the WAP is calculated for their particular dog(s). The example below is provided to assist in the general understanding of the calculation.

Assumptions:

In this example, assume the owner/trainer received **\$1,000** in prizemoney for any/all races for the month.

In this the total prizemoney (paid to all participant) is **\$700,000**.

In this example, the total WAP is **\$50,000**.

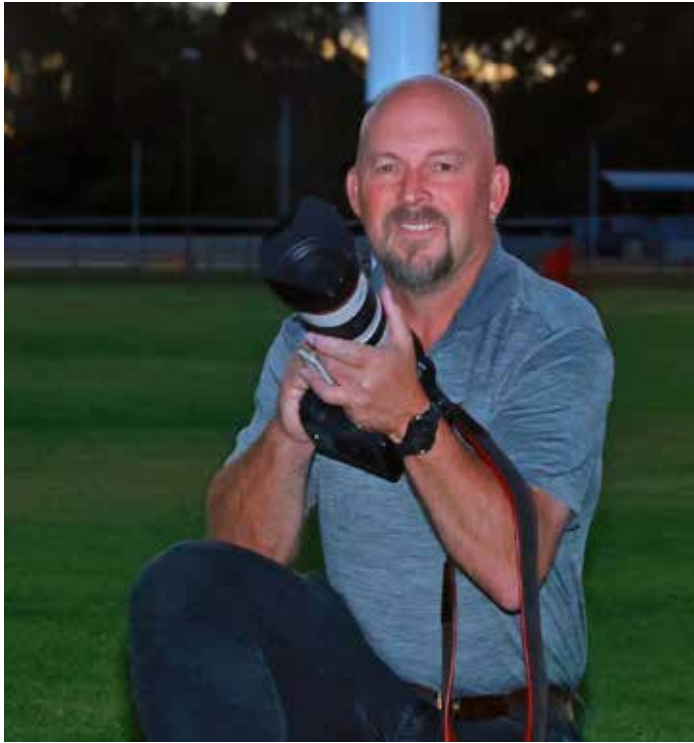
In this example, the owner/trainer would receive a WAP of **\$71.43**, calculated as:

$$\$1,000 \div \$700,000 \times \$50,000 = \$71.43$$

Participants should note that:

- WAP is **not payable** for any prizemoney received in relation to feature races [where total stakes are above \$5,000];
- Trainers' fees and other bonus payments are not included in the calculation of the share of the WAP; and
- It is a requirement that a greyhound has to have raced and received prizemoney during a month to be eligible to receive the WAP payment for that month.

Please also make sure the application form is fully completed and includes the on-track vet (OTV) signatures for race night or stewards signature for trials plus the vet's signature who provided the care at the vet clinic.

You also need to sign the application.

- Note that making an application does not guarantee acceptance. The TIRS covers defined bone, tendon or ligament injuries that result in surgery. Please see the TIRS policy on the GRSA website for detailed information.

Greyhounds should not be raced or trialled within the 10 days prior to assessment.

Please remember to book in your greyhound's vet work AFTER you submit the GAP placement form.

Payment of placement fees

The \$60 placement fee is due at the time the placement form is submitted, payment can be made by either completing the card details on the form or by paying in cash. The placement form will only be processed, and the greyhound placed in GAP, once payment has been received.

Kind reminder from GAP:

Please submit a placement form if your greyhound has already passed the GAP first point assessment.

If you have not submitted the placement form within six months after the assessment, your greyhound will have to be re-assessed by GAP.

If your greyhound returned to racing or trialled after a successful assessment, it will have to be re-assessed after a 10-day downtime again. Thank you!

As previously advised, GAP have been increasing the number of assessments in the monthly schedule.

We continue to look to increase these further in order to offer a wider variety of times to meet participants varying requirements.

The following graph depicts the number of assessments that have been occurring on a monthly basis.

TRIALS

QUALIFYING AND SATISFACTORY TRIALS

Angle Park qualifying and satisfactory trials are held every Tuesday night between 6.50pm and 7.15pm. Qualifying will be for the following Monday meeting (drawn Thursday). Nominations close at 12.30pm on the Tuesday (for online nominations 11.59pm Monday).

Gawler qualifying and satisfactory trials are held every Thursday morning from 7am. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm Wednesday the day prior.

Murray Bridge qualifying and satisfactory trials are held fortnightly on a Wednesday night (between the end of the straight track trials and the beginning of the one turn track trials). Normal trials start at 4:00pm during non-daylight savings and 5:30pm during daylight savings. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm on Wednesday (for online nominations 11.50pm Tuesday).

ANGLE PARK

SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number or alternatively logon to trialbooker.com, create an account and book your own trials.

POLICY FOR TRIALLING AT ANGLE PARK, GAWLER AND MURRAY BRIDGE BEFORE THE RACE MEETING

Policy Background

This policy is to detail the procedure for trainers seeking greyhounds to trial before race meetings. This policy is effective from 2 May 2019.

Race Meeting Trial Policy

This policy is in place for the following race meetings:

Angle Park Monday, Gawler Wednesday and Sunday, Murray Bridge Tuesday, Friday, and Sunday.

Two fields from the boxes with a maximum of four (4) greyhounds. Trials may be conducted at any time during the race meeting from immediately after kennelling until after the last race, at Stewards' discretion.

The following lists the order in which greyhounds will be selected in the event if more than eight (8) greyhounds are nominated:

1. Reserves at the meeting that do not obtain a start
2. Trainers that have greyhounds engaged and are located more than 100km in distance from the track
3. Satisfactory trials

Procedure/criteria

1. For Angle Park Monday night, the trainer is to contact GRSA between 9am and 10am on Monday to nominate. Should the Monday be a public holiday bookings are to be made between 8am and 9am on the scratching number.
2. For Murray Bridge Tuesday & Friday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Murray Bridge Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
3. For Gawler Wednesday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Gawler Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
4. Other than reserve greyhounds, trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
5. Stewards will allocate the box for the greyhound.
6. Trials will be 515m, 530m & 531m in distance as first preference. Other distances considered depending on nominations.
7. Greyhounds currently under suspension are ineligible to trial unless they are undertaking a satisfactory trial to be cleared.
8. Greyhound registration cards must be produced at kennelling time.
9. Trainers with other greyhounds engaged can utilise the extra kennel space until such time they are ready to leave. Trainers with no other greyhounds engaged will be permitted to leave with Stewards permission.
10. At Murray Bridge, trials will only be available on the track that is prepared to race that day i.e. Friday meeting on the u-shaped track, trials will be on the u-shaped track only.

Please note: If there are 12 races at Angle Park, Gawler or Murray Bridge there will be NO trials.

RACING REPORT

The Angle Park Vet Clinic and/or swab kennels cannot be used to accommodate any additional greyhounds due to operational requirements of the Clinic and Stewards.

It is vital that trainers nominate to trial at these race meetings. If you are unable to nominate at these times, please contact GRSA as soon as possible as permission may be given at GRSA's discretion to accept bookings outside these times.

Exceptions to this policy

Thursday nights are kept available for interstate greyhounds to solo trial in a lead-up to SA Group races as well as local greyhound's trialling for Group racing interstate.

Upon request, local greyhounds will be allowed to solo trial in a lead-up to a feature race and they will take one of the eight (8) kennels available for trialling greyhounds ahead of the policy and sit separate to the four (4) dog trials. Races considered to be a feature are: Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals and any interstate Group race

Local greyhounds will be permitted to trial on a race night, where they are in preparation for a feature event, nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy. If a greyhound qualifies for a feature final and requires a trial in between, this will be conducted as a solo trial and will sit separately to the four (4) dog trials.

MOUNT GAMBIER SATISFACTORY TRIALS

Mt Gambier hold trials on Wednesday and Saturday mornings with Satisfactory trials ONLY being conducted on Wednesdays and need to be booked with Barry Shephard from the Club on 0419 824 512 no later than 12pm the day before.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shephard.

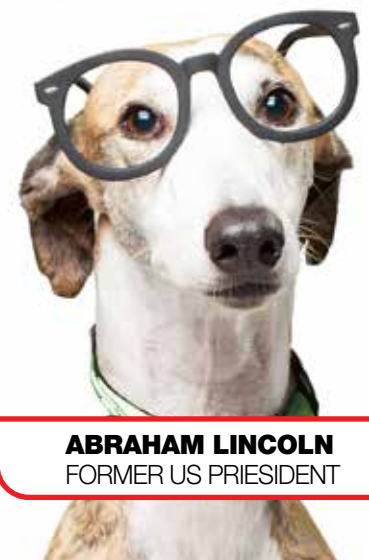

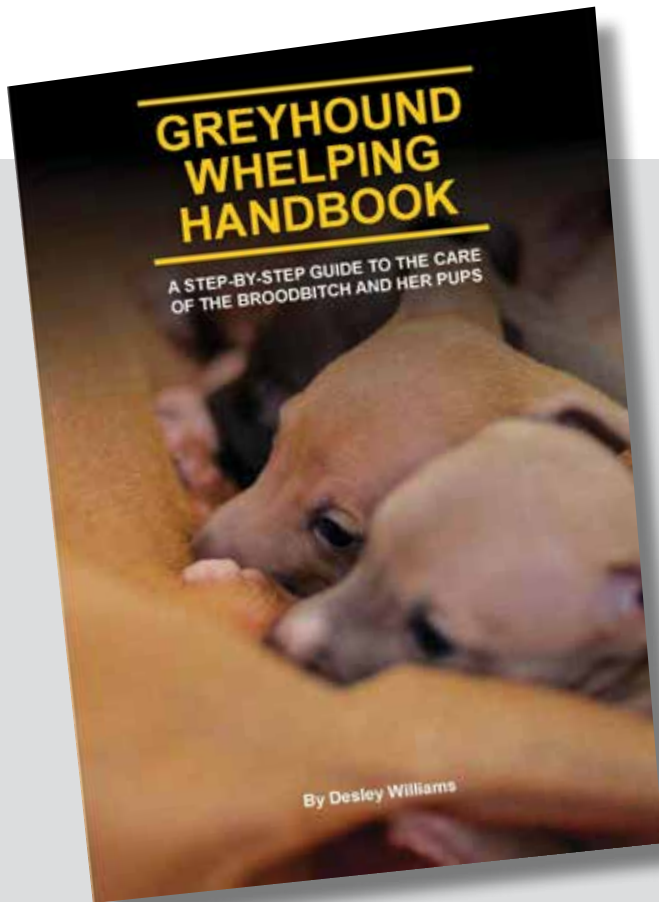

GREYHOUND RACING SOUTH AUSTRALIA GRADING REVIEW PANEL MEETING

Held at the offices of GRSA at
55 Cardigan St, Angle Park on
Friday 23rd February, 2024

Meeting commenced at 10.00am. Shaun Mathieson, Racing Manager, thanked those attending the meeting today.

1. Minutes From Previous Meeting

The panel approved the minutes from the previous GRP meeting held on 02/06/23.

2. Business Arising

The Racing Manager provided an update to the panel on those items introduced from the last meeting. The panel discussed a number of those items in detail.

Grade 6 – As a standing item the Grade 6 conditions continue to remain on the agenda for any new discussion. No further proposed changes were made by the group.

ANGLE PARK – Thursday night extra race –

It was discussed that winners of heats take a penalty but not the final when heats at other venues are drawn for a City A final where programmed. The RM advised currently these series are Non Penalty to encourage nominations however will consider how these races are programmed in the future.

342m Events at Angle Park -

The RM advised as a Board directive to have 12 races at Angle Park on a Thursday night that we have recently conducted a few 342m events. Trainers cannot nominate for these events until they are called for and only when it is clear we cannot get sufficient for a 12 race program with 530m+ greyhounds.

It was reconfirmed where possible the process below will be implemented, however, this may change due to nomination numbers, public holiday etc -

When nominations closed at 9am for City A meetings and there were insufficient nominations for 12 races they should be extended until 12.30pm. If at 12.30pm there are still not enough for 12 races the grader is to grade the 500m+ events he has and nominations for the 342m races (however many required) called for and close around 2.30pm. This will only be for the best greyhounds nominated and the grader is to take into account the grades of greyhounds that have raced at APM on Monday nights over 342m. All greyhounds on City A Thursday will be Maiden, Grade 6 and Grade 5 to start with and however many races are to be run they will be conducted at the end of the program.

It would be our intention for preference to our best short course sprinters. GRSA took into account the Prov 1 prizemoney for short course and the CITY A sprint distance stake money.

The panel were comfortable with the prizemoney allocating being more that Category 2, however, not over sufficient that it will transition the 530m greyhounds to 342m purely for prizemoney. Total prizemoney –

Maiden – \$1,945

Grade 6 – \$2,025

Grade 5 – \$2,225

Mixed 3/4/5 – \$2,430

Open – \$3,195

MIDDLE DISTANCE NOMINATIONS AND FIELDS –

The panel were comfortable with the recent change GRSA made for staying events to increase to 5 runners.

Subsequent to this meeting the RM did conduct a 4 runner 595m event as a lead up to the Easter heats over 595m which was in a weeks time, a unique circumstance, to provide those greyhounds the opportunity one week out from a feature series, bearing in mind this was not at the account of a full field at the meeting.

TIME BANDS FOR TRACKS AND DISTANCES –

The RM advised there has been no changes to Time Brands, however, there are some time changes that possibly need to be reviewed. He provided the group with a link to the Time Bands report for them to provide feedback in the coming weeks. He did advise there has also been no change to the 4 in 6 starts, however, will keep the 3 of your last 4 or 4 or your last 4 possible change as something to consider further.

The panel did suggest changing the 1-4 win grouping to 1-6 for 530m+ events and also consider moving these to Thursday night instead of Saturday morning. The suggestion was the 5 and 6 win greyhounds are now finding it hard to get a suitable event and also that the heats would be better served on a Thursday and free up Saturday for 342m events. The RM will look to implement this in programming and alter groupings where appropriate.

Actions:

The RM to move 1-4 heats from Saturday to Thursday where appropriate and change from 1-4 wins to 1-6 wins or other groupings where appropriate.

The RM advised the panel that there would be a video posted on the Registered Participants Facebook page showing the box draw process with an example meeting that all the OzChase states use. The panel were supportive of more of this occurring. The RM did advise the group that if any trainer/owner wanted to view the box draw of a particular event that affected them then Management can have a time available to do this box draw so long as they are given sufficient time to manage. This has been available for many years, however, hardly any participants take this option up. The panel were supportive of this.

SA Country Cup & Gawler Feature Race Concept –

The RM advised these races are still to be considered for implementation or alteration.

In reminding the panel that the GRSA Board increased the Anniversary Cup at Angle Park, run in April to \$50,000 for future years, he did suggest the way Easter fell next year that a creative option could be implemented. Next year the Anniversary Cup will fall on Easter with Anzac Day close, so the Match Race series will have to be a week before the Anniversary Cup. The RM advised it might be good to support the local trainers by having a similar condition for next year that we have for the Adelaide Cup where the winner of the Easter Match race gets direct entry into the \$50k Anniversary Cup. The group were supportive of this innovation based on how the dates fall next year. The RM to investigate and recommend this change to next year.

Nomination Numbers Online – The RM advised changing the preferences online to make the numbers correct will take a lot of work. He advised the numbers add up each preference, if it looks like 200 nominations its actually about 150, as 50 have second preferences. The panel were keen to get this accurate and if possible, flesh this out further to break it down into grades and distances. The RM to investigate further.

ADDITIONAL TUESDAY NIGHT MEETING AT ANGLE PARK

The RM advised the group that this item is back on the agenda with a potential Tuesday night to start in the coming months. He provided details from our last meeting about how this meeting might be graded. He advised his hesitation with the greyhound numbers and possible issues arising from an extra meeting for the weekly schedule.

The RM proposed grading both the fortnightly Saturday and Tuesday at the same time so effectively grading two meetings at once and whoever didn't get a run on Saturday would have to go to Tuesday. This would ensure a greyhound gets at least one start rather than having a greyhound get two and some none. The panel were not convinced fully doing two meetings three days apart was the right option.

The panel were supportive of different dogs from Saturday having the opportunity first for Tuesday. Possible preference for reserves from Saturday, maybe Best to Worst grading, maybe a different grouping of dogs. The RM advised all these things still

need to be confirmed, however, one of the intents of the extra meeting will be to try and assist some of the greyhounds who could be racing at this meeting rather than being in a kennel waiting to be rehomed.

GRADING REVIEW PANEL MEMBERS

The RM advised since the last GRP meeting in June 2023 there have been some changes and some members have expired. He advised the current panel bearing in mind each person is for a two year term.

Tony Rassmussen, Sharyn Gray and Mike Wittholz have all come off for various reasons. Petar Jovanovic has come off to remain on the Industry Consultative Group due to the new ICG selection process where participants can only represent on one panel. GRSA management appreciates the contribution these previous members have made.

Remaining members have confirmed their intent to remain on the group. The RM advised that he will now wait for the ICG panel to be confirmed and then will call for new members for the GRP.

Subsequent to the meeting Daniel Grgurovic advised that he no longer wished to be on the GRP. Management appreciates the contribution Daniel has made over the years.

RESERVES IN ORDER FOR TIME GRADING

The panel reconfirmed that reserves for Time Graded events selected to gain a start should be based on rating. The RM will follow up NSW who can select the reserve for specific events without it being a final and see how this could be implemented for SA through OzChase.

PREFERENTIAL BOX DRAWS

The RM advised as part of the independent review Preferential Box Draws are something that is to be considered for SA racing. Previously management has advised that it would be best managed using data from Isolynx, however, this technology isn't progressing sufficiently for any state in Australia, so it is being managed manually. The RM attached information from WA about implementation and also how each state in Australia is managing PBD'S.

The group were not convinced PBD were required, however, did suggest that if they were trialled in SA, it would be best over 530m at Angle Park due to the longer run to the first turn. They did not think bend starts would give a good indication if PBD worked. The RM suggested small pool of greyhounds like the 305m at Mt Gambier. The RM suggested could the new Tuesday night which is exclusively 342m events be trialled or maybe even the Straight track. The panel did not believe Maidens would provide a good indicator if PBD would work due to their limited racing. The panel were comfortable a trial may occur and would wait and see what outcomes come from this.

3. Agenda Items

No other agenda items submitted.

4. Submissions - Edited

Ben Rawlings –

6 dog fields over short course [342m and 400m]. The RM advised with the 8 dog quad and time grading there will be some short course races that are 8 dog fields purely because they have the most nominations. Where possible the longer journey will be 8 dogs as they are generally better wagering and higher profile dogs, however, when grading we want to give as many greyhounds a run at the meeting based on the current criteria.

Tuesday Nights – As advised earlier in meeting.

No advertised races in calendar with multiple trainers – As discussed later with guarding.

Performance trials – The RM advised until resourcing and a change in policy is introduced there will be no requirement as yet.

Daniel Grgurovic -

275metres [starting at the 730m boxes and racing to the finish line] for maidens, juveniles and veterans only on Tuesday night and flattened prizemoney. This could prolong the careers of the slower maidens/juveniles or masters greyhounds. The RM advised there is no intent for a shorter distance at Angle Park, however, appreciates this submission in an effort to give more options for trainers with their greyhounds.

Inconsistencies in grading – The RM advises that the grading for a meeting is published on the GRSA website based on the grading guidelines and policy. Any

queries can be answered by the Grader in relation to a specific reason why something happened. Daniel advised his appreciation of the Box Draw video being published on the Facebook page to assist with transparency to participants and would like to see more ways this can be done.

The value of guarding and if it's worthwhile and fair in the current climate – A strong discussion was held amongst the group about the positives and negatives of guarding especially if a race is not advertised and a trainer is quite restrictive about the way they nominate. The Grader advised that he gets the most negative queries about guarding when greyhound trainers are in the same race rather than separating. He advised he will go off of trainer's comments even if they are quite restrictive and whether a race is selected will be based on how many races for the meeting and the types of events which is normal practice.

After much discussion the RM advised his intent to program much more feature races in the All Tracks calendar to provide all trainers the chance to nominate for a specific event. He is mindful that guarding affects all types of events whether it be City class or Country class and depending on the greyhounds in your kennel may determine what side of the debate you sit. He also feels that if in the grading process there was any integrity issues with events this would be referred to the stewards.

Subsequent to the meeting for clarity the RM advises that in SA we guard [separate trainers] in all racing except Time Grading [time grading is done based on time rating so we don't guard as that compromises the field as its done on a dogs rating at the time]. Guarding means when there are two grade 5 events over 342m, and a trainer has two grade 5 dogs they will be separated. They will be separated on race wins. However, for example, if a trainer puts Masters only, or SA bred only or Juvenile only and there's only one race but there could be another race they could go in we will put both dogs in the race they asked for. i.e. both in a Masters event even though there is another grade 5 on the program if eligible.

For heats and semi finals we will guard not only trainers but owners as well. SA has guarded for over 20 years and used to guard owners and trainers but about 6-8 years ago it was just trainers as basic grading.

Tony Nobes -

Vison of nomination numbers to cease – Some concerns raised by Tony regarding when the nomination numbers are visible trainers may manipulate to get an event on the program and then scratch. The panel are mindful of this, however, would prefer there be more information available that is a true reflection on what's nominated. They believed that if there was manipulation then the stewards should deal with these participants strongly.
