FROM THE CEO'S DESK

Sky Race Meeting Schedule

Further into this week's edition there is an update regarding the future composition of the weekly schedule of racing and trialling. Without wanting to duplicate any aspect of that article I would, however, point to a related matter – that being the number of recent extensions of race meeting nominations – and paint a broader picture of what we see happening in this space. The industry had generally been aware that a

period of breeding decline would ultimately be followed by some restriction on numbers of greyhounds available for race meetings, and whilst we are now observing some really positive signs of rebound and responsible growth there will still be some lag in nominations until this situation corrects.

There are a number of 'levers' that can be applied to cope with and manage this challenge in the months ahead, however the primary ones relate to programming [GRSA] and nomination behaviour [participants]. In support of maintaining its current Sky timeslots and ensuring balanced opportunities in our key regions, GRSA will continue to look at programming opportunities which support that goal. Examples of that approach include restricting the number of races per meeting to 10, when more are possible, if additional races have flow-on impact for other meetings and acting on the [potential] need for short-course racing on a Monday night, as has been a topic of recent discussion. The fact that Monday night racing will potentially shift away from Angle Park when Murray Bridge commences may soften people's views on that strategy, noting that a changed approach may be forced upon us regardless. Separately, we will continue to work with industry to try to ensure that the nomination process accounts for practical participant-related considerations – for example, the timing of close of nominations relative to the day of the meeting – to ensure that this part of the process is as efficient as it can be to minimise the need for nomination extensions.

On current signs we anticipate that this issue is only a temporary priority and that, more broadly, the new racing opportunities at Murray Bridge are helping to underpin an emerging sense of confidence and optimism within the industry which will help restore the previous balance in the schedule.

Industry Information and Engagement Sessions

Also, in this edition, there is reference to upcoming Industry Information and Engagement Sessions [ie – Roadshows] which will be conducted across June 4-6 in each of the key regional areas where TAB racing is conducted. From an information perspective, our aim is to provide participants with a clear picture of the things that are happening inside GRSA which either impact them directly or their understanding of broader industry context. From an engagement perspective, we anticipate that the majority of the time in these sessions will be allocated to Q&A – taken from the floor and answered directly by members of the Board or Management team at each event. I can't encourage our participants – trainers, breeders, owners – strongly enough to embrace the fact that this is a unique opportunity to have such an open and public exchange of ideas and information and to support the event with their attendance.

Draft of future Sky Racing Schedule

Over the past few months GRSA has undertaken various form of consultation with the industry to gauge views on the racing and trialling schedule once the new Murray Bridge facility is completed.

This consultation culminated in a dedicated industry workshop on Wednesday 2nd May to finalise the draft proposed schedule.



These investigations were quite complex and needed to consider a whole range of issues, from Club/track utility, location of participants and greyhounds, opportunities to race and trial after normal working hours, equality in the distribution of meetings to regions and wagering outcomes.

Perhaps the biggest challenge was to fit the current 5.5 weekly Adelaide meetings (3x Angle Park, 2x Gawler, 0.5x Strathalbyn) into three clubs with four tracks (two tracks at Murray Bridge). This allocation would always result in one of either Angle Park, Gawler or Murray Bridge receiving less than two weekly meetings.

The following draft schedule is a culmination of the investigations. It should be noted that the schedule remains a draft and is subject to final endorsement from the GRSA Board, management, Clubs and participants. If you have any specific feedback relating to the draft schedule, it should be forwarded to GRSA Racing Manager Shaun Mathieson at shaun.mathieson@grsa.com.au.

The GRSA Marketing Department intends to conduct a Facebook Q&A session in the coming week where management will be happy to answer queries from the industry regarding the draft racing and trialling schedule.

Victa Louise takes out Breeders 2018 Prelude (2) Final

Up and coming sprinting star Victa Louise added another feature race to her collection taking out the second Prelude Final of Breeders 2018.

Trained by Robyn Mackellar and owned and bred locally by Ron and Joan Schadow the daughter of Fabregas and Victa Brooke began brilliantly to lead a high quality field of top youngsters. The track was in fine order with Victa Louise recording a personal best time of 29.60 for the 515m journey taking her record to an imposing 14 wins and 2 placings from just 18 starts. She has won over \$22,000 in prizemoney and will be hoping to add another \$25,000 with her next major target being the Group 3 Howard Ashton Final on Thursday, 31st May.



Big night of feature racing at Angle Park

The state's best greyhounds gathered at Angle Park for the Bargain Steel Centre Anniversary Cup Final and Distance Championship Final on April 26th.

Both races highlighted the crème of South Australian racing with quick times and exciting racing the order of the night.

It looked like a match race on paper for the SA Distance Championship and it turned out exactly that way with Ashom Monelli for Tony Rasmussen just edging out Purpose Driven for Cameron Butcher in a terrific display of speed and stamina.

Both were well found in the market and as the start was affected Ashom Monelli pounced on the early lead, Cryer's Plugger for Tracie Price moved into a clear second while Purpose Driven slotted across nicely onto the rails in third place. As the field of stayers raced down the front straight they made for a great spectacle with 1 lap to go as the large crowd was keen in anticipation on what the final lap would bring. Entering the back straight Ashom Monelli began to move away from his rivals however Purpose Driven also made her move running strongly into second position and setting out after her main adversary. Shot Thru for Jamie Quinlivan and Springvale Cooke for Gavin Harris began to make good ground from midfield and looked set to battle out the minor prize as they got the better of Cryer's Plugger. Ashom Monelli had a handy break off the back straight however turning for home Purpose Driven had closed the margin to inside a length and was full of running. Into the front straight and Ashom Monelli gave a good kick while all the time Purpose Driven was making ground however the post came up too quickly with Ashom Monelli hanging on for a stirring victory in a solid 43.51 for the 731m journey. Purpose Driven was brave in defeat only going down by a neck. Springvale Cooke got home well for third only 2 lengths away just too edge out surprise packet Shot Thru who performed well at only her second start at the distance.

The son of Mogambo and Jackie Bale is owned locally by Tim Aloisi and Matthew Lehman and has now won 25 races from 63 starts with 20 placing's and prizemoney around \$110,000.

The Bargain Steel Centre SA Anniversary Cup Final had one of the best fields in recent years assembled after three outstanding heats were run last week.

Leading market contenders were the flying Honcho Monelli for Tony Rasmussen, young up and coming star Cairnlea Jet for Petar Jovanovic and last year's brilliant winner On Fire for Cameron Butcher.

As the start was affected last November's Gawler Cup winner Windmill Haze exploded from box 7 for Ken Gill to lead easily to the first turn. Cairnlea Jet began well and settled nicely into second position from box 2 and loomed as a big danger however all eyes were back in the field to see where the other big guns were. Both Honcho Monelli and On Fire blew the start from their wide boxes and looked to recover ground with Honcho Monelli worse than midfield and wide leaving the front straight and On Fire last and looking for gaps to the inside. Down the back straight Cairnlea Jet quickly collared Windmill Haze up the inside and raced to the lead, both Bean Monelli for Tony Rasmussen and Fox Gambler for Sharyn Gray were battling out 3rd and 4th however looming large on their outside was Honcho Monelli and from the rear On Fire was getting to the outside of the track and powering home.

Off the back straight Cairnlea Jet was full of running and looked to be headed for a scorching time, Honcho Monelli challenged Windmill Haze for second but was still a number of lengths of the lead while On Fire continued to make ground from midfield. Entering the front straight Cairnlea Jet was in no danger and powered to the line with attention now turning to the clock. As the son of Bekim Bale and Cairnlea Elle crossed the finishing line he ran a sizzling 29.45 for the 515m journey in winning by 2 lengths. Honcho Monelli was gallant in defeat after being slow out and wide he still got home in a slick 12.55 while On Fire nailed Windmill Haze for third a further 2¼ lengths away, storming home with a flying 12.51 run home.

Full credit must go to Cairnlea Jet, his trainer and owner Jan Hubbard for a brilliant performance. He only turned 2 years of age last month and to knock off the best sprinters in the State was a superb effort and all goes well for his racing future.

Cairnlea Jet has now won 8 races from just 15 starts and 4 placings with prizemoney over \$26,000.

First 4 months of dates released for 2018/2019

Pending the introduction of the new Murray Bridge track expected later this year, we have released the dates for the first 4 months of 2018/2019 season from July through October. See page 44.

2018 Group 3 Howard Ashton

The major race for Breeders 2018 is the Group 3 Howard Ashton. Trainers are reminded that the heats will be run on Wednesday, 16th May.

These will be followed by the Semi- Finals on May 24th and the \$37,500 final on May 31st. Total prizemoney for heats and semis will be determined by the number of races run.

The race is for greyhounds that are eligible for Breeders 2018. Greyhounds don't have to have competed in the Preludes to run in the Group 3 Howard Ashton.

Maidens added to Angle Park Thursday nights

Claiming races being conducted

Specific claiming race conditions have been released for these events, but basically, greyhounds are graded into an event with a claiming price.

Prior to the event, new owners can buy the greyhound before it starts with any prizemoney won being retained by the old owners and then the new owners take the greyhound after the race.

These races provide an opportunity to sell and buy greyhounds that are currently competing.

Mount Gambier returning to racing

The upgrade of the Mt Gambier track has been completed. The project involved raising the cambers around the track to 10% on the turns and 4% on the straights.

The positions of the starts and track access points were all impacted by the increase to the camber.

The club will return to racing on schedule for this Sunday 13th May after trialling on Tuesday.

Mount Gambier set to run additional fortnightly Thursday meeting

The Mount Gambier Greyhound Racing Club is set to run an additional fortnightly Thursday afternoon race meeting over the coming months.

The addition of these meetings follows consultation between the Club and GRSA on servicing local participants during the temporary closure of the Warrnambool Greyhound Club for refurbishments from May to August. With the pool of nominations for Mount Gambier coming from the South East region of SA and from across the border in country Victoria, it is believed that an extra meeting per fortnight will assist participation in the region. The change will result in Mount Gambier racing on a two week cycle of Friday/Sunday in the first week and then Thursday/Sunday in the second week.

GRSA have released three extra dates in the first instance in late May and June to establish support, with the intent to add additional meetings in July and August whilst the Warrnambool works take place (estimated at 4 months). GRSA thanks the support of the Mt Gambier GRC, Radio TAB, staff and Sky Racing for their support for these extra meetings.

Cairnlea Jet rockets up the ranks to claim monthly awards

The Petar Jovanovic trained Cairnlea Jet went from Grade 6 company, to winning the Anniversary Cup final against the best sprinters in the State, in the space of only one month to be named the Greyhound of the Month for April.

The son of Bekim Bale and Cairnlea Ellie was undefeated in April winning all four of his starts. He started the month off by winning a Grade 6 heat at headquarters before sizzling around the Angle Park loam in 29.70 when he won the final. He made the big step up to Open grade when he



contested a heat of the SA Anniversary Cup. He won the heat in a slick 29.66 defeating reigning Greyhound of the Year On Fire in the process and went into the final as one of many winning chances. He was sensational in the final running a brilliant 29.45 in defeating one of the best fields

seen in recent times at the venue.

At the end of the month Cairnlea Jet's record stood at 15 starts with 8 wins and 4 placings and earnings around \$25,000. Only turning 2 years of age in March he looks to have a very bright future.

The Run of the Month for April was Cairnlea Jet for trainer Petar Jovanovic for his performance at Angle Park on Thursday, 26th April in the Anniversary Cup final, just edging out Victa Louise's performance for Robyn Mackellar when she ran a track record over the 388m at Angle Park on the 4th April.

Cairnlea Jet was taking on the best sprinters in the State and ran a super race. From box 2 he was able to position just off the pace in second spot before exploding to the front down the back straight. From there he was powerful to the line running a super 29.45 for the 515m journey in winning by 2 lengths against a very strong field. His splits were 4.45, 16.82 with a run home of 12.63.



Shane McQueen Memorial Final in late April

The main 600m feature at Angle Park comes up on Thursday, 31st May with the running of the \$4,990 heats of the Shane McQueen Memorial.

This series has always been well supported by the Industry with three or four heats normally run. The Final will be held on Thursday, 7th June and will be worth \$9,290.

* Nominations close on Monday, 28th May with GRSA at 9.00am.

2016 AGRC/Greyhound Racing SA Greyhound Auction – Racing Dates

The Main race series for greyhounds that were purchased through the 2016 Auction will be \$4,590 heats run on Thursday, 7th June. The \$19,000 final will be run on Thursday, 14th June 2018.

* Nominations for the heats will close with GRSA on Monday, 4th June at 9.00am.

There will be another series to be run in July or August over 515m for \$1,130 heats and then the final is worth \$5,000. These dates are yet to be confirmed.

Port Augusta Cup increased to \$5,000

The Port Augusta Greyhound Racing Club has advised that their Cup will now be worth \$5,000. Their heats will be run on Saturday, 16th June and the \$5,000 Final will be run on Saturday, 30th June.

\$7,000 Stayers Cup in June

The next feature race for the stayers will be Heats of the Stayer's Cup on Thursday, 22nd June over the 731m journey. The \$7,000 Final will be run on Thursday, 29th June.

AGRC to sponsor the next Low Grade Feature Heats in June

The next low grade series heats at Angle Park will be run on Thursday, 21st June for SA Bred and/or SA Owned Grade 5 greyhounds over the 515m.

Conditions will be that if sufficient nominations are received to run two heats of SA Bred then those heats will be run. If insufficient nominations then SA Owned greyhounds will also be included with the SA Bred dogs given first preference. The Adelaide Greyhound Racing Club will kindly sponsor this event with added prizemoney and a rug to the winning connections donated by Kay Versari.

The final will be worth \$5,340 run on Thursday, 29th June.

*Nominations close on Monday, 18th June at 9.00am with GRSA.

Gawler Produce Stake Heats in June

A reminder to all trainers with greyhounds paid up for the Gawler Produce Stake that the heats will be run on Sunday, 24th June. The semis are listed for Sunday, 1st July and the Final will be held on Sunday, 8th July.

The prizemoney breakdowns will be announced after the number of heats are known, however the Final is guaranteed at \$22,000 and Consolation at \$2,700.

Nominations for the heats close on Tuesday, 19th June with GRSA at 9.00am.

The winner of the Final is also eligible for a \$6,000 bonus if it can win the 2018 Gawler Gold Cup later this year. If the winner of the Gawler Produce is SA Bred, there is also a \$1,000 SA Bred Bonus.

2018 Gawler Breeders heats on July 15

After the Group 3 Howard Ashton Final this month the Gawler Breeders will be run on Sunday, 15th and 22nd July for those greyhounds that are eligible for Breeders 2018.

Accell Therapy mat now available at Angle Park

The mat is now available in the foyer area of the Angle Park building. It is recommended that a greyhound derives benefit with a 15 to 20 minute session and is generally for recovery from racing or injury.

It will be available during normal office hours to be used [greyhounds racing on that day excluded]. Please ask the Racing Admin staff if you wish to use the mat. GRSA is working towards making this available also during trial sessions.

Trial fees at race meetings

With GRSA allowing for trials under certain conditions at race meetings, on occasions payment of these trials may have been overlooked.

From the 1st April any trainer trialling a greyhound at the race meeting will be required to pay staff as they would at a normal trial session. This will be consistent with all our racing and trialling meetings.

Grading Review Panel to meet on Friday, 25th May

The Grading Review Panel will meet on Friday, 25th May to discuss grading in South Australia from an Agenda provided by submissions and industry consultation with the outcomes released shortly after the meeting.

Checking off of greyhounds at trials on Tuesdays and Wednesdays

Stewards have advised that the checking off of greyhounds to clear them to race will ONLY be conducted at trials on Tuesday nights and Wednesday nights.

Syndication interest from trainers

Greyhound Racing SA is interested in gaining feedback from trainers who would be interested in having their details made available to any prospective syndicate groups.

GRSA receives a number of queries from owners about getting involved with their friends however it is quite hard for them to find a trainer. Those trainers who are comfortable with this please respond to Shaun Mathieson via email shaun.mathieson@grsa.com.au or phone [08] 8243 7100. These details would only be made available to syndicate groups.

Naming applications

When lodging a Naming Application participants are advised to allow at least two weeks for the name to be approved from Greyhounds Australasia and then for GRSA to process the application and issue a greyhound card and weight card.

Therefore, should you wish to nominate the greyhound GRSA suggests that you lodge the Naming Application three weeks prior to nominating, this will give GA, GRSA and yourself enough time to name the greyhound, issue documentation and then for the trainer to have the greyhound "checked off" on a trial night.

This time frame could be further extended if GA requires more name choices.

Trainers are reminded of their obligation to notify GRSA within 3 working days of a greyhound coming into or leaving their kennel (Rule 105(4)(i)).

This is a requirement for all greyhounds regardless of where bred. We have had a number of trainers recently put in training amendments late the night prior to nominations closing at 9am the following day, this practice can lead to your nomination not being accepted or being unable to nominate online should any issues arise the following morning.

Trainers are also leaving it to the night before nominations close to have greyhounds "checked off". This practice can also lead to your nomination not being accepted or being unable to nominate online should any issues arise.

It is therefore in the trainer's best interest to have lodged with GRSA the training amendment and clearance of the greyhound a number of days prior to wishing to nominate the greyhound. It is not GRSA's responsibility to ensure that the paperwork is processed within ½ hour, which is the amount of time available to have it processed before nominations close at 9am.

Handling greyhounds at the trials while lure in motion

A reminder to participants that when on course for any trial sessions that the lure could be in motion at anytime. Please be mindful of your surroundings and also with your greyhounds ensuring you have full control at all times.

Completion of paperwork

Participants are reminded of their obligation to ensure that when lodging paperwork that it is fully completed and payment is made at the time of lodgement.

GRSA is here to assist should you be unsure of how to complete any paperwork however it is not our responsibility to arrange for its completion, nor is it our responsibility to ensure that it is lodged. Therefore, please ensure when lodging any paperwork eg, Transfer of Ownerships, Litter Registrations etc that they are fully completed and paid for (if payment required) and lodged within a timely manner.

NOTES OF INDUSTRY CONSULTATIVE GROUP (ICG) MEETING

HELD IN THE BOARDROOM OF GREYHOUND RACING SA LIMITED, 55 CARDIGAN STREET, ANGLE PARK ON FRIDAY 23 MARCH 2018 AT 9.30AM

The meeting commenced at 9.34am.

1 APOLOGIES

Melissa Trowbridge, Tony Hinrichsen and Ryan Tugwell were noted as apologies.

2 NOTES FROM PREVIOUS MEETING

The notes from the previous meeting were agreed to be an accurate reflection of matters discussed at that meeting.

3 BUSINESS ARISING FROM PREVIOUS MEETING

3.1 Breeder Support Changes

Panel members noted Victoria's recent positive breeding figures but suggested that the benefit would not flow through for the best part of 12 to 18 months. It was noted that the recovery in NSW breeding was relatively poorer.

Panel members noted that the newly introduced breeder payments had been received positively.

The Chairman advised that despite signs of breeding uplift in Victoria, the South Australian industry should not be relying on interstate supply and needs to nurture a strong local breeding framework.

The CEO sought direction from the group regarding the manner in which the Superbonus scheme may best be expanded to increase payments made through that vehicle. The feedback pointed to the merit of GRSA rewarding the performance of SA-Bred greyhounds in interstate Group racing series by introducing payments for making the finals of those series and/or for running placings in those finals.

Panel members noted that breeders do not get rewarded for making a Group race final in SA, other than for the Adelaide Cup. The group suggested that the significance of those performances interstate was often greater. Notwithstanding, it was suggested that finalists in the Oaks, Derby and Gawler Gold Cup receive a \$250 bonus if the expansion of the scheme was able to stretch that far.

3.2 Trainer's Travel Fee

The CEO raised the possibility of the reintroduction of the Trainer's Travel Fee for local trainers travelling long distances. He suggested that the argument supporting its re-introduction was not obviously compelling, would be difficult to fit equally across the circumstances of different participants, and creates a disproportionate administrative burden. He observed that its previous introduction had been predicated upon helping participants from regions wherein tracks had closed to transition to new opportunities.

Panel members questioned whether particular trainers who had been affected by track closures should receive the fee. Members noted the overall benefit to the industry that flows from trainers travelling to distant tracks. It was then suggested that the fee might be applied against a 'per kilometer' basis, rather than as a flat payment. Following further discussion, the Group resolved to support Management's view to not reintroduce the fee on the basis that the benefits did not appear to outweigh the associated issues.

3.3 Six Dog Fields

The CEO noted that the Board is equipped with a number of 'levers' to counter foreseeable issues associated with greyhound supply over the coming 12 months, one of which is field size reduction. For the moment, Management is managing supply issues by way of amendments to scheduling and programming of race meetings.

Panel members noted the suggestion of the need to introduce Pathways racing on Monday nights, but also suggested that the same pool of dogs would be highly likely to have nominated for that meeting, regardless, in standard graded races.

Panel members queried whether 388m races were conducted for the same prizemoney as 515m races on a Monday and suggested they would like to see a lower amount, potentially at the Wednesday prizemoney level. Further to discussion, it was determined that a 388m race on Monday would be paid at the same prizemoney as Level 2, Wednesday.

Panel members noted that the issue with having 388m racing on Monday night in any form was that it ran the risk of forcing serious punters out of the habit of betting on that timeslot. It was confirmed that 388m races would only occur with very low nominations and will be avoided where possible.

3.4 AGRC Items – Fence/Sails/Fast Start Boxes etc

The CEO noted these items have been captured and will be discussed further between GRSA and the AGRC.

Panel members noted an additional query received from a Trainer regarding the height of the catching pen fence. It was noted this item will be included with those previously raised and considered.

3.5 Hot Weather Policy

The panel were advised that there had been five meetings lost to hot weather (one at each track) over the summer period. The CEO asked the group whether there were any specific issues that required tweaking. The group observed that the policy was now working reasonably well and that there were no obvious issues.

3.6 Murray Bridge Scheduling

The CEO noted Management's concern regarding having both straight track and one-turn racing on the same day at Murray Bridge. It was advised that alternating tracks during the one meeting would require maintenance of two racing surfaces, involve extra staff, present challenges for the broadcast and incur additional cost.

Panel members questioned whether there would be potential issues with nominations by holding a meeting for only one track 'type' on a given day. The panel was advised that the risk of having two options was that nominations for each grade on each track would be diluted.

The panel questioned whether the issues raised could be overcome. It was suggested they were not insurmountable. Panel members suggested that the use of the straight track (potentially on Sunday) as preparation for Thursday night racing would be well supported as some Trainers would utilise this in place of a trial.

3.7 \$15 Starter Fees

The CEO noted a proposal currently before the Board to replace the current \$15 unplaced allocation with a \$20 subsidy to support trainers specifically with the costs of time and transport associated with raceday attendance. The group noted that it had previously indicated its philosophical comfort of such a change and was supportive of the proposal.

A break was taken 11.13am.

4 AGENDA ITEMS

4.1 Chairman's Address – Grantley Stevens

The meeting resumed at 11.24am

The Chairman noted his excitement at having been appointed to the Chairman role. He congratulated Michael Fabbro for the outstanding contribution that he made during his tenure and observed that his achievements have set the foundation for future success. He expressed the view that the current landscape was defined by opportunity and that SA was well placed to lead the country in a number of areas. The Chairman noted that he will be transparent in his dealings and welcomes feedback from industry.

The panel wished to have the minutes reflect the appreciation that the participants have for Michael Fabbro and everything that he has done for the industry, recognising that Michael had earned their trust for consistently delivering on his promises. On behalf of the group, they also welcomed Grantley to the position of Chairman.

On a somewhat related note, the Chairman noted the passing of former GRSA Chairman, Bob Kennedy and advised that GRSA Board and Management would be represented at his funeral.

4.2 Syndication

The Chairman noted the importance of syndication and the need to attract younger people and new participation to the industry.

The CEO flagged the significant regulatory implications associated with GRSA promoting syndication – based on ASIC requirements around managed investment schemes – and the issues that the national industry had encountered in its efforts to obtain Lead Regulator status. He did, however, identify that there were compliant steps that could be taken to match public interest in ownership back to a register of industry trainers.

He asked the group what level of interest they felt existed from industry to be open to expressions of interest in syndication from the general public. Regardless of that interest, he expressed the view that a process of filtering would need to be applied to any registered Trainer who might apply to put themselves on a register of the kind being contemplated.

The CEO opened the topic up to the group for comment.

Panel members noted that they have occasionally fielded questions from the public and has provided contact details but has never had any follow up. It was advised that the Marketing Department has received emails and comments on Facebook, and that it must be in a position to direct those enquiries in a meaningful manner.

Panel members provided details of modelling that had undertaken and noted the potential merit of an option which would involve prepayment of fees. It was suggested that any syndicate trainers should be separately licensed with the regulator holding a trust to control all syndicate monies.

Panel members raised some issues that syndicates face including the difficulty in obtaining payment. It was suggested that trainers for public syndicates should be required to meet minimum criteria and that information should be provided to syndicate members to educate them on all relevant context. Amongst other things, syndicate members would need to be made aware of their obligation towards responsible ownership over the full life of the dog.

It was further suggested that it would be beneficial for trainers to undertake customer service training so they do not provide a negative experience to syndicates. There was suggested benefit in a register of current race dogs being maintained and responsive to public enquiry. It was noted that owners in this code would see their greyhounds race more frequently than their thoroughbred counterparts and that this message should be conveyed.

Panel members suggested the need to maintain a list of trainers interested in taking on syndication enquiries as well as a list of dogs and pups available for syndication. It was felt that GRSA should consider the allocation of a resource to coordinate and manage those lists. Panel members endorsed the concept raised earlier in the meeting of an advanced payment and felt that this would make trainers more amenable to the concept.

It was suggested that trainers would be identified based on specific criteria and then discussions could be held with those selected, potentially around 15, trainers. Panel members questioned whether larger breeders would be open to offering shares in pups or dogs. It was suggested that breeders are already proactively searching for owners via social media.

Management committed to determining how this feedback could be brought together in a manner which supports new ownership without offending ASIC requirements in relation to syndication. The CEO noted the documentation that panel members had prepared and sought their assistance with providing same to Management, assuming that they were happy to share the information.

4.3 Sky Racing Schedule

Panel members raised issue with the proposed schedule having all Murray Bridge races scheduled for weekdays. The Chairman queried whether Gawler and Murray Bridge could alternate on Sundays in response to which panel members suggested that there would be merit, but also flagged the limitation of the absence of track lighting on the straight track which would prevent same.

The CEO advised that the schedule is genuinely open to discussion and that it would be beneficial for Management to consult with participants from all areas to determine the optimal schedule. It was suggested that a balance of club delegates and 'representative' participants be consulted to gain a broader perspective. Panel members suggested the need for GRSA to provide a second draft based on feedback received today, including one meeting at Murray Bridge outside of work hours. Management committed to gathering trainers from each area of SA as well as four representatives from the TAB tracks within the next four weeks to discuss the proposed schedule.

4.4 Murray Bridge – transport to Straight Track

Management discussed the different options available and requested the group's opinion on the best approach. The preferred option of the group was for trainer transport only – that is, trainers and greyhounds would be required to walk to boxes, with trainers being transported by minibus back to the kennelhouse.

4.5 GOTY – main awards & outstanding service

Panel members suggested that the panel would benefit from periodic renewal. In response to the points that were raised within the agenda he endorsed the notion that to replace the voting system with a points system would be fraught.

Peter Damarell expressed the view that the system has been functional and noted that his decision to resign from the panel was based purely on the acrimonious nature of the response towards the panel from some participants in light of what some felt to be a contentious outcome to the 2018 GOTY award.

The CEO suggested that the GOTY panel may benefit from the addition of some GRSA representation. After further discussion, the group resolved its support for the inclusion of both Shaun Mathieson and Greg Barber in the first instance.

4.6 DEWNR – minimum kennel size

The CEO pointed to legal advice received regarding the minimum kennel size standard prescribed in legislation from August 2017 and noted that the standard cannot be applied retrospectively to existing facilities.

The group spoke about the separate difficulty of applying any such standard to greyhound breeders having regard for the circumstances under which those pups reside – eg rearing yards for the first 12 months or more of their life.

4.7 Local Rule - rehoming

The CEO noted GRSA's intention to be recognised as national leaders in animal welfare by progressing to this next step in a broader strategy. Panel members indicated their support for the introduction of the Rule. Panel members queried whether the ability existed for dogs being re-assessed to be prioritised for testing. The CEO committed to flagging that question with Management.

Panel members queried GRSA's approach to a recent situation wherein the 10 day retirement rule was applied in a manner which they felt was too 'literal'. The CEO observed that GRSA has a fundamental requirement to be consistent around its application of policy. He did add, however, that Management has continuously prioritised the refinement of GAP's systems and processes and will continue to do so until everything has been perfectly bedded down. He asked the group to understand the scale of the change that had been necessary over the previous two years and the complexity involved in the different elements of managing the rehoming strategy.

It was suggested that a case study of third party adoptions should be considered for inclusion within the Annual Report.

4.8 Pink Card Policy

The CEO requested comments or feedback from the group in order to sign off on the policy but no additional changes were forthcoming.

5. OTHER BUSINESS

Panel members expressed concern regarding offences and penalties being carried through to GOTBA coursing. It was suggested that straight track coursing should be exempted within the context of racing suspensions. Management noted that this would offend the relevant national Rule, further to which it was advised that this was avoidable, but only if Virginia was classified as a trial track.

Panel members suggested the possibility of puppy races from 14 months of age at Virginia. The CEO committed to that question being tabled for inclusion on the agenda for the next ICG meeting.

Panel members noted a letter received from Council regarding the new DCMB regulations and sought clarification as to whether GRSA intends to have any communication with trainers in relation to same. The group was advised that Management is working on providing the necessary information directly to the DCMB on behalf of participants.

Panel members noted the lack of trials on Easter Saturday. Management advised that historically trials have not occurred on Easter Saturday and it is classed as a public holiday in South Australia. It was resolved to remain as is for this year but Management would commit to reviewing for next Easter.

The group were made aware of the outcomes of the recent SA election and the growing need for the industry to have a voice within Government.

Panel members noted the installation of the Accell therapy mat and management confirmed its readiness for use.

Stewarding, Animal Welfare and Licensing

Licensing time is approaching

GRSA licences expire on 30 June. Keep an eye on your mailboxes as all licence renewal forms will be posted out in the last week of May.

Whilst GRSA aims to process applications in a timely manner, participants are encouraged to ensure all paperwork is correctly completed and lodged with payment as early as possible.

Trainers are also encouraged to contact owners to ensure their licences have not lapsed as a greyhound will not be eligible for nomination if this is the case.

Outstanding fines

A small number of participants with outstanding fines have been advised by letter to ensure payments are finalised or approved payment plans are in place.

Trainers who have failed to pay fines and do not address the matter may have nominations stopped or will not be permitted to renew their licences until they become financial.

Lodgement of breeding documents

With the removal of fees for breeding documentation I remind participants of the due date for lodgement of documentation under the Rules of Greyhound Racing.

It is imperative that these documents are still lodged on time so GRSA can plan for the future regarding greyhound population.

Notice of Service [within 14 days]
Whelping Notice [within 14 days]
Litter Registration [within 4 months]

To ensure documents are received by the due dates the following fines have been reviewed and have been increased and will be imposed should documentation be lodged late.

Due date to 4 weeks overdue - \$50
5 weeks to 8 weeks overdue - \$100
9 to 12 weeks overdue - \$150
13 to 16 weeks overdue - \$200
17 plus weeks overdue - \$250

Changes to Rulebooks

Any industry participant with a Rulebook is welcome to hand it in to GRSA reception for it to be updated with the recent national and local rule changes. This service is provided free of charge.

Application to re-vet injured greyhound

Where a greyhound has had an injury stand down imposed by the on-course veterinarian, the Trainer may apply to have the suspension period varied under GAR 73(3).

When applying for re-vetting, Trainers should be aware of the following:

- An application must be made to GRSA Stewards prior to any official re-vet being conducted;
- The greyhound must be free of any injury and cleared to race at the time of inspection;
- Only one application is to be made for re-vetting. Therefore, if the greyhound is not cleared at this inspection, the original stand down period will be upheld with no further opportunities to have the penalty varied;
- The penalty imposed for any scratching can only be varied to a minimum of 7 days under GAR 23(5)

The relevant national rules are below:

R73 Greyhound suffering injury

[3] Where a greyhound is prohibited pursuant to Rules 37(2) and 73(1) from competing in any Event, the trainer may, subsequent to the day that an order is made, make only 1 application to the Stewards for the greyhound to be examined by an officiating veterinary surgeon or authorised person, to determine whether at the time of the examination the greyhound is free of injury and if the greyhound is found not to be suffering an injury the restriction imposed shall be revoked.

R23 Withdrawal after box draw

[4] A greyhound withdrawn from an Event due to injury or illness, shall be prohibited from competing in any Event immediately from the time of its withdrawal until the completion of a period of 10 days commencing on the date of the event ["period of prohibition"].

[5] The period of prohibition referred to in sub-rule [4] may be varied to a minimum of 7 days upon production of a veterinary certificate to the satisfaction of the Stewards stating that at the time of examination the greyhound is fit to start.

Breeding information

All current and lapsed breeders have recently been sent updated breeders information packs. New breeders who apply going forward will also be provided with this pack.

The pack is also uploaded to the GRSA website under the 'Get Involved' banner.

Inquiries and notifications

Mr. Ben Rawlings – Racing Appeals Tribunal 13/04/18 – GAR 86[o] – Misconduct in that he engaged in an exchange with another trainer and made offensive and unnecessary comments at the Greyhound of the Year Awards at Gawler on 02/02/18. Mr. Rawlings pleaded guilty and he was fined \$1000; with \$500 suspended for 12 months on the condition he does not reoffend. Mr. Rawlings appealed on the grounds of the severity of penalty. The appeal was dismissed and the penalty stands.

The Golden Rules

Since the introduction of cobalt and arsenic thresholds, all participants should be reminded – in their own best interests – that there are a number of Golden Rules that can help them to avoid making any such breaches (for prohibited substances generally) and which should be adhered to as principles of best practice:

- Always consult your vet to seek guidance in relation to any of the products that you are using, any associated risks and other relevant context
- Review the range of any feeds or supplements that you typically purchase and, wherever it is reasonable to do so, replace products containing substances that could contribute to a threshold breach under the rules [eg. cobalt] with alternative products
- Observe the instructions on any products that you use and adhere strictly to those directions [having regard for prescribed amounts, frequency of administration/ application, methodology for administering/applying]
- Ensure a greyhound is never administered any treatment on race day other than as relates to its feeding and drinking requirements [GAR83(A)[1] treats this as a specific offence]
- Refrain from the use of injectable treatments [eg. Vitamin B12] to any extent that is practical, including ensuring a greyhound is not administered any injectables the day before an event

Our registered participants have the responsibility to ensure that greyhounds are presented to the track free of any prohibited substances. This information is offered as advice in good faith and should not be relied on as a defence in the event of a breach occurring.



Greyhound Rehoming Obligations resulting in new Local Rules

GRSA has a fundamental responsibility to ensure full rehoming of greyhounds and we have committed to that outcome being delivered. As of 1 May 2018, GRSA will introduce Local Rules ensuring every greyhound in this state has the opportunity to be rehomed. As a result, the only acceptable reasons for euthanising a greyhound in South Australia will be because of serious injury, serious illness, by court order or because of an unsuitable temperament for rehoming (as identified by GAPSA).

In order to accommodate all greyhounds, GAPSA has made significant progress in terms of GAP resourcing, reduced waiting times for foster care and the subsidy for greyhounds on the waiting list beyond six weeks. Testing opportunities have been increased in all parts of the state. Participants have seen these positive changes rolling out for some time. This preparation means that whilst an increase in the number of greyhounds requiring assessment is expected to increase, GRSA is ready to implement the new Rules and be able to ensure all participants are able to comply with the requirements. The impact upon assessment and availability and waiting times will be monitored and resourcing adjusted as required.

GRSA participants should take pride from the fact that our state holds animal welfare at the highest standard and requires, expects and encourages all participants to take responsibility for their greyhounds – during and after racing. Our approach to rehoming is the foundation from which the SA industry can move forward with confidence and respect.

In an effort to provide information about the Local Rules, a number of Frequently Asked Questions have been addressed below:

Q: Why are these Local Rules necessary?

A: GRSA has a fundamental obligation to every greyhound to ensure that it has the opportunity to be rehomed.

Q: What does this mean for me?

A: A majority of industry participants have been doing the right thing and have been rehoming their greyhounds – either through GAP or third parties. If you have been doing this, then it won't affect you.

Q: I have always attempted to rehome my greyhounds with owners or third parties. Can I continue to do this?

A: Absolutely! This is so important and a large number of greyhounds find suitable homes post-racing through the hard work of Trainers and Owners. These numbers contribute to a significant number of rehomed greyhounds.

Q: If my greyhound has been rehomed to a third party, does it need to be GAP assessed?

A: No – we trust Trainers and Owners to ensure they are responsibly rehoming greyhounds to suitable homes. However, we would always encourage the new owner to contact GAP to consider options for obtaining a green collar.

GRSA regularly contacts the new owner of a greyhound which has been retired through a Trainer or Owner as part of its broader tracking requirement. This also gives the opportunity for feedback about the interaction during the rehoming and information about how the greyhound is settling in to their new home.

Q: I am a Trainer. Can I keep my greyhound as a pet myself?

A: Absolutely! The greyhound does not need to be assessed for GAP. Please lodge a Notification of Retirement form within ten [10] working days of the retirement.

Q: I want to retire a female greyhound for breeding. Does she need GAP tested to become a breeding female?

A: No – lodge a Notification of Retirement within ten working days of the retirement. You would then need to apply for a Pink Card which will register her as a breeding female.

Q: What if I have an unraced, unnamed greyhound which will not be suitable for racing? What are my options?

A: The greyhound can be rehomed to a third party. If this is not an option, the greyhound must be assessed by GAP – this will give direction on whether it is suitable to be rehomed by GAP.

Q: What if my greyhound has a serious injury or illness and it needs urgent medical treatment?

A: Your first responsibility is to ensure the greyhound has appropriate veterinary treatment. If in the opinion of the treating Veterinarian that the greyhound injury or illness is so severe that it is in the best interests of the greyhound for it to be euthanised, then this is an acceptable reason. A veterinary certificate of euthanasia (with information detailing the injury or illness) must be provided to GRSA with the prescribed Notification of Euthanased Greyhound form. GRSA will follow-up with the Veterinarian for more information, if necessary.

Q: How long does my greyhound have to stopped racing for before it can be assessed by GAP?

A: A greyhound must have not raced for a period of ten (10) days before being assessed.

Q: My greyhound is aggressive and I know it won't pass GAP. Can I just get it euthanised?

A: No. We all have an obligation as part of the greyhound racing industry to ensure every greyhound is given an opportunity to be rehomed. The greyhound is required to be tested by GAP to assess its suitability for rehoming.

Q: What if my greyhound fails its GAP assessment?

A: The success rate of passing assessments are high. For the small number of greyhounds that fail the testing, GAP staff will provide the Trainer with paperwork detailing the fail. Once in receipt of this paperwork, the Trainer and Owner have the option to euthanise the greyhound without breaching GRSA Rules. A Notification of Euthanased Greyhound form, a Vet Certificate of Euthanasia and the GAP paperwork must be submitted to GRSA within two (2) working days.

Q: What if GAPSA advises me at the first assessment that the greyhound needs to come back for further assessment?

A: The greyhound must then be presented for reassessment. If a greyhound has failed the first assessment but the GAP assessors/staff have indicated the greyhound should be represented, this must be done in accordance with the timeframe indicated. GAPSA will provide a realistic timeframe for reassessment.

During this period, GAP will provide information on how to work with the greyhound to prepare it for success at its second assessment.

Q: What are my options when a greyhound fails its second GAP assessment?

A: On the second fail, GAPSA will advise the Trainer in writing of the greyhound's unsuitability to be rehomed through the program. The Trainer and Owner will have the option to euthanise the greyhound on behavioural grounds.

Q: What if I can't get an assessment with GAP? Can I euthanise my greyhound?

A: No – you will be committing a breach of the Rules.

Q: What if I choose to euthanise a healthy greyhound without going through the process as specified?

A: The matter will be referred to GRSA Stewards as you may have breached either Local or National Rules. The matter will likely result in a Stewards inquiry. Strong action has been taken in other states for participants who have failed to comply with similar rules – including disqualification of licenses.

Q: The owners told me to euthanise a fit and healthy greyhound as they don't want to put it through GAP. What do I do?

A: A direction of that nature from the owner does not circumvent the requirement to rehome. The Rules state that the Responsible Person is the person who has the care, custody and control of the greyhound. The Trainer will be required, as well as the Owner, to ensure they comply with the relevant Rules.

Q: I have been asked to provide more information in relation to the euthanasia of a greyhound. Do I have to?

A: The GRSA Integrity department monitors the euthanasia rate and reasons for all registered participants. On occasions, participants will be asked for more information or evidence in relation to reasons for a euthanasia of a greyhound. Sometimes this is asked to be provided in a Statutory declaration. If you have been directed to provide this information and fail to do so, you may be in breach of GRSA Rules and your licensing conditions.

Q: Does GRSA has the right to order an autopsy on a euthanised or deceased greyhound?

A: Stewards can order an autopsy, if they believe it is warranted.

Q: Have the timeframes in relation to the reporting of retirement and euthanasia changed?

A: No – the Controlling Body must be notified within ten [10] working days of a retirement and two [2] working days of a euthanasia.

Q: Where do I find a copy of the new Local Rules in relation to Greyhound Rehoming Obligations?

A: A copy is on the GRSA website under Integrity – Rules and Policies. As of 1 May 2018, an updated Rulebook will be available on the website or at GRSA. Information will also be distributed during kennel inspections.

What is it?

The technical name for bloat is **Gastric Dilation-Volvulus (GDV)**. There are two parts to the condition.

1) Gastric dilation: Stomach expands which often relates to swallowed air. This can occur when there is an abnormal build up of air, fluid or foam in the stomach.

2) Volvulus: As the stomach swells it can rotate 90-360 degrees. The twisting stomach traps air, food and water inside of it. This can lead to low blood pressure, shock, damage to internal organs and eventually death if untreated.

This condition is common in deep chested breeds such as Great Danes, Weimaraners and Greyhounds. Bloat is a serious health issue and can kill in less than an hour.

Symptoms (primary & secondary)

| Primary | Secondary (symptoms become apparent as condition progresses) |

| Attempts to vomit (sounds like a repetitive cough) | Dark red gums in early stages. Pale to white gums in later stages |
| Not acting like usual self | Heavy salivation/drooling |

Treatment

If your greyhound experiences any of the symptoms above seek medical attention immediately. Bloat occurs rapidly - the sooner you seek medical attention the better to increase chances of survival.

Causes & Prevention

| Causes | Prevention |

| Overfeeding | Not feeding too much meat or kibble |
| Rapid eating/drinking | Do not permit rapid eating (consider slow bowls) Feed 2 or 3 meals daily Manage water intake one hour before or after a meal |
| Exercise after eating | Do not exercise (<i>especially vigorous exercise</i>) for at least an hour (longer if possible) after eating. |

Latest updates from GAP

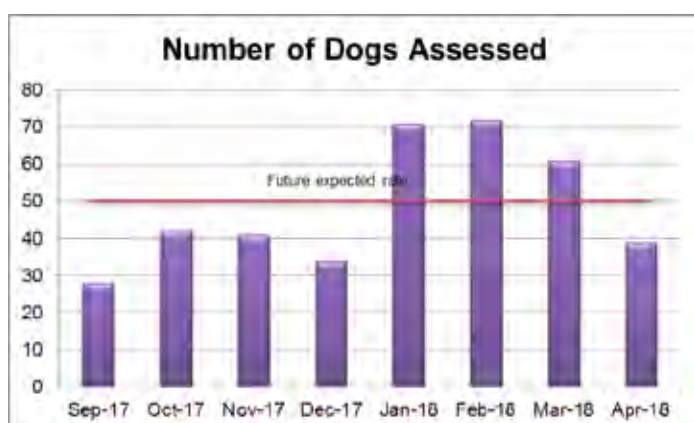
As previously advised, GAP have been increasing the number of assessments in the monthly schedule.

We continue to look to increase these further in order to offer a wider variety of times to meet participants varying requirements. The following graph depicts the number of assessments that have been occurring on a monthly basis.

We have also been working on reducing the time between assessment and entry into the program. The following graph shows the average monthly waiting times in weeks.



Do you have a small dog?



Do you or someone you know have a small dog that could benefit from some socialisation and company during the day?

GAP SA is looking for small dogs to help with their green collar and first point assessments.

Your dog will be well looked after with plenty of pats and treats throughout the day. They will assist with either green collar assessments for dogs that have been living with foster carers or for greyhounds entering the program.

During assessments, greyhounds will be muzzled, on a leash and handled by an experienced assessor and handlers. All dogs will be walked around together in a secure testing area for approximately 5-10 mins to assess the greyhound's reaction to the small dog. If the greyhound is reacting well we will allow them to approach and sniff the small dog.

We are looking for dogs that are generally social and happy meeting other dogs and ones that walk well on a lead. Sessions are rostered at least a month in advance and are generally around two to four hours in length.

Track works completed at Mount Gambier

The Mount Gambier Club will resume racing this Sunday following a three week project to improve the consistency of the camber around the track.

Whilst the camber was the primary focus of the project, the following additional works were completed:

- Raising and widening of the concrete pads at the 512m and 732m starts to the height of the new camber
- New shelter over the 512m start
- Relocation of the main vehicle access point to in between the 600m and 732m starts
- New grass matting in front of the four starting boxes
- Installation of TV's at the 400m and 512m starts
- Some minor changes to the fencing around the starting areas

The Club will install a new shelter over the 732m start in the coming weeks as the final aspect to this project.

Special mention must go to Tim Manterfield, the track work supervisor at the Club.

Tim has effectively managed the works onsite from start to finish and has put in numerous extra hours to ensure the project could be completed in such a small timeframe.

The fact that the project was completed well in advance of the return to racing, is a testament to Tim's good planning and execution.



Murray Bridge Project

The Murray Bridge project has reached the halfway point and an exciting phase as the site really begins to take shape.

The majority of major civil works have now been completed and the tracks, buildings, landscape areas, roads and car parks are well progressed.

The patron building is at lock up and internal cladding has commenced. It is really starting to feel like a racing facility and the views of the tracks from the building will make for great oncourse experience.

Despite some rumblings from within the industry, the project remains on budget and on target to race later in the year.



Angle Park Timing

At the last couple of trial sessions there has unfortunately been a failure of the timing system at the 731m boxes (handslip trials).

GRSA's electrical contractor has established that it was caused by an issue with the cabling to the timing sensor.

A temporary fix has been completed to allow the system to operate and the cabling run from the judges tower to the 731m will be redone in the coming days.

Operation Flinders Update

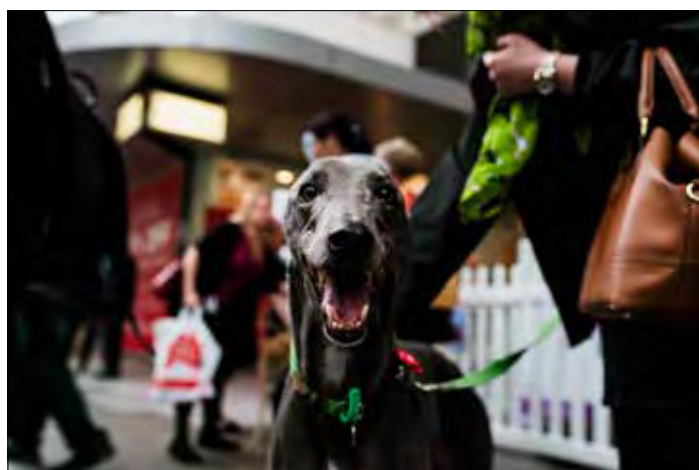

Fitting win in ANZAC Day's Dowdell Memorial

Glencoe greyhound Galactic Viper's win in the Ivor Dowdell Memorial final [400 metres] at Tara Raceway on ANZAC Day was surely a fitting result.

After all, the race – now in its second year – is run in memory of a man who was still training when in his early 90s and who had been generally regarded as the world's oldest licensed greyhound trainer.

And the winner, owned and trained by Mount Gambier Greyhound Racing Club secretary/treasurer Barry Shephard, turned five in February, making him one of very few greyhounds of that age to be still racing and winning at a TAB track anywhere in Australia.

The final attracted a good field with Mahlo Blackhawk, looking to open his Tara Raceway winning account after two recent second placings, taking up the early running over Dimora Flash and Galactic Viper.

But turning for home, both Dimora Flash and Galactic Viper were poised to make their moves – the latter finishing well along the rails to defeat Dimora Flash, who made his run out wide and failed by a head, while the early leader was a further head back in third spot in a winning time of 23.31 seconds.

Speaking at the presentation, an emotional Shephard paid tribute to the son of Velocette x Magic Elite that has now raced on 121 occasions for 26 wins, 26 seconds and 12 thirds, marvelling that the black dog was still competing and winning at an age when most racing greyhounds have been retired.

Earlier at the ANZAC meeting, Spirited Bingle, lining up for her third start at Tara Raceway, had looked to be the omen tip of the day – her dam being Kokoda Spirit.

And the black bitch showed plenty of spirit, leading all the way in the Veterans Stake [400 m] for Portland trainer Robert Halliday, running out a 6¼ length winner over Galactic Shiraz in a best of day time of 23.05 seconds.

"Actually, she should be in gaol," joked Halliday, referring to the fact that Spirited Bingle had previously copped convictions [for failing to chase] at Horsham and Bendigo.

"Mark Morrissey of Strathfieldsaye reckoned she had some ability and suggested the finish-on-lure at Tara Raceway as a means of perhaps switching her on," he said.

Kokoda Spirit, winner of the 2013 Group 3 SA Oaks at Angle Park, is by Knocka Norris

x Flaming Doll and a litter sister to former Tara Raceway 400 metre record holder Star Doll (23.05 sec.) and Guru Doll, the dam of Brinza and Odd Boots who Halliday has enjoyed success with.

And in December, Guru Doll whelped a litter of four dogs and three bitches to General Destini, this coming about after Halliday won a service to the beautifully bred sire as part of the winner's prize when successful with Hutch in the 2017 Summer Classic at Tara Raceway.

Leading trainers Tracie Price and Nicole Stanley dominated the meeting with trebles – Price with Swift Limes, Blazing Moment and Banjo Queen while Stanley was successful with Joshy Wink Wink, Bereluke and Jan's Star.

Track record falls again at Mount Gambier

In March the Philip Lenehan trained Victorian speedster Lektra Stomp claimed the 512m track record at Mt Gambier with a brilliant display in the heats of the Mt Gambier Cup running a sizzling 29.45.

On the 20th April he lowered the time mark again by .1 of a second running a blistering 29.35 in winning by 12 lengths.

ANGLE PARK

QUALIFYING TRIALS – NOW WEEKLY

Angle Park Qualifying Trials are run weekly on Tuesday night, for the corresponding Monday APM meeting and the Wednesday APD meeting. Trainers must be specific on their nominations about which day they are trialling for and what distance. (ie Wed 388m, Mon 515, Mon 600m etc)

Tuesday Angle Park Qualifying dates are:

May 15th (for APM Monday meeting on 21st May– for APD Wednesday meeting on 23rd May)

May 22nd (for APM Monday meeting on 28th May – no APD Wednesday meeting on 30th May due to Time Grading meeting)

May 29th (for APM Monday meeting on 4th June – for APD Wednesday meeting on 6th June)

June 5th (for APM Monday meeting on 11th June – for APD Wednesday meeting on 13th June)

June 12th (for APM Monday meeting on 18th June – for APD Wednesday meeting on 20th June)

Nominations close with GRSA at 12.30pm on the Tuesday of the meeting.

NOMINATING ONLINE FOR QUALIFYING TRIALS

For Angle Park, Gawler and Strathalbyn qualifying trials the nominations must be lodged with GRSA by 12.30pm on the day of the meeting. To nominate online however you can only do this up until 11.59pm the day before. Due to a system security policy you cannot nominate on the day for these trials online. Please contact our staff if you have any issues with these nominations prior to them closing.

SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number.

POLICY FOR TRIALS IN PLACE

Remember trials will only be taken from –

- * 11.30am Monday for Angle Park Tuesday nights
- * 11.30am Tuesday for Gawler Wednesday nights
- * 11.30am Thursday for Angle Park Saturday morning (day earlier due to being morning trials)

* For Public Holidays it will be the working day before ie if Monday is a Public Holiday then bookings taken on the Friday

trial days that are not booked in with GRSA remain the same process (ie Gawler Thursday)

POLICY FOR TRIALLING AT ANGLE PARK AND GAWLER BEFORE THE RACE MEETING

RACE MEETING TRIAL POLICY

Angle Park Monday & Wednesday along with Gawler Tuesday, Friday and Sunday.

Two fields from the boxes with a maximum of four (4) greyhounds will be conducted immediately following the completion of the kennelling procedure for the Race Meeting.

The following lists the order in which greyhounds will be selected in the event if more than 8 greyhounds nominated.

1. Reserves at the Meeting that do not obtain starts.
2. Trainers that have greyhounds engaged and are located in an area affected by track closures.
3. Trainers that have greyhounds engaged.
4. Satisfactory trials.
5. Other greyhounds.

PROCEDURE/CRITERIA

1. For Monday nights trainer to contact GRSA between 10.00am and 11.00am on the Monday to nominate. Should the Monday be a public holiday bookings are to be made between 8am and 9am on the scratching line.
2. For Angle Park Wednesday, Gawler Tuesday & Friday trainer to contact GRSA between 4.00pm and 4.30pm on the day before.
3. For Gawler Sunday trainer to contact GRSA between 8.00am and 9.00am on the scratching line to nominate.
4. Other than reserve greyhounds Trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
5. Stewards allot the Box for the Greyhound.
6. Trials will be 515m & 531m in distance as first preference. Other distances considered depending on nominations.
7. Greyhounds currently under suspension or not cleared to race are not eligible to be nominated (these trials are conducted as if they are at a race meeting so all greyhounds need to be eligible at nomination time).
8. Greyhound registration certificate or cards must be produced at kennelling time.

9. Trainers with other greyhounds engaged can utilize the extra kennel space until such time they are ready to leave OR trainers with no other greyhounds will be free to leave following their trial.

If there are 12 races at Angle Park or Gawler there will be NO trials.

The Vet Clinic at these meetings cannot be used to accommodate any greyhounds to allow for extra trialling greyhounds. This policy has been introduced so that participants book in under the policy. The Vet Clinic needs to be available for the Vet and Stewards at race meetings

EXCEPTIONS TO THIS POLICY–

- Thursday nights are kept available for the option for Interstate greyhounds to solo trial in a lead up to our Group races and also local greyhound's trialling for Group racing interstate.
- Local greyhounds will be allowed to solo trial in a lead up to a feature race upon request and they will take one of the eight kennels available for trialling ahead of the policy and sit separately to the 4 dog trials. Feature races are considered to be – Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals & any Group race Interstate.
- Local greyhounds will be allowed to trial on a race night, where they are in preparation for a feature event and nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy.
- If a greyhound qualifies for a feature final and requires a trial in between this will be conducted as a solo trial and sit separately to the 2 four dog trials.

It is extremely important that trainers book in to trial at these race meetings. If unable to book in at these times then please contact GRSA where permission may be given to accept a booking outside of these times. .

MOUNT GAMBIER

The Mt Gambier GRC committee advises that satisfactory trials can be run in the summer months under the criteria below.

1. On race days when there are less than 12 races.
2. On race days with 12 races when the temperature is 30 degrees or less trial can be run before the first race but greyhounds must leave the track straight after the trial to head back to their home kennel.
