STEWARDS' NOTICE - *Local Rules 2022*

Penalty Notices

Penalty Notice Offences and Penalty Notice Fines

1. Pursuant to *Schedule 2, Local Rules 2022*, the following are *penalty notice offences* –
 - (a) An offence –
 - (i) that is not a *serious offence*, except those serious offences prescribed in this Notice;
 - or,
 - (ii) The *serious offences* –
 - (A) Rule 86(o) [except corrupt, fraudulent or misconduct];
 - (B) 86(p)
 - (C) 86(q)
 - (D) 86(ag),
 - and,
 - (b) Where, in the opinion of the Controlling body, the only appropriate penalty is under rules R95(1)(a) or 98 of *the Rules*; and rule 79 of the *Local Rules 2022*; and,
 - (c) Where a fine, that fine is no more than \$499.00.
2. Where the offence relates to an attempt or conspiracy to commit a breach of the Rules (rule 86(m), *Greyhounds Australasia Rules*); or, knowingly aid, abet, counsels or procures a person to commit a breach of the Rules (rule 86(n), *Greyhounds Australasia Rules*), the offence is dealt with as if the person acted as the principal offenders for the breach.
3. Where the *penalty notice fine* is a range up to \$499.00, the amount of the fine is at the discretion of the *authorised person*, but must be after a consideration (at least) of –
 - (a) The objective seriousness of the breach, and,
 - (b) Any previous *penalty notices* issued to the person (and their fines).
4. Where a penalty notice offence does not have a prescribed penalty notice fine, the fine is at the discretion of the *authorised person*, but must not exceed \$100.00.

 - (d) GAR 86(o) [where corrupt or misconduct];
 - (e) GAR 86(r), (s), (x), (v), (aa), (ad), (ae), (af), (ah) & (ai)
 - (f) GAR 86B
 - (g) GAR 86C
 - (h) GAR 87;
 - (i) GAR 88;
 - (j) GAR 91;
 - (k) GAR 94;
 - (l) GAR 104(7);
 - (m) GAR 106(1) & (2);
 - (n) such other Rules and GAR’s expressly stated as being Serious Offences;
 - (o) such other Rules and GAR’s deemed by the Board to be a Serious Offence (as the Board may declare in writing from time to time);
 - (p) L114;
 - (q) L114A; and,
 - (r) Any rule expressly stated as a serious offence.
