# NOTES FROM GRSA MANAGEMENT

## **BODELLE FRANCIS** CEO

The Board and Management of GRSA continue to listen to our participants and the ongoing challenges that are being experienced, particularly around rising costs. The care and welfare for our dogs is at the core of everything we do and we are pleased to announce two different increases to support participants, both on and off the track. From 1 July, the TIRS has been significantly increased, covering up to \$3,500 per injury, with the scheme previously capped at \$1200 per injury. From 1 September, the Starter Fee has been doubled from \$20 to \$40 per dog. This is in addition to a modest WAP of \$64,000 to be distributed, based on July's wagering revenue generating a slightly better than forecasted result.

On the track, it has been an exciting month of racing with the SA National Distance, Sprint and Straight Championship finals all taking place. We would like to wish a congratulations and best of luck to the connections to Fantastic Radley, Fly For Trix, He's On Fire and I'm Gifted Too – we know you will do our state proud!

# Greyhound Racing SA boosts funding for Track Injury Rebate Scheme and participant starter fees

**Greyhound Racing South Australia (GRSA) has expanded its Track Injury Rebate Scheme, injecting an additional \$150,000 per annum to cover participant veterinary care costs in the event a greyhound is injured on track.**

The scheme, which has assisted in the rehabilitation of more than 60 greyhounds over the last financial year, will now absorb surgery costs of up to \$3500 per injury - up from the previous cap of \$1200 per injury.

Coverage has also been expanded to include more injury types – surgery for dislocations, ruptures and other serious injuries will now be included alongside fractures – as well as injuries sustained during trials.

GRSA Chief Executive Officer Bodelle Francis said the initiative plays an important role in maintaining injury management standards across the sport.

“As an industry, we take our responsibility to care for dogs at every stage of their life and career very seriously,” Bodelle said.

“South Australia was the first jurisdiction to implement a Track Injury Rebate Scheme and we have now reviewed it to ensure it still achieves what we set out to do – to support our participants in pursuing quality, consistent veterinary care for every greyhound.

“We trust the expanded scheme will help even more greyhounds on their road to recovery.”

Alongside the expanded injury care initiative, GRSA has announced it will increase participant starter fees at all GRSA TAB tracks from \$20 per greyhound to \$40 per greyhound from 1 September 2022, representing an additional investment from GRSA of \$300,000 per annum.

“This seemingly small increase will make a significant difference to our participants in the face of rising costs, allowing them to continue to engage with the sport, train and care for their greyhounds,” Bodelle said.

“The increased investment in both initiatives is designed to ensure all greyhounds are self-sufficient and support our participants in continuing the best practice care of their dogs.”

“GRSA is committed to setting and maintaining the highest standards of safety and welfare for our greyhounds, throughout their racing careers and onto their life as pets through our dedicated rehoming program.”

The expanded Track Injury Rebate Scheme absorbs 100% of surgery costs up to the capped amount as well as set amounts for triage and recovery. Dogs that are supported through the scheme are prioritised through GRSA's dedicated Greyhounds as Pets (GAP SA) program should they retire and need to be rehomed.

## SA qualifies two for National Straight Track Championships at Richmond

**He's On Fire for Tim Richards took out the State Final of the National Straight Track Championship on Tuesday, 9th August at Murray Bridge defeating the Ben Rawlings trained, I'm Gifted Too, in a wonderful two dog battle over the concluding stages.**

Both sprinters will now represent SA in the National Championships at Richmond on Saturday morning, 29th August, with the winner receiving \$25,000. We will take on greyhounds from QLD, VIC and NSW.

All States except Richmond have now run their State Finals with Milligan for Tony Brett and Bogie Fury for Ryan Ayre representing QLD, Quinlan Bale and Nicolson Bale both trained by Daniel Gibbons representing Vic. This Saturday (August 20) at Richmond the NSW State Final will be run, with two greyhounds to join these qualifiers in what is shaping as a terrific Final.

Richards and Rawlings both represented SA in last year's event with He's All Purpose and My Name's Craig respectively. Good luck to both dogs and hopefully we can see them produce their best.

### 2022 North v South Challenge - series update

**On Sunday night, 14th August at Murray Bridge only the first Rounds for the South were conducted with the points leaders listed below –**

These South greyhounds now head to Gawler on Sunday night, 21st August over the 400m and 531m for their second round with the top four point scorers from both rounds representing the South in the big Finals on Sunday, 28th August at Murray Bridge.

As there were no North fields drawn up for round 1 the greyhounds which nominated for the series had preference into the Sunday night at Gawler for the North series. We have drawn together a five dog field for the 400m North event featuring Lady Luck, Classy Chaos, Svitolina, Shall Not and Compton Casey and four dog 531m North event featuring Toby West, Spring Phoebe, Harry and Scott Hue with the first four placegetters from the 400m event and all runners in the 531m event qualifying for the Final against the South at Murray Bridge. The Gawler and Murray Bridge Clubs along with GRSA appreciate the support for this series from these trainers for both the South and North events.

The North V South Challenge Final over the 530m will be worth \$8,000 and a 395m Final will be worth \$4,000, to be run at Murray Bridge on August 28 and then from next year will be on rotation with Gawler over the 531m/400m every other year in July. Special conditions regarding eligibility for greyhounds and trainers have been used to establish the fields for each round and accommodate when races have not been conducted. For the Finals over 395m and 530m at Murray Bridge if there are insufficient qualifiers for either region the Finals will be made up of the remainder of the other region eligible greyhounds to make up an 8 dog field.

The next meeting of the Industry Consultative Group will be held on Friday, 9th September with an agenda sent out to members in the coming weeks.

### Kings and Queens feature heats – nominations close on Monday

**Again this year GRSA will conduct the Kings and Queens Feature series with \$5,150 Heats on Thursday, 25th August and a \$7,500 Final on Thursday, 1st September in continued support of any greyhound affected by the change to the GCA Age Restricted Classics change quite a number of years ago.**

The eligibility for this series is for dogs and bitches whelped between 1st March, 2020 and 31st May, 2020.

Performed Maidens are eligible (raced or quality trialed).

It will be dependent upon nominations, however, we would like to run a dogs Heat and a bitches Heat separately with greyhounds qualifying into the Final. If there are insufficient nominations for either sex then these Heats may be mixed into a couple of mixed Heats. Special conditions apply, however, these races will be non-penalty.

- Nominations close Monday, 22nd August at 9.00am with GRSA.

### Saturday to Thursday night finals at Angle Park

**Once a fortnight GRSA run Heats on the Saturday morning meeting at Angle Park, where there will be either (1-4 wins or 5+ wins) over the 530m and will be Non Penalty events, run as 8 dog fields. The Final will be conducted as Race 1 on the Thursday night.**

Trainers should be mindful that if you have a greyhound in a Heat and it qualifies for the Final that the greyhound will be ineligible to compete in the Final if it is engaged to race the day prior [Wednesday].

The next lot of Heats will be on Saturday, 3rd September for 1-4 wins with the Final on Thursday, 8th September.

- Nominations for the Heats close with GRSA at 9am on Wednesday, 31st August.



### NEW HANDLER VESTS COMING IN SEPTEMBER

GRSA will be introducing new handler vests to be worn at all race meets beginning early September. Keep an eye on GRSA's channels for more information to come.

# Giant's Flash has a 'giant' month in the South-East



**Greyhound of the Month for July was Giant's Flash for trainer Tracie Price, highlighted by his terrific win in the Mount Gambier Anniversary Cup Final and equalling his own track record at the Southeast venue.**

The son of Banjo Boy and Nevada Flame has been having a great year and was undefeated throughout the month of July winning all three of his starts. He started the month off with a sizzling win in open company at Mount Gambier running 29.37 in winning by almost 6 lengths. He then competed in Heats of the Mount Gambier Anniversary Cup winning as he liked, running 29.53 in winning by more than 8 lengths over the 512m. He then started favourite in the Final and didn't disappoint his fans winning by 3 lengths in a blistering 29.19 which equalled his own track record.

A dominant greyhound down the South, no doubt the Group 1 Adelaide Cup at Angle Park will be on the agenda for the "Flash" in the coming months.

**Giant's Flash for Tracie Price was also voted the Run of the Month for July after his track record equalling performance at Mount Gambier on Sunday, 24th July in the Final of the Mount Gambier Anniversary Cup over the 512m.**

Already holding the 512m track record and the 600m track record he dominated the Final from start to finish going on to win by 3 lengths in a sizzling 29.19.

At the end of the month Giant's Flash record stood at 38 starts for 20 wins and 12 placings and earnings around \$37,000.

## SA Oaks and SA Derby features in September

**The Group 3 SA Oaks and SA Derby to be run in September this year will be for greyhounds whelped on or after 1st June, 2020 [27 months].**

The Heats of the Oaks will be run on the same night as the Derby again this year with Heats on Thursday, 8th September and the Group 3 Finals on Thursday, 15th September.

## SEGRC 50 Year Anniversary Cup run next month at Mount Gambier

**As the Southeast Greyhound Racing Club is celebrating 50 years, GRSA has supported the club with an Anniversary Cup series to be run on Sunday, 11th September and the Final on Sunday, 18th September.** The series will be an Open event over the 512m and worth \$2,125 with the Final worth \$5,000.

- Nominations for the Heats close Tuesday, 16th September at 9.00am.

## TAB Match Race Challenge – SA takes on the all-stars in September

**South Australia will again conduct the annual Match Race Challenge in September, to be held on Thursday, 22nd September during the rich Adelaide Cup Carnival. Previously conducted as a State of Origin Series between SA and Victorian greyhounds, this was changed last year to an Allstars edition due to Covid and the linking of feature races with Victoria being unavailable.**

After liaising with GRV and due to a change in the feature race programming and conditions, the linking of the Group 1 Adelaide Cup with Victorian events is not available this year. Also the Million Dollar Chase which was programmed on top of the Group 1 Adelaide Cup has been changed to an earlier timeslot giving SA's prestigious event much needed clear air on the racing calendar.

To ensure that Angle Park TAB Match Race Challenge attracts the best greyhounds possible, GRSA has kept the conditions of the series the same as last year to be "SA TAKES ON THE ALL-STARS". It will be four [4] SA greyhounds taking on the four [4] best nominated greyhounds from anywhere in Australia.

GRSA will still guarantee the winner of the TAB Match Race Challenge direct entry into the \$100,000 to the winner Group 1 Adelaide Cup Final on Friday, 7th October [bypassing the Adelaide Cup Heats].

Nominations close at 9am on Monday, 19th September with GRSA.

**Conditions of the TAB Match Race Challenge – SA TAKES ON THE ALL-STARS:**

Eligibility as to who represents South Australia or All-Stars will be based around the National Championships domiciliary clause. Greyhounds need to be trained in the State they wish to represent for 76 days out of the last 150 days prior to the date that nominations close [19th September].

The best four [4] greyhounds nominated from SA will be selected by the GRSA Grader to represent "SA's Best". The best four [4] greyhounds nominated from Interstate will be selected by the GRSA Grader to represent "the All-Stars".

The Grader will use whatever information he has available to select those greyhounds including liaising with other State bodies as required. The SA Grader's decision will be final.

Those greyhounds not selected from Interstate will be given the opportunity to solo trial or race in another event on the night. Reserves will be declared, with one [1] from SA and one [1] from Interstate [dependant on nominations], which will replace the SA or All-Stars representative as required. For example the SA reserve will only replace an SA scratching.

The Grader will rate the four [4] greyhounds from SA and the four [4] from Interstate in order from 1 to 4, with No.1 being the highest rated greyhound from each group. The head-to-head matches will be decided by the two No. 1 rated greyhounds competing against each other and then it will be 2 v 2, 3 v 3 and 4 v 4.

Prizemoney for each individual match will also reflect the seeding of greyhounds from 1 to 4, with the No. 1 rated greyhounds racing for the most prizemoney in the head-to-head races. However, the overall winner of the race will still be determined on actual race times run by each greyhound [to three decimal places].

As previously advised from the Grading Review Panel, it was agreed to change the Time Rating for first starters from 10 to 8. The programming changes have been made in OzChase and will be implemented over the weekend with the first meeting graded using the Time Ratings being Mount Gambier on Thursday, 25th August. Those nominations close at 9am on Monday, 22nd August. This will mean that the base for first starters will now be 8 on the Time Rating band. This is also the base for those greyhounds that have not yet had three lifetime starts. The below table advises the changes -

Debutant Base Time Rating of 8.00

The Grading Department will monitor the impact of the change on our race fields and how greyhounds are graded into these events. GRSA will accept the Time Ratings as being correct when formatting upcoming fields.

### 305M MASTERS AT MOUNT GAMBIER

Time band for Mount Gambier 305m Masters-

Previously GRSA had been using a policy for Masters events at Mount Gambier utilising the 277m distance, however, we had not adjusted this for the 305m until there was sufficient racing. At the most recent Grading Review Panel meeting it was decided to make the below changes and implement. The below policy will now be implemented for meetings conducted from 1st July 2022-

**305m Masters Policy for Mount Gambier** - With Mount Gambier GRC conducting one 305m Grade 5 Masters race each meeting where possible, the Grading Department determined conditions for these races using some of the conditions of normal Grade 5 Masters events, however, factoring in the restricted nature of the 305m distance. If a dog wins and runs faster than 17.75, it can still remain eligible for the next week, if the dog then wins and runs faster than 17.75 again it will be ineligible for the race and distance the following week. The dog will either run over another distance or will miss that week's race. The following week it will then be eligible. If there is no 305m Masters race the greyhound has to miss the next time that race is conducted. This only refers to the greyhounds that win.

## Nominations for Satisfactory Trials

**Recently we have had several trainers nominating online using the Qualifying Trial meeting for Satisfactory Trials.**

The online Qualifying Trial meetings are for trainers to nominate their greyhound which they wish to improve on the Order of Choice for the upcoming meeting only. Trainers, whom have a greyhound that is required to complete a Satisfactory Trial, are required to contact the offices of GRSA and provide the relevant details. By contacting the office, you will be advised of any further requirements that are needed for the Satisfactory Trial.

## TIME BANDS FOR MASTERS AT ANGLE PARK

**Since Angle Park has been redeveloped with the new distances of 342m, 530, 595m and 730m GRSA has not allocated any times for Masters events.**

There subsequently has been sufficient racing at the venue for a time standard to be applied, which was approved at the most recent Grading Review Panel meeting.

The below time ratings for Masters events will now be implemented for meetings conducted from 1st July, 2022.

It was a wonderful training performance by Emily who had three in the Final, and the punters rallied behind Angus Keeping before the jump after he had drawn nicely in the 1 box to start favourite just ahead of the Kim Johnstone trained Rushes Raw who was drawn out in box 8 like his Heat win, with Monique Keeping on the third line of betting from box 5. As the start was affected all eight greyhounds came out running as they charged to the first turn with Queen Of Scotch for Tony Rasmussen gaining a slight ascendancy from Angus Keeping with Monique Keeping moving to third as the young speedsters jostled for position. With tight racing and shifting Rushes Raw was checked back to last while Angus Keeping railed hard on the inside of Queen Of Scotch to take the lead but was quickly joined on the outside by his litter sister Monique Keeping who was challenging hard. Into the back straight and Angus and Monique had cleared out from their opposition as brother and sister laid it all on the line. Back in third was Fifty Eight for Don Turner with Melissa Keeping making ground to his inside. Finnis Redeem for Lauren Harris from her wide draw had found her way to the inside and began to make ground from a long way back. Off the back straight and it was neck and neck with Angus Keeping and Monique Keeping engaged in an absorbing dual while kennel mate Melissa Keeping had found her way to third. As they rounded the home turn Monique Keeping gradually gained the ascendancy and was able to move clear from Angus to record a wonderful win in a flying 30.66 by 1.75 lengths from Angus Keeping, claiming the \$10,000 first prize. ## Breeders Support Program – important update from July 1

At the most recent ICG meeting our local breeding numbers were discussed. After considering how many litters are currently being bred, the panel decided to make an alteration to how many Breeder Rebates will be available each financial year.

For any Breeder Rebate application lodged (at Litter Registration time) from July 1 2022 to June 30 2023, GRSA will only rebate two Litters fully and if there is a third litter, this will be at a half price rebate. If a Breeder has a fourth litter there will be no claim available. It will be up to the Breeder to determine which 2½ Litters they would like the Breeders Support Claim for in the 12 month period. Please contact Racing Manager, Shaun Mathieson at GRSA for further information.

Below are the current Breeders Support Conditions -

Details regarding the Breeders Support Program for litters registered in SA. It is crucial that GRSA receives receipts for actual and verifiable expenses relating to litters whelped for items below or else no support payment can be provided: Claims will be a Maximum of \$2,000 with FSI and Pup payment in addition.

Owned Sire Fee	Set amount of \$250

\*In the event that the 1st payment of the SA Bred Scheme is claimed as a component of the rebate, those pups will automatically be registered in the scheme with only the 2nd and 3rd payments still required.

\*\*The limit of the support as it relates to the [50%] contribution to the stud/sire fee component is equivalent to the full support value of \$2,000. The limit of the support as it relates to 'other' expenses is \$1,000. Excluded expenses include veterinary (pre-conception), rearing, breaking in or pre-training costs.\*\*

## How do I register an account to book public trials online?



## Field Trials

Existing field trials will appear in each block. To book a dog in an existing field trial simply click the Book 1/2/3 button.



If there are no available field trials of the distance and type you require then feel free to create one yourself. Simply book a slot as-per-normal and select Maiden Field or Performed Field, as shown below.



Note: booking a dog or several dogs in a field trial counts as 1 trial towards your 4 trial maximum.

## When do trial bookings commence each week?

Bookings for meetings will commence at 11.30am the working day prior to the trial session [henceforth known as “booking opening time”].

## Is there a limit to how many trials I can book online?

Yes: 4. If you wish to reserve more than 4 trials a session then you must phone the office as per normal. For example, in the screenshot below, it indicates that you can book 3 more trials using TrialBooker without phoning.

## Why am I limited to 4 trials in one block?

In short: to prevent abuse of the system. To book more phone the office after booking opening time.

**Can I cancel a trial booking online?** Yes: Press the X button and confirm.



## Will I receive a confirmation to confirm my online trial booking?

Your trials are reserved for you as soon as you press the “Book 4” button [or “Book 4” or whichever it may be]. You must then confirm the details of those trials [distance, number of dogs etc.]. There will be a summary of your bookings in each session on the Home page.

**Can I book trials for other licensees?** No—under no circumstances may you book trials for anyone other than yourself using TrialBooker. Dogs must be brought in and paid for by the person whose name they were booked under. If you wish to share a non-field trial with another trainer you must book over the phone.

## How can I book a trial if I don't have access to a computer?

You can still book trials by calling the office after booking opening time.



# WAP payment update for July 2022

Greyhound Racing SA Limited (GRSA) advises that the Wagering Activity Payment (WAP) for the month of July 2022 amounted to **\$64,000**. For reference; the WAP for the same month last year was \$242,000. The result corresponds with the predicted softening of wagering revenue as communicated in recent months in these same announcements.

## Distribution of WAP Payments between Trainers and Owners

GRSA would like to remind all participants that receive a WAP that the payment is the equivalent of prizemoney. If you are currently responsible for distributing prizemoney to another party then the same approach applies to WAP payments.

From GRSA's perspective the position in relation to third parties is reflective of OzChase records and is as follows:

- If GRSA have been notified of an ownership split [which is recorded in OzChase] then you DO NOT need to make a payment to owners for the WAP because GRSA will do this automatically; however
- If you ordinarily forward on payments to owners on your own accord, then you DO need to do the same for the WAP. Each remittance will include the name of the dog for which the WAP is being made.

### Example to help participants understand the WAP they receive

It is not uncommon for GRSA to receive requests for more information in relation to how the WAP is calculated for their particular dogs(s). The example below is provided to assist in the general understanding of the calculation.

#### Assumptions:

In this example, assume the owner/trainer received **\$1,000** in prizemoney for any/all races for the month.

In this the total prizemoney (paid to all participant) is **\$700,000**.

In this example, the owner/trainer would receive a WAP of **\$71.43**, calculated as:

$$\text{\$1,000} \div \text{\$700,000} \times \text{\$50,000} = \text{\$71.43}$$

## Changes to Track Injury Rebate Scheme

**July's Board meeting saw a significant amendment to the Track Injury Rebate Scheme (TIRS), both in terms of the scheme maximums and what the scheme covers.**

From now, the scheme applies to all events, including trials. Due to the change, I have updated the policy and the application process. The intent is to have a scheme that is as simple to access as possible but is robust enough to ensure the scheme gives every injured greyhound the best support possible. Both the policy and the new application forms are available on the GRSA website. Please read them carefully. The amended scheme has been renamed to the Track Injury Recovery Scheme (TIRS) to better reflect its evolved intent and application. Here is a summary of the major changes –

- This scheme applies to all registered persons and greyhounds, where that greyhound is injured at a track in South Australia, and the circumstances of the injury meet the eligibility criteria of the scheme.
- An event, for clarity, includes the start at a starting box to the end at the catching pen [or finish on lure].
- All races and trials are potentially covered.
- GRSA will now cover 100% of the reasonable treatment costs for the surgical procedure for the eligible injury up to a maximum GRSA payment of \$3,500.00; and, \$50.00 per week towards the recovery [rehabilitation] of the greyhound for the duration of the recovery period prescribed by the veterinarian, up to a maximum of six [6] weeks [\$300.00]; or, 100% of the reasonable treatment costs for the off-track treatment for the eligible injury up to a maximum GRSA payment of \$200.00.
- The eligible injuries are bone fractures that are described in Schedule 1 of the policy as injuries that are covered by the scheme, that are treated by off-track treatment, or a surgical procedure performed by a veterinarian; bone dislocations that are treated by a surgical procedure performed by a veterinarian; tendon injuries that are treated by a surgical procedure performed by a veterinarian; and, ligament injuries that are treated by a surgical procedure performed by a veterinarian.
- Where a greyhound is reasonably suspected of suffering an eligible injury, the applicant [and regardless of whether the applicant makes a claim under the scheme or not] must provide immediate and appropriate first aid treatment to the greyhound. This includes any person or greyhound not usually resident in this State.
- Following the surgical procedure or off-track treatment, the applicant [and regardless of whether the applicant makes a claim under the scheme or not] is responsible for providing [or making arrangements to provide for] care for the greyhound and for ensuring that the greyhound

recovers in accordance with the advice of the veterinarian that performed the surgical procedure or off-track treatment.

- If the greyhound does not return to racing, it must be retired by the applicant in accordance with L130 of Local Rules and R22 or R23 of the GAR and any relevant policy or procedure on retirement or rehoming of GRSA.
- Following the completion of the recovery period specified in 4.5(c), the owner may enter the greyhound into the Greyhound Adoption Program SA [GAP SA] and GAP SA will grant the greyhound priority entry into the program.
- A euthanasia procedure for a greyhound must only be performed without prior notice to GRSA if the greyhound, in the opinion of the veterinarian, is suffering from an incurable condition or the injury causes significant pain or discomfort, or a marked reduction in quality of life and must be declared to GRSA by the veterinarian and notified by the applicant [and regardless of whether the applicant makes a claim under the scheme or not] to GRSA pursuant to R22[1](b) of the GAR.
- For any proposed euthanasia procedure for any other reason, it is deemed a euthanasia procedure conducted pursuant to L130 of the Local Rules, and GRSA must be notified, by the applicant [and regardless of whether the applicant makes a claim under the scheme or not] of the proposed procedure no less than 10 working days before the intended euthanasia procedure [unless a lesser period is authorised by GRSA and, in any event, before the euthanasia procedure is performed]. Failure to notify GRSA in accordance with 4.6(h) or 4.6(i) is deemed a breach of R156(w) of the GAR; or L5 or L130 of the Local Rules; or all of them.
- The euthanasia requirements apply to all registered persons and greyhounds that suffer any injury at a race or a trial in this State, and treated, regardless of the jurisdiction the person or the greyhound is registered in or usually resides in.
- Application forms can be downloaded from the GRSA website.
- Applications must be submitted to GRSA no later than 2 months from the date of injury. Late applications will not be considered unless in exceptional circumstances.
- If an applicant intends to make an application and cannot do so within 5 days of the injury, they must notify GRSA within 5 days of the potential, eligible injury. The notification must contain sufficient particulars to enable GRSA to identify the greyhound and the race or trial, namely the name of the greyhound; microchip; date of injury; track; race or trial number; veterinarian, official or club manager on duty.
- Where the applicant incurs an additional cost for a subsequent surgical procedure for the claimed, eligible injury, that cost may be considered by GRSA, upon further written application to GRSA in the prescribed form; but, in any event, the total reimbursement cannot exceed the scheme maximum for all, combined, surgical procedures for the eligible injury.

## NOTES OF INDUSTRY CONSULTATIVE GROUP (ICG) MEETING

HELD IN THE BOARDROOM OF GRSA, 55 CARDIGAN STREET, ANGLE PARK ON FRIDAY 17 JUNE 2022 AT 10.00AM

The meeting commenced at 10.04am.

### 1 APOLOGIES

Jason Newman, David Lewis, Ray Fewings

The Chairman welcomed Bodelle Francis to her first ICG meeting. He noted the current, somewhat interesting, climate. He advised the Board had gone through budget process and noted the conservative approach taken.

### 2 NOTES FROM PREVIOUS MEETING

The Minutes from the ICG Meeting held on Friday 18 March, 2022 were noted as a true and correct record.

### 3 BUSINESS ARISING FROM PREVIOUS MEETING

#### 3.1 Updates from Minutes

##### Pannus

The IM provided an update. He advised that all applications would be considered.

##### TIRS

The IM provided an update and advised that a paper will be put to July Board meeting for review of TIRS with potential to include for trials. Panel members appreciated the consideration given to trial injuries being included. They request that GAP ensured priority entry in relation to TIRS. Members questioned use of on course cameras for trial injuries. The COS noted issues with introduction for trials however also suggested there were potential solutions to these issues. The Chairman noted the Board will consider at upcoming Board meeting.

##### Trackside Filming

The MM provided an update, noting various options investigated. It was recommended pre-race filming be undertaken by trainers or third party (not handler) for owners, tracks allow for vision to be taken relatively closely by these people. It was advised that Marketing will capture vision of high-profile races and dogs for Facebook and the like.

##### Greyhound Auction

The RM detailed options currently being considered. Members provided further information regarding the proposed format. Panel members suggested increasing timeframe to a three-monthly stagger. The panel took these comments on board and will consider. The Chairman noted his request to continue moving forward with proposal.

#### 3.2 Sustainable Breeding Levels

The RM provided background to current breeding levels and sought feedback from the group. The panel suggested there was a natural limit due to rearing opportunities. It was suggested a review be undertaken in 3-6 months' time. Members highlighted concern with the issue and noted their change in structure and that they will no longer accept interstate dogs. The Chairman requested item be placed on the GA CEO meeting agenda as well as revisiting regularly with this group and the Board. Members suggested if breeder bred more than three litters per year, a rebate should not apply. Members questioned whether rebate restrictions should apply around premises not per registered person. Management committed to considering and investigating this issue. The Chairman noted the importance to ensure quality breeding, The RM reinforced this and noted the quality of SA dogs performing on an interstate level. The COS noted the breeding review panel analyse submissions to ensure quality.

Action: Management to review breeding bonuses where it applies to multiple registered breeders/partnerships on one single premises.

Action: CEO to ensure breeding restrictions is included on GA CEO's agenda.

#### 3.3 Limited Monthly Starts

The RM provided background to item noting this item was intended to be included on national GA agenda which has been deferred. Management will provide a further update at the next meeting.

### 4 AGENDA ITEMS

#### 4.1 Digital Transformation and Broadcast Enhancement [Isolynx]

The CEO provided an update in regard to the Isolynx project and noted intent to obtain data from Angle Park in August. The Chairman noted the Board's and Management's excitement being the only state with technology on all tracks. He further noted the benefits of the technology in regard to wagering and animal welfare advantages. Members noted the lack of information available on results sheet. The COS suggested the issue was with information coming from different sources and the difficulties combining this.

#### 4.2 Syndication

Members provided an update on the current AGRC syndicate noting syndicate dog Weblec Rebel had been successfully rehomed. The IM suggested this should be promoted as a good news story.

Action: Marketing to produce story on AGRC syndicate dog Weblec Rebel.

The COO noted new GRV appointment of Stuart Laing, should this role be replaced, this would be the person to progress syndication.

#### 4.3 TAB Digital On Course

The COO provided an update and noted options

currently in discussion with Tabcorp. He noted the potential to have terminals available in Chasers. Discussion around percentage of participants/punters utilising digital technology.

## 5. OTHER BUSINESS

### 5.1 Prizemoney Submission

The Chairman requested feedback from the group regarding a submission in relation to the additional costs being borne by trainers travelling to/from Mount Gambier to Angle Park. The COO noted concerns around perceptions of fairness amongst participants from other regions. The RM noted the incentives available to Mt Gambier participants. Members suggested it was not encouraging country trainers to come to city Thursday night, which they saw as a privilege. Members suggested there needed to be greater fairness across the board. The Chairman suggested discussion around appearance fee increase noting increase to this would result in decrease in another area. The CEO questioned whether there were any fees or subsidies that GRSA provided to participants that they could forgo. The RM suggested reintroducing breeding fees and naming fees and removing DNA subsidies. Members suggested savings could be made by restricting interstate movements. Management committed to investigating and considering potential options and revisiting with the group to provide findings. The general consensus of the group was that an increase to unplaced money would be well received by a greater range of participants.

### 5.2 Marketing Update

The Chairman noted the recent activities from the marketing department, highlighting the 50th Anniversary event. The CEO noted the very positive comments received from the Chair of GA recently.

The MM noted the intent to present the marketing plan to the group at the next meeting following its finalisation and approval. He provided an update on recent activities. The CEO noted the importance for participants to provide the "good news stories" to marketing when they happen to ensure they have the content. Members suggested the Dogcast could be run more frequently with a greater number of interviews with trainers, owners and breeders. It was further suggested Marketing review both Greyhound Gossip [WA] and Greyhound Girl [NSW] for content. Members noted they were receiving notification of posts on GRSA Facebook page following the event. The CEO suggested boosting these posts to see if a difference is noticeable.

### 5.3 Thursday Trials at Murray Bridge

Some members noted their disappointment with removing Thursday trials at Murray Bridge and the difficulties this has caused. The COS noted it was raised at ICG and referred to MBGRC and agreed to with no objections received.

Further discussion around kennelhouse temperatures. Members to provide COS with interstate information for his reference.

### 5.4 Inquiries Delays

Members questioned the current delays experienced with inquiry hearings and if there were plans to expedite these. The IM noted most recent IHP hearings needed to be cancelled due to a panel member having Covid. It was advised another two hearings were scheduled and expected to clear the backlog. He further provided details of the difference in procedure for varying offences.

The IM suggested he could provide information on the inquiry process and reasons for recent delays in hearings in Kennel Capers next month.

Action: The Chairman and CEO to address current issues with delays in inquiry hearings.

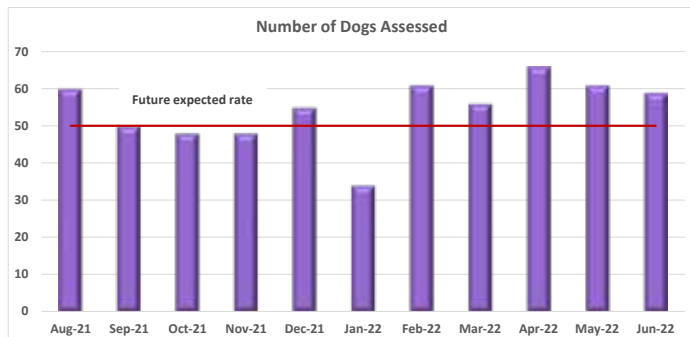

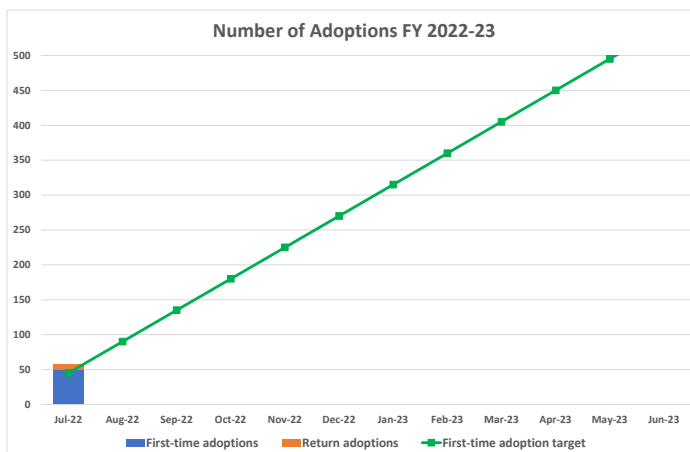
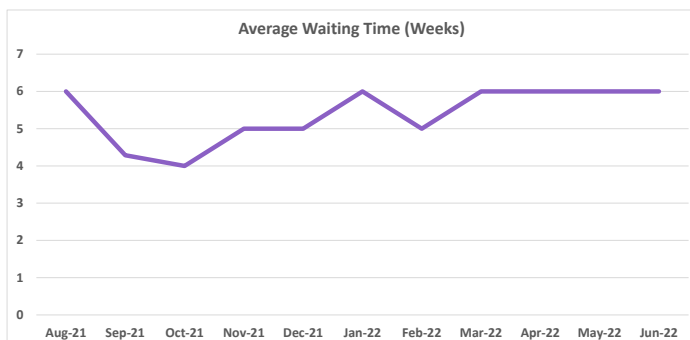
## Latest updates from GAP

# TRIALS

## QUALIFYING AND SATISFACTORY TRIALS

Angle Park qualifying and satisfactory trials are held every Tuesday night between 6.50pm and 7.15pm. Qualifying will be for the following Monday meeting (drawn Thursday). Nominations close at 12.30pm on the Tuesday (for online nominations 11.59pm Monday).

Gawler qualifying and satisfactory trials are held every Thursday morning from 7am. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm Wednesday the day prior.

Murray Bridge qualifying and satisfactory trials are held every Wednesday night at approximately 5.15pm (between the end of the straight track trials and the beginning of the one turn track trials). Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm on Wednesday (for online nominations 11.50pm Tuesday).

## ANGLE PARK

### SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

### BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number or alternatively logon to trialbooker.com, create an account and book your own trials.

## POLICY FOR TRIALLING AT ANGLE PARK, GAWLER AND MURRAY BRIDGE BEFORE THE RACE MEETING

### Policy Background

This policy is to detail the procedure for trainers seeking greyhounds to trial before race meetings. This policy is effective from 2 May 2019.

### Race Meeting Trial Policy

This policy is in place for the following race meetings:

Angle Park Monday, Gawler Wednesday and Sunday, Murray Bridge Tuesday and Friday.

Two fields from the boxes with a maximum of four (4) greyhounds. Trials may be conducted at any time during the race meeting from immediately after kenneling until after the last race, at Stewards' discretion.

The following lists the order in which greyhounds will be selected in the event if more than eight (8) greyhounds are nominated:

1. Reserves at the meeting that do not obtain a start
2. Trainers that have greyhounds engaged and are located more than 100km in distance from the track
3. Satisfactory trials

### Procedure/criteria

1. For Angle Park Monday night, the trainer is to contact GRSA between 9am and 10am on Monday to nominate. Should the Monday be a public holiday bookings are to be made between 8am and 9am on the scratching number.
2. For Murray Bridge Tuesday & Friday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times.
3. For Gawler Wednesday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Gawler Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
4. Other than reserve greyhounds, trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
5. Stewards will allocate the box for the greyhound.
6. Trials will be 515m, 530m & 531m in distance as first preference. Other distances considered depending on nominations.
7. Greyhounds currently under suspension are ineligible to trial unless they are undertaking a satisfactory trial to be cleared.
8. Greyhound registration cards must be produced at kennelling time.
9. Trainers with other greyhounds engaged can utilise the extra kennel space until such time they are ready to leave. Trainers with no other greyhounds engaged will be permitted to leave with Stewards permission.
10. In the case of race at Murray Bridge, trials will only be available on the track that is prepared to race that day i.e. Friday meeting on the u-shaped track, trials will be on the u-shaped track only.

Please note: If there are 12 races at Angle Park, Gawler or Murray Bridge there will be NO trials.

The Angle Park Vet Clinic and/or swab kennels cannot be used to accommodate any additional greyhounds due to operational requirements of the Clinic and Stewards.

It is vital that trainers nominate to trial at these race meetings. If you are unable to nominate at these times, please contact GRSA as soon as possible as permission may be given at GRSA's discretion to accept bookings outside these times.

### Exceptions to this policy

Thursday nights are kept available for interstate greyhounds to solo trial in a lead-up to SA Group races as well as local greyhound's trialling for Group racing interstate.

Upon request, local greyhounds will be allowed to solo trial in a lead-up to a feature race and they will take one of the eight (8) kennels available for trialling greyhounds ahead of the policy and sit separate to the four (4) dog trials. Races considered to be a feature are: Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals and any interstate Group race

Local greyhounds will be permitted to trial on a race night, where they are in preparation for a feature event, nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy. If a greyhound qualifies for a feature final and requires a trial in between, this will be conducted as a solo trial and will sit separately to the four (4) dog trials.

## MOUNT GAMBIER SATISFACTORY TRIALS

Mt Gambier hold trials on Wednesday and Saturday mornings with Satisfactory trials ONLY being conducted on Wednesdays and need to be booked with Barry Shephard from the Club on 0419 824 512 no later than 12pm the day before.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shephard.

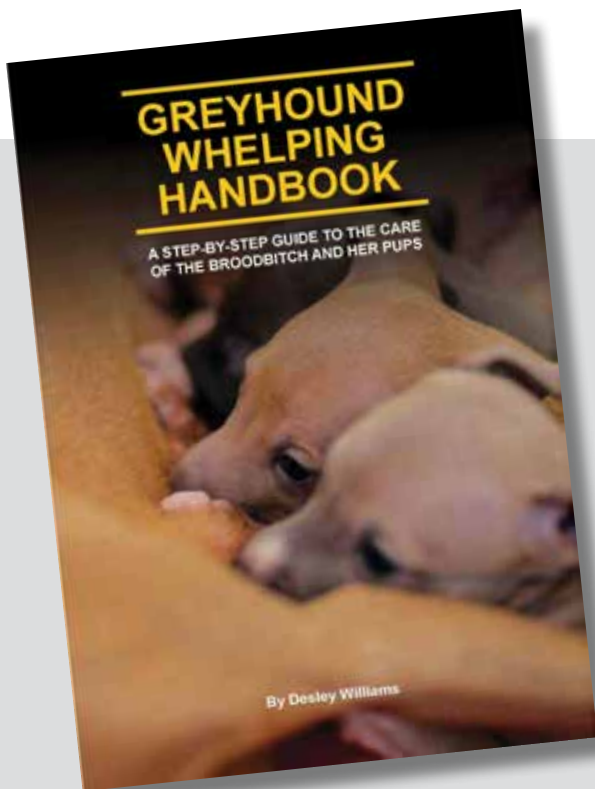
