Victa Haydn claims 2022 Stayers Cup

ANGLE PARK

The Final of the Bayroad Queen Stayers Cup was run at Angle Park on Thursday, 23rd June with trainer Tony Rasmussen securing another feature final when Victa Haydn was able to take out the prestigious distance event.

The locally bred son of Fernando Bale and Victa Victoria was one of the favourites after his good performance in the Heats when he ran second to Beck's Monelli who was also strong in the market for trainer Tim Aloisi. Just behind on the third line of betting was the other Heat winner, Lashes Monelli for Tim Aloisi who had to overcome box 8 in the Final.

As the start was affected in the back straight, Run Like Jess for Adrien Chevalier quickly pounced on the early lead from box 3, in hot pursuit was Victa Haydn who came across into second from box 6 and tucked just in behind was Beck's Monelli from box 4. Lashes Monelli had to go all the way back to last to find the rails with the whole field in front of her as they left the back straight on the first occasion. Into the front straight and the lead division broke away from the main pack with Run Like Jess stretching out nicely followed by Victa Haydn and Beck's Monelli, a good gap back to New Year Years for Clint Trengove and Contour for Adrien Chevalier while Lashes Monelli began to pick off her rivals. Out of the front straight and Victa Haydn moved up strongly to challenge Run Like Jess for the lead with Beck's Monelli in a close stalking position back in third. It looked a race in three as they entered the back straight with New Year Tears and Lashes Monelli looking like battling out fourth. Victa Haydn quickly raced to the front and opened up a gap back to Beck's Monelli with Run Like Jess holding onto third spot. Off the back straight and it was now down to a race in two with Victa Haydn going strongly in the lead and Beck's Monelli trying desperately to close the gap. Turning for home and Victa Haydn was holding Beck's Monelli and in the run to the line and ran out a strong 730m journey to take the Bayroad Queen by over 2 lengths in 42.83 from Beck's Monelli with a further 7 lengths back to Run Like Jess and Lashes Monelli who charged into fourth.









Max produces the goods at Gawler

GAWLER

Talented youngster Springvale Max claimed another feature final for trainer Gavin Harris winning the Gawler Produce Final with an impressive 30.65 second run at the Gawler track on June 26.

Springvale Max was only fairly away with He's All Purpose for Tim Richards and Spring Phoebe for Ben Rawlings setting the early pace as expected. On the back straight, Springvale Max had somehow managed to find the rail from box 5 and was in a fantastic spot to stalk the early leaders. By the final bend Springvale Max showed terrific pace to boot up and go past both He's All Purpose and Spring Phoebe and power on to another impressive victory for his trainer.

He's All Purpose and Spring Phoebe ran on well to fill in the placings after setting the early pace but they were unable to hold out Springvale Max who proved too strong.

Max has been in a rich vein of form for trainer Gavin Harris recently winning the Group 3 Howard Ashton in May at Angle Park and now boasts a career record of 21 wins from 42 starts for over \$75,000 in prizemoney.

Victa Grosso is June's GOTM

Greyhound of the Month for June was Victa Grosso for trainer Tony Rasmussen, highlighted by his fantastic win in the time honoured Shane McQueen Final over the middle distance at headquarters, where he dominated a high class field in early June.

The son of Fernando Bale and Victa Victoria had five starts for the month with four wins, showing his potential over the middle distance. He started the month off with that breathtaking win in the Shane McQueen Final where he won by over 4 lengths in a sizzling 34.06 for the 595m. He then had two starts at Gawler over the 643m where he won on both occasions by 5.25 and 8.75 lengths, in the brilliant time of 37.19 and 37.25 respectively. Victoria was next on the agenda in a lead up to feature races, so Rasmussen headed to Sandown for a 595m event on a Sunday where Victa Grosso impressed with a 34.45 win over the 595m in winning by 2.24 lengths. His last run of the month



was an unlucky 5th in a Heat of the Group 2 McKenna Memorial also at Sandown, where he lost no admirers. At the end of the month Victa Grosso's record stood at 63 starts for 25 wins and 25 placings and earnings around \$126,000.

Mallee Magic makes it 2-in-a-row

For the second month in a row Mallee Magic was voted the Run of the Month but this time for June after his amazing performance to win from an almost unwinnable position at Angle Park on Monday, 20th June in a Mixed 4/5 event over the 530m.

The star chaser for trainer Tony Rasmussen was returning from a 6 week break and started a very short priced favourite, and after he began well from box 5 and landed third, nice and handy out of the front straight everything was going to plan. However, he found a bit of trouble leaving the front straight with a few bumps and drifted back to midfield losing momentum. Into the back straight he balanced up and looked to get to the outside but was spotting the leaders about 6 lengths with plenty to do. Leaving the back straight and prior to the home straight he made good ground to look a big danger turning



for home. Into the front straight and even though Mallee Magic was pushed that wide he was shaking hands with Kurt, he was able to power home over the top of his rivals for a classy win by almost 2 lengths running away. He ran 30.82 with splits of 5.33 and 18.09 and it was a dominant and impressive performance.

SATURDAY TO THURSDAY NIGHT FINALS AT ANGLE PARK

Once a fortnight GRSA will run Heats on the Saturday morning meeting at Angle Park, where they will be either (1-4 wins or 5+ wins) over the 530m and will be Non Penalty events. The Final will be conducted as Race 1 on the Thursday night.

Trainers should be mindful that if you have a greyhound in a Heat and it qualifies for the Final that the greyhound will be ineligible to compete in the Final if it is engaged to race the day prior [Wednesday].

The next lot of Heats will be on Saturday, 23rd July for 5+ wins with the Final on Thursday, 28th July.

• Nominations for the Heats close with GRSA at 9am on Wednesday, 20th July.

2022 NATIONAL CHAMPIONSHIPS IN NEW SOUTH WALES

The GCA National Championships are just around the corner. The National Finals this year will be held at Wentworth Park in NSW and are to be conducted on Saturday, 29th August.

Both the National Sprint and National Distance Finals will carry prizemoney of \$75,000 to the winner.

The State series' for SA will be held at Angle Park on Thursday, 4th August for the Sprint Heats over 530m with the State Final of the Sprint and one-off Final over 730m of the Distance on the 11th August.

In an effort to support this series ALL States will be conducting their Finals on the same night to be run within a two hour period.

 Nominations this year will close at the normal time with GRSA which will be at 9am on Monday, 1st August

A reminder to all trainers of the clause which requires a greyhound to have been domiciled in South Australia for a period of not less than 76 days out of the 150 days immediately prior to the nomination closing date to be eligible to represent SA, which going back is on Wednesday, 18th May 2022. If unsure of a greyhound's status, please contact the GRSA grading staff.

NATIONAL STRAIGHT TRACK CHAMPIONSHIPS ALSO IN NSW

The National Straight Track Championship this year will be held at Richmond on Saturday morning, 29th August –with the winner receiving \$25,000 so all the National Finals will be held on the same day.

This year SA will have two SA dogs represent the State in the series with QLD, NSW, VIC and SA challenging for the title.

So the Straight Track series aligns with the circle and the other states our heats will be held at Murray Bridge on Tuesday, 2nd August for the heats with our final on Tuesday, 9th August. Prizemoney for the SA Straight track Final will be elevated to \$10,000 to the winner and align with the other three states. It is important that trainers are aware that these series for the circle and straight track are run at the same time so they need to be aware when nominating and the qualifying criteria.

• Nominations this year will close at the normal time with GRSA which will be at 9am on Thursday, 28th July

2022 NORTH V SOUTH CHALLENGE IN AUGUST THIS YEAR

After some consultation with the Murray Bridge and Gawler Clubs, GRSA has formulated a race series that will see the North V South Challenge being conducted on an annual basis creating plenty of friendly banter amongst industry depending on where you live.

The North V South Challenge will have a 530m Final worth \$8,000 and a 395m Final worth \$4,000, to be run at Murray Bridge in August and then on rotation with Gawler over the 531m/400m every other year in July.

All conditions regarding eligibility for greyhounds and trainers are included on the following page for what will hopefully be an exciting series engaging both venues and participant groups.

2022 GAWLER CLASSIC HEATS ON AUGUST 17

The Gawler Classic for 2022 over 400m will have \$1,600 Heats on Wednesday, 17th August with the \$3,300 Final on Tuesday, 23rd August for greyhounds paid up for Classic 2022.

LOW GRADE FEATURE SERIES AT ANGLE PARK

2022 NORTH V SOUTH CHALLENGE

Below are details of how the North V South Challenge will work for a 530m Final worth \$8,000 and a 395m Final worth \$4,000, to be run at Murray Bridge in August and then on rotation with Gawler over the 531m/400m every other year in July.

The inaugural running will have one Heat for Gawler greyhounds and one Heat for Murray Bridge greyhounds at Murray Bridge on Sunday, 14th August, with the 530m Heats worth \$2,125 each and the 395m Heats worth \$1,855 for round 1. Round 2 will be at Gawler with the same greyhounds competing in one Heat for the Gawler greyhounds and one Heat for Murray Bridge greyhounds on Sunday, 21st August, with the 531m Heats worth \$2,125 and the 400m Heats worth \$1,855. Each Heat will consist of a maximum of 8 dogs plus reserves with the Finals run at Murray Bridge on Sunday, 28th August as an 8 dog Final plus reserves. Greyhounds will receive points through both rounds 1 and 2 to establish the 4 from each Club who will progress through to the Final.

Conditions:

- To be eligible for either Murray Bridge or Gawler trainers will be classified on their Post Code as to which Club they can represent (see table below. Please contact GRSA if your postal address is not recognised below).
- The 530m/531m event is open to all South Australian greyhounds that have not won 4 or more CITY A Grade 5 or higher events at time of nomination for round 1 (730m excluded). Also, they cannot have won a Metro Grade 5 or higher interstate in the last 6 months. This will draw from a different pool of greyhounds with the National Sprint Final conducted in the same week as Round 1.
- The 395m/400m event will be for open greyhounds with no specific restrictions on the races the greyhound has won.
- Winner of each event takes a penalty including the Final. However, if a greyhound has won round 1 and round 2 they will only take 1 penalty.
- The greyhounds must not have any offences precluding them from competing at Murray Bridge or Gawler or they will be ineligible for the rounds.
- Graders' discretion will be used to determine the best nominated.
- The greyhound must be SA trained.

o A South Australian trained greyhound is defined as one that is in SA for a period of not less than 3 out of the 6 months immediately prior to the time of nomination.

- The greyhound must have started at least 2 times in the last 12 months at the track over any distance it is attempting to represent. (Gawler Prov 1 and Murray Bridge One Turn Prov 1). This only relates to the track they are representing.
- Greyhounds must compete in both rounds 1 and 2 to be eligible for the Final (reserves are exempt)

- Points will be allocated for each round (1st 12 points, 2nd 9, 3rd 7, 4th 5, 5th 4, 6th 3, 7th 3, 8th 3. Reserves that do not get a start in round 1 will be allocated 3 points, these greyhounds will be the same reserves for round 2.
- If greyhounds have the same amount of points the greyhound with the best finish in either round 1 or 2 will progress, however, if the placings are the same then this will be by ballot.
- If a Heat is not conducted in round 1 then those greyhounds nominated will have preference for round 2. If no Heats are conducted in round 1 or 2 then the grader will select the 4 greyhounds at his discretion to represent a Club from nominations. If a race is abandoned in round 1 then this event will remain the same for round 2 including the box draw.
- GRSA reserves right to alter any conditions as necessary.
- The two reserves for the Final will be determined by points initially [as above] to select which reserve from either Club is first or second reserve, however, if identical then by a ballot. The sixth greyhounds if required will be by points or then by ballot if required. Should a greyhound be withdrawn prior to the final fields, the next placed greyhound from that Club's Heat will be selected.
- Once a greyhound has been selected or qualified for a Heat, it is not eligible to compete for the other Club in this series.

KINGS AND QUEENS FEATURE HEATS IN AUGUST

Again this year GRSA will conduct the Kings and Queens Feature series with \$5,150 Heats on Thursday, 25th August and a \$7,500 Final on Thursday, 1st September in continued support of any greyhound affected by the change to the GCA Age Restricted Classics change quite a number of years ago.

The eligibility for this series is for dogs and bitches whelped between 1st March 2020 and 31st May 2020.

Performed Maidens are eligible (raced or qualy trialled).

It will be dependent upon nominations, however, we would like to run a dogs Heat and a bitches Heat separately with greyhounds qualifying into the Final. If there are not sufficient nominations for either sex then these Heats may be mixed into a couple of mixed Heats. Special conditions apply, however, these races will be non-penalty.

 Nominations close Monday, 22nd August at 9.00am with GRSA.

OAKS AND DERBY ELIGIBILITY IN 2022

The Group 3 SA Oaks and SA Derby to be run in September this year will be for greyhounds whelped on or after 1st June, 2020 (27 months).

The Heats of the Oaks will be run on the same night as the Derby again this year with Heats on Thursday, 8th September and the Group 3 Finals on Thursday, 15th September.

Since Angle Park has been redeveloped with the new distances of 342m, 530, 595m and 730m GRSA has not allocated any times for Masters events.

There subsequently has been sufficient racing at the venue for a time standard to be applied, which was approved at the most recent Grading Review Panel meeting.

The below time ratings for Masters events will now be implemented for meetings conducted from 1st July, 2022.

305M MASTERS AT MOUNT GAMBIER

Time band for Mount Gambier 305m Masters-

Previously GRSA had been using a policy for Masters events at Mount Gambier utilising the 277m distance, however, we had not adjusted this for the 305m until there was sufficient racing. At the most recent Grading Review Panel meeting it was decided to make the below changes and implement. The below policy will now be implemented for meetings conducted from 1st July 2022-

305m Masters Policy for Mount Gambier – With Mount Gambier GRC conducting one 305m Grade 5 Masters race each meeting where possible, the Grading Department determined conditions for these races using some of the conditions of normal Grade 5 Masters events, however, factoring in the restricted nature of the 305m distance. If a dog wins and runs faster than 17.75, it can still remain eligible for the next week, if the dog then wins and runs faster than 17.75 again it will be ineligible for the race and distance the following week. The dog will either run over another distance or will miss that week's race. The following week it will then be eligible. If there is no 305m Masters race the greyhound has to miss the next time that race is conducted. This only refers to the greyhounds that win.

TIME RATINGS FOR FIRST STARTERS

As previously advised, it is the intent for the Time Rating for first starters to be varied from 10 to 8 after the most recent Grading Review Panel meeting.

There needs to be a programming change in OzChase and at present this has not been finalised. GRSA will advise an implementation date once the changes are ready to take effect.

MOUNT GAMBIER SATISFACTORY AND NORMAL TRIALS – TIMING FOR BOOKINGS

Trainers are reminded of their requirements when booking Satisfactory Trials and normal trials at Mount Gambier. Mount Gambier hold trials on Wednesday and Saturday mornings with Satisfactory trials ONLY being conducted on Wednesdays which need to be booked with Barry Shepheard from the Club on 0419 824 512 no later than 12pm the day before.

Normal trial bookings need to be done by 4pm the day before for both Wednesday and Saturday. They will not be accepted after this time. Effective immediately.

GRSA is working with the Club regarding an online trial booking system which would help the management of these normal trials.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shepheard.

TRIAL DAYS FOR GAWLER AND MURRAY BRIDGE

Gawler trial on the Monday morning and every Thursday morning. There will be no rotation due to racing.

Murray Bridge will trial on Monday morning and do not trial on Thursday morning for the Straight Track. These are on Wednesday night with the One Turn trial session. During non daylight saving Straight track trials will start at 4.30pm with the One Turn at 5.30pm. During Daylight saving the Straight track will start at 5.30pm with the One Turn 6.30pm.

Any changes to this will be advised to industry via text message and social media.

Breeders Support Program – important update from July 1

At the most recent ICG meeting our local breeding numbers were discussed. After considering how many litters are currently being bred, the panel decided to make an alteration to how many Breeder Rebates will be available each financial year.

For any Breeder Rebate application lodged (at Litter Registration time) from July 1 2022 to June 30 2023, GRSA will only rebate two Litters fully and if there is a third litter, this will be at a half price rebate. If a Breeder has a fourth litter there will be no claim available. It will be up to the Breeder to determine which 2½ Litters they would like the Breeders Support Claim for in the 12 month period. Please contact Racing Manager, Shaun Mathieson at GRSA for further information.

Below are the current Breeders Support Conditions -

Details regarding the Breeders Support Program for litters registered in SA. It is crucial that GRSA receives receipts for actual and verifiable expenses relating to litters whelped for items below or else no support payment can be provided: Claims will be a Maximum of \$2,000 with FSI and Pup payment in addition.

Stud/Sire Fee (Commercial)

50%, up to \$2,000 rebate (receipts required)

*In the event that the 1st payment of the SA Bred Scheme is claimed as a component of the rebate, those pups will automatically be registered in the scheme with only the 2nd and 3rd payments still required.

The limit of the support as it relates to the (50%) contribution to the stud/sire fee component is equivalent to the full support value of \$2,000. The limit of the support as it relates to 'other' expenses is \$1,000. Excluded expenses include veterinary (preconception), rearing, breaking in or pre-training costs.

NOMINATIONS FOR SATISFACTORY TRIALS

Recently we have had several trainers nominating online using the Qualifying Trial meeting for Satisfactory Trials.

The online Qualifying Trial meetings are for trainers to nominate their greyhound which they wish to improve on the Order of Choice for the upcoming meeting only. Trainers, whom have a greyhound that is required to complete a Satisfactory Trial, are required to contact the offices of GRSA and provide the relevant details. By contacting the office, you will be advised of any further requirements that are needed for the Satisfactory Trial.

QUALIFYING AND SATISFACTORY TRIALS FOR MURRAY BRIDGE

Murray Bridge qualifying and satisfactory trials are held every Wednesday night at approximately 5.15pm (between the end of the straight track trials and the beginning of the one turn track trials). Qualifying will be for the following Friday/Sunday meeting (drawn the following week).

Nominations close at 12.30pm on Wednesday (for online nominations 11.50pm Tuesday).

SATISFACTORY AND QUALIFYING TRIAL TIMES FOR ANGLE PARK

After sufficient racing has been completed on the redeveloped Angle Park track, times have now been allocated for the new distances for Satisfactory trails and Qualifying trials. Effective immediately.

342m - 20.50; 530m - 31.70; 595m - 35.70; 730m - 45.00

COMMENTS ON NOMINATIONS MARKED "ONLY"

A few years ago the Grading Review Panel agreed that some trainers were using the comments box to influence the grading of fields in particular Grade 5 Only for all their greyhounds.

The panel previously resolved that "Only" would be disregarded over all distances and the grading left to the Grader. [Masters Only or Juvenile Only will be accepted as this is for a specific type of race].

If trainers put "Only or no start or leave me out" then the grader will grade as normal and if a greyhound would be graded into a mixed event based on race wins then he will leave them out based on the trainers request. The more information provided to the Grader allows for him to accommodate those requests.

WINNING GRADE 6 RACES IN ORDER

GRSA reminds trainers to win their grade 6 events in order at a specific venue.

For the venues that allow two Grade 6 wins trainers need to win a Grade 6 over one distance and then a Grade 6 over the other distance. If a greyhound wins a Grade 6 and then a Grade 5 then they will lose their Grade 6 over the other distance at that venue.

RE-GRADING FOR ALL TRACKS AND DISTANCES

Re-grading will occur for all tracks and distances for Grade 3 or higher greyhounds.

A trainer can apply for a re-grade after two unsuccessful nominations over the corresponding distance. If having met this criteria the responsibility is on the trainer to apply for a re-grade prior to the close of nominations. Only one distance will be considered for a re-grade per meeting.

DAISH IRRIGATION & FODDER VOUCHERS FOR MURRAY BRIDGE

The Murray Bridge GRC has been able to secure some \$100 vouchers from their sponsor Daish Irrigation & Fodder to be used on heat and final series' over the next 12 months.

In the All Tracks calendar these races will be highlighted which is a terrific initiative of the Murray Bridge GRC.

When do trial bookings commence each week?

Bookings for meetings will commence at 11.30am the working day prior to the trial session (henceforth known as "booking opening time").

Is there a limit to how many trials I can book online?

Yes: 4. If you wish to reserve more than 4 trials a session then you must phone the office as per normal. For example, in the screenshot below, it indicates that you can book 3 more trials using TrialBooker without phoning.

Why am I limited to 4 trials in one block?

In short: to prevent abuse of the system. To book more phone the office after booking opening time.

Can I cancel a trial booking online? Yes: Press the X button and confirm



Will I receive a confirmation to confirm my online trial booking?

Your trials are reserved for you as soon as you press the "Book 4" button (or "Book 4" or whichever it may be). You must then confirm the details of those trials (distance, number of dogs etc.). There will be a summary of your bookings in each session on the Home page.

Can I book trials for other licensees? No—under no circumstances may you book trials for anyone other than yourself using TrialBooker. Dogs must be brought in and paid for by the person whose name they were booked under. If you wish to share a non-field trial with another trainer you must book over the phone.

How can I book a trial if I don't have access to a computer?


You can still book trials by calling the office after booking opening time.

WAP payment update for June 2022

Greyhound Racing SA Limited (GRSA) advises participants that the Wagering Activity Payment (WAP) for the month of June 2022 amounted to \$145,000, taking total payments for the year past \$2.1 million.

GRSA is aware there was also an expectation of an Industry Performance Reward Payment (IPRP) being made. Unfortunately, there will IPRP is being paid because wagering revenue over the second half of the financial year was much lower than the first half. While this is likely to be a disappointing outcome for many, the IPRP was never a guarantee and was always predicated on recent performance. In any case, participants should be aware that GRSA will pay-out 53% of net wagering revenue in FY22.

For some time GRSA has expressed a view that wagering revenue was showing signs of softening. The macro-economic factors of significant inflation and the biggest increase to interest rates in twenty years is almost certainly reducing the disposable incomes of the wagering public. That in turn is flowing through to reduced wagering revenue. Race field fees from corporate bookmakers account for 80% of GRSA's wagering revenue and as can be seen from the chart below, the uplift in revenue that occurred at the beginning of FY22 has now fallen to below FY21 levels [June 2022 compared to June 2021].



The GRSA budget for FY23 anticipates a reduction in corporate revenue of \$2.4 million [from \$22.8 million to \$20.4 million] in this new financial year (see the dashed line in the chart above). If GRSA's prediction is right, then WAP's during FY23 will be very modest and there will be a number of months where no WAP is payable. Importantly, if revenue exceeds forecasts, then the WAP model (which guarantees a minimum payment of 50% of net wagering revenue) operates in a way that pays out any upside to participants as soon as practically possible.

Distribution of WAP Payments between Trainers and Owners

GRSA would like to remind all participants that receive a WAP that the payment is the equivalent of prizemoney. If you are currently responsible for distributing prizemoney to another party then the same approach applies to WAP payments.

From GRSA's perspective the position in relation to third parties is reflective of OzChase records and is as follows:

- If GRSA have been notified of an ownership split [which is recorded in OzChase] then you DO NOT need to make a payment to owners for the WAP because GRSA will do this automatically; however
- If you ordinarily forward on payments to owners on your own accord, then you DO need to do the same for the WAP. Each remittance will include the name of the dog for which the WAP is being made.

Disciplinary processes and the new rules

As I reported in the June 2022 edition, at its meeting on 2 June 2022, the GRSA Board approved amendments to Division 22 of the Local Rules.

Part of these amendments allows some breaches of the rules to be dealt with by Stewards, with others dealt with by the Integrity Hearings Panel (IHP). While Stewards' Inquiries may be familiar to the Industry, the IHP may not. The IHP commenced in 2020 and is up to three, appointed people who comprise what could be described as the 'judiciary'. For rule breaches that must be heard by the IHP (commonly prohibited substances) the alleged wrongdoer will be charged with a breach of the rules. In some instances, the alleged wrongdoer will be required to attend an interview (in person or phone) with a Steward, before the IHP hearing. This is to allow an opportunity to provide a version or clear up unanswered issues to streamline the IHP hearing. After being charged, the alleged wrongdoer has the option of pleading guilty or not guilty. It is a bit like a court. If you plead not guilty, the IHP will hear and decide the issues in dispute. For a guilty plea, the IHP will decide penalty. Common penalties are fines and suspensions. In some instances, the suspension will be suspended. This terminology can be confusing, but what it means is, the penalty is on hold for a period of time. Unless further offences are committed during the hold period, the original penalty falls away. This is similar to some sentences in criminal courts. Please note the time frame from offence to appearing before the IHP can be many months. Much of this is beyond anyone's control. The task of getting three members of the IHP together in a post-COVID world can be difficult, and the IHP, for the most part, sits bi-monthly. At the moment, the delay to appear for new matters is up to 4-months. Stewards' Inquiries, logistically, are easier to convene and so the clearance rate for them can be within days. Please always keep up to date with the new rules by looking on the webpage for the latest re-print.

But I put my form in?

Lodging forms with GRSA can happen in a number of ways and we still rely on physical lodgement of forms in many cases.

It is preferrable, however, to use email because you can then have your own record of lodgement. This can be as simple as taking a picture of the form and emailing it to the relevant department. Shortly, a new PDF signable document format will be available so you will not need to print/scan/post or drop-in anymore.

SMS notices

You might receive an SMS notice from the Animal Welfare Team.

Some industry folk live or work in areas or circumstances where mail or email is difficult. Mobile SMS messages are an alternative that can be faster and more convenient. If you receive an SMS from the Team, please do not ignore it. If you feel you need to verify the message, please call the team on the GRSA number.

Transfer or other status changes of greyhounds

Please remember it is very important, and a requirement under the rules of racing, that you let GRSA know about all greyhounds that enter and leave your custody.

This now includes, under the new Greyhounds Australasia Rules, retired greyhounds.

Return to sender: the end of the franking machine

If you receive GRSA mail, you will be used to the inked GRSA impression on the letter where a stamp usually goes, thanks to our ever-faithful franking machine.

Like many devices of a bygone era (like the fax, VHS cassettes and Space Invaders), the modern era has seen the use of posted letters decline considerably. After a review, GRSA is stopping the use of the franking machine, due to its cost compared to actual use. This will present savings to GRSA. So, if you start to see GRSA letters with sticky stamps, they are still legitimate correspondence. For notices where registered post is considered necessary or desirable, the usual arrangements remain.

Online scams

I received some information recently about a person (not part of our industry) who appeared to be the victim of hacking that saw some funds fraudulently removed from their wagering account.

It is timely to remember that, while things like letters are on the decline, internet fraud is on the rise. Please remain vigilant when using apps to conduct transactions. Keep your mobile device secure with a PIN or some type of recognition to unlock it. Enable two-factor authentication where you can. If you see a suspicious message or email with a link, do not click on it. Take a good look at the message and see if it looks legitimate. Hackers seem to be able to use advanced maths to conduct scams but struggle with spelling. If in any doubt, or you think you have been hacked, immediately change your passwords, and seek advice from an IT professional.



KENNEL HOUSE WHITE BOARDS

White boards have been placed at prominent positions inside the kennel houses at Angle Park, Gawler and Murray Bridge.

Stewards will make note on these boards of all greyhounds required to undergo a post-race Veterinary examination or Participants who are required by Stewards. Participants are directed to view the whiteboard and seek clearance from Stewards (in the Stewards Room) prior to leaving the race meeting if you or your greyhound's name is on the board. Please do not ask kennel house staff. Failure to obtain clearance from Stewards may result in you having to return to the track if required.

SATISFACTORY TRIAL POLICY

Version number: 3.0– 2022 - Board approval: February 2020 Last review: May 2022 - Next review: January 2024

Policy Background

The purpose of this policy is to detail the procedure for a greyhound undertaking a satisfactory trial.

Application of the Policy

A "satisfactory trial" means a trial required to be performed by a greyhound to the satisfaction of Stewards pursuant to Rule 132.

The chart to the right lists the type of satisfactory trials, associated field types and numbers:

Procedures:

a) The trainer must contact GRSA Racing department to give details of the satisfactory trial required. In the instance the satisfactory trial is for Mount Gambier, a booking must be made directly with the club.

b) GRSA will determine the time the greyhound is required to run. The Steward[s] on duty during the trial may adjust the time at their discretion i.e., dependent on track conditions, etc.

c) Stewards will allot the box for the greyhound.

d) To be cleared to race at any distance, greyhounds must trial over a similar distance to that at which it offended. Please refer to the chart above right for applicable track, distances, and times.

Stewards will accede to a request from a trainer to trial a greyhound over a shorter distance than that at which the penalty was placed on them. The successful trial distance will be recorded for the greyhound's requalification and will only permit the greyhound to be nominated for races up to that distance. Greyhounds must trial and requalify over a longer distance to be permitted to race over further.

e) A Veterinary Certificate of Fitness must be obtained and lodged prior to competing in an unraced for more than six [6] months trial, returning from retirement trial or when requested by Stewards.

f) Greyhounds that re-offend may have their nomination refused for future trials at the discretion of the Stewards.

g) The provisions of Rule 132 and Rule 135 apply.

h) Satisfactory Trials ordered under Rule 123 (Marring), Rule 124 (Failing to pursue), Rule 125 (Failing to pursue by reason of injury) and Rule 129 (Unsatisfactory performance) must be performed at the track where the offence occurred to obtain clearance at all tracks. For clearance at all tracks except the track where the offence occurred the trial may be performed at any venue.

i) If a greyhound is ordered to undergo a Satisfactory Trial on a circle track and successfully completes a Satisfactory Trial on a straight track, it will be cleared for straight track racing only.

j) If a greyhound is ordered to undergo a Satisfactory Trial on a straight track and successfully completes a Satisfactory Trial on a circle track, it will be cleared for circle track racing only.

GRSA reserves the right to alter or amend this policy at any time.






As previously advised, GAP have been increasing the number of assessments in the monthly schedule.



RACING REPORT



QUALIFYING AND SATISFACTORY TRIALS

Angle Park qualifying and satisfactory trials are held every Tuesday night between 6.50pm and 7.15pm. Qualifying will be for the following Monday meeting (drawn Thursday). Nominations close at 12.30pm on the Tuesday (for online nominations 11.59pm Monday).

Gawler qualifying and satisfactory trials are held every Thursday morning from 7am. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm Wednesday the day prior.

Murray Bridge qualifying and satisfactory trials are held every Wednesday night at approximately 5.15pm (between the end of the straight track trials and the beginning of the one turn track trials). Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm on Wednesday (for online nominations 11.50pm Tuesday).

ANGLE PARK

SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number or alternatively logon to trialbooker.com, create an account and book your own trials.

POLICY FOR TRIALLING AT ANGLE PARK, GAWLER AND MURRAY BRIDGE BEFORE THE RACE MEETING

Policy Background

This policy is to detail the procedure for trainers seeking greyhounds to trial before race meetings. This policy is effective from 2 May 2019.

Race Meeting Trial Policy

This policy is in place for the following race meetings:

Angle Park Monday, Gawler Wednesday and Sunday, Murray Bridge Tuesday and Friday.

Two fields from the boxes with a maximum of four (4) greyhounds. Trials may be conducted at any time during the race meeting from immediately after kenneling until after the last race, at Stewards' discretion.

The following lists the order in which greyhounds will be selected in the event if more than eight (8) greyhounds are nominated:

1. Reserves at the meeting that do not obtain a start

2. Trainers that have greyhounds engaged and are located more than 100km in distance from the track

3. Satisfactory trials

Procedure/criteria

- 1. For Angle Park Monday night, the trainer is to contact GRSA between 9am and 10am on Monday to nominate. Should the Monday be a public holiday bookings are to be made between 8am and 9am on the scratching number.
- 2. For Murray Bridge Tuesday & Friday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times.
- 3. For Gawler Wednesday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Gawler Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
- 4. Other than reserve greyhounds, trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
- 5. Stewards will allocate the box for the greyhound.
- 6. Trials will be 515m, 530m & 531m in distance as first preference. Other distances considered depending on nominations.
- 7. Greyhounds currently under suspension are ineligible to trial unless they are undertaking a satisfactory trial to be cleared.
- 8. Greyhound registration cards must be produced at kennelling time.
- Trainers with other greyhounds engaged can utilise the extra kennel space until such time they are ready to leave.
 Trainers with no other greyhounds engaged will be

permitted to leave with Stewards permission.

10. In the case of race at Murray Bridge, trials will only be available on the track that is prepared to race that day i.e. Friday meeting on the u-shaped track, trials will be on the u-shaped track only.

Please note: If there are 12 races at Angle Park, Gawler or Murray Bridge there will be NO trials.

The Angle Park Vet Clinic and/or swab kennels cannot be used to accommodate any additional greyhounds due to operational requirements of the Clinic and Stewards.

It is vital that trainers nominate to trial at these race meetings. If you are unable to nominate at these times, please contact GRSA as soon as possible as permission may be given at GRSA's discretion to accept bookings outside these times.

Exceptions to this policy

Thursday nights are kept available for interstate greyhounds to solo trial in a lead-up to SA Group races as well as local greyhound's trialling for Group racing interstate.

Upon request, local greyhounds will be allowed to solo trial in a lead-up to a feature race and they will take one of the eight (8) kennels available for trialling greyhounds ahead of the policy and sit separate to the four (4) dog trials. Races considered to be a feature are: Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals and any interstate Group race

Local greyhounds will be permitted to trial on a race night, where they are in preparation for a feature event, nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy. If a greyhound qualifies for a feature final and requires a trial in between, this will be conducted as a solo trial and will sit separately to the four (4) dog trials.

MOUNT GAMBIER SATISFACTORY TRIALS

Mt Gambier hold trials on Wednesday and Saturday mornings with Satisfactory trials ONLY being conducted on Wednesdays and need to be booked with Barry Shepheard from the Club on 0419 824 512 no later than 12pm the day before.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shepheard.


