Departure Gate claims memorable win in Mount Gambier Cup

MOUNT GAMBIER

Moorak trainer Jason Newman struck a blow for the locals on April 10th when his \$18 chance Departure Gate won the 42nd running of the Mount Gambier Cup (512 metres), sponsored this year by Carlin & Gazzard MG.

Contesting the first Group 3 event to be run at Tara Raceway, Departure Gate, together with fellow locals Whole Way and Midnight Blast, took on the might of the powerful Victorian-based foursome – Blazing Times, Keep It Blue, Keep It Black and Weblec Ranger – all trained by Angela Langton.

But it was Departure Gate who quickly found the front from box six and from then on was never headed. He eventually held out last month's Murray Bridge Cup winner Weblec Ranger to win by a head in 29.42 seconds, the time equalling Sunset Milo's race record established in 2020.

Weblec Ranger's head defeat cost Langton a \$10,000 bonus, awarded by Greyhound Racing SA to any trainer winning both the Murray Bridge and Mount Gambier Cups with the same greyhound.

And many long-time greyhound racing followers declared the 2022 Carlin & Gazzard MG Mount Gambier Cup meeting as one of the best ever run at the Lake Terrace East venue.

"I haven't missed too many Mount Gambier Cups over the years and I reckon today's was probably the best one I've ever attended," said Michael Robinson, a former local greyhound chief steward and still a regular at the twiceweekly Tara Raceway meetings.

Once again, GRSA, the sport's controlling body, made its presence felt with Grantley Stevens (chairman), Gavin Bosch (acting CEO), Adrian Battiston and David Lewis (directors) and Matt Watson and Tim Stoeckel of marketing all in attendance.

"We were particularly keen to see how the club's first Group 3 event went off," Stevens said. "And we were absolutely delighted with the whole day. The support it received was tremendous and certainly a credit to the Mount Gambier Greyhound Racing Club."

It was an emotional Newman who returned to the recently-built new look presentation dais with Departure Gate, a son of Fernando Bale x Tarks Nemesis who ironically had been bred by Langton.

"I can't believe it, I've just won the cup," he said. "He had to drive hard to hold the lead and that's what he did!"

Newman kicked the day off with a win in the first race, the Exchange Printers Maiden Stake [305 m], with Velocity Cleo in 17.80 seconds. Then, following the cup win, Ajmer was successful in the Trackside Meats Stake [400 m] in 23.11 seconds.

And just when the day surely couldn't get any better, partner Melissa Freitag won the second-last race, the Gordon Refrigeration Stake [512 m], with Awesome Alpaca in 30.61 seconds.









Weblec Ranger explosive in big cup win

Murray Bridge Cup night on March 20th promised to be a beauty and it lived right up to the expectations, with a bumper crowd, great weather and terrific racing all helping create a terrific night at the Bridge.

The two straight track races were absolute winners. With the sun setting in the background, the two Heats were run and it was something we don't rarely see at the dogs, with the crowd packed in near the finish line. It made for an awesome backdrop! The first Heat winner, Man Absconded was excellent in busting up his field by 4 lengths and breaking the 19 second barrier. He's All Fire was super impressive in winning the second heat holding off the inform Curl's Victory.

Gemtree Maximus impressed in the short course feature for the night. He's always had ability but hasn't been able to put it together in recent times, however, the win on Sunday was super classy and a sign of a matured dog. He got posted wide from box 8 and didn't quite have the zip to get around early. He took his time though and kept working, before shooting back to the inside and running down Classy Chaos in a terrific effort. Well done to Paul and Bec, it would have been a terrific thrill for them!

The 530m feature was taken out by Danyo's Charlie, who had been in terrific form going into it. He was able to lead but was quickly overtaken by Spring Phoebe, but then Charlie took back the lead before they turned for home. Charlie maintained the lead the rest of the way home, holding off another Spring Phoebe resurgence, who got within half a length. A great run from Danyo's Charlie and he ran a slick 29.92 in the process.

Dave Peckam claimed the Cup Consolation with Denzell Bale, who is proving to be quite a handy addition to his kennel. It was a really strong field, but Denzell Bale used box 1 to perfection, driving hard to hold the lead and then never leaving the fence as they turned for home. The result was a 25.49 victory, making it an enjoyable drive home for Dave!

Race 8 and the punters got what they came for - The Murray Bridge Cup! It was a really even race in the betting market, with all dogs given a genuine chance of winning the race. Early brilliance proved to be the difference, with Weblec Ranger shooting over from box 8 to find the front. Given he was the quickest Heat winner, it was always going to be difficult to run him down. Mr. Ticket and Fantastic Victor landed behind Weblec Ranger in the run and appeared up to the challenge of trying to run him down, but they never really made an impression, as Weblec Ranger claimed the Cup with an explosive effort. A big congratulations to the Britton/ Langton training duo but also to Neville Loechel and all the connections, you won't find a nicer bloke and family in the industry, which makes seeing the Weblec breed achieving success quite enjoyable!





Stars no match for Fantastic Victor in big win

ANGLE PARK

The fourth running of the Eastar Match Race series on 14th April saw another exciting series with 8 of the state's fastest greyhounds going head-to-head in 4×2 dog races.

In front of a fully booked Angle Park Easter Thursday crowd it was the Ossie Chegia trained Fantastic Victor who came out on top with a sizzling overall time of 30.09 for the 530m to claim the \$6,000 first prize.

In the first Match Race Came And Went for Troy Murray and Jack's Well for Cameron Butcher set the crowd alight with a stirring battle with only a finger nail separating the two speedsters in a great start to the series. Came And Went led as expected and Jack's Well was just of his heels as expected, however, as they entered the front straight they were both level pegging and raced head and head down to the finish line with the judge giving Jack's Well the win on the outside with both recording 30.22 for the 530m.

The second match race saw Harbor Blues for Kirin Corby and Fly For Trix for Jane McNicholl do battle. Harbor Blues was nicely supported into favouritism for this match and after showing terrific speed from the boxes he was able to cross and lead on the first turn. Fly For Trix was giving strong chase however Harbor Blues was low flying in the lead and opened up a decent break as they left the back straight. Whilst Fly For Trix tried hard to bridge the gap, Harbor Blues was in no danger and recorded a sizzling win reminiscent of his brilliant win in the Doug Payne Feature back in January. He recorded 30.16 to be the club house leader as we reached half way.

The third match was touted as the best of the night with Fantastic Victor for Ossie Chegia and Victa Grosso for Tony Rasmussen lining up head to head after they had been dualling out the Open company events at Angle Park over the last few months. Fantastic Victor jumped brilliantly as normal to lead however Victa Grosso was right there on his outside as they sped to the back straight. Both were in full flight as Victa Gross edged a little bit closer turning for home and it looked like anyone's race, however, Fantastic Victor pulled out plenty in the home straight to claim the third match race with both sprinters running scintillating time. Fantastic Victor jumped in the overall lead with a slick 30.09 win while Victa Grosso ran 30.17 seeing him slot into third place.

There were now only two chances left to beat Fantastic Victor's time when Victa Haydn for Tony Rasmussen and He's All Purpose for Tim Richards matched up in the last two dog battle.

The match was one of brilliant early speed against raw power over the concluding stages which saw it one of the most interesting matches of the night. As expected, He's All Purpose jumped to the early lead and looked to speed away with Victa Haydn moving to the rails and starting to go through his gears. Into the back straight He's All Purpose was running along out in front but Victa Haydn was a lot closer than expected and with his massive run home time Fantastic Victor's time of 30.09 looked to be in danger. Off the back straight and Victa Haydn moved up ominously to move past He's All Purpose who fought back hard and tried to keep him out however Victa Haydn drew to the lead entering the front straight and ran away with the win. All eyes turned to the clock to see if he could break his own run home time record to claim the title however a solid 30.31 was the time posted, meaning Fantastic Victor would claim the Eastar Match race title for 2022.

The win for trainer Oswald Chegia came as no real surprise,







given Fantastic Victor had run quick times in the past.

"You're never confident but the dog was feeling really well and he's run that sort of time before so it was good he did it again." said Ossie, who not too long ago put Fantastic Victor over the 600m trip, to try and strengthen him up and by the manner of the win last night, it certainly seems to have done that.

"I got a bit worried around the turn but he normally kicks away in the straight and he did again like I thought he would. You probably have to run that sort of time to beat the dog."

After this success, all eyes will turn to the enormous Anniversary Cup heats on April 21st with a \$50,000 first prize on offer in the final. Whilst we are sure to see some strong interstate representation, Fantastic Victor will be there to greet the challengers.

"Next week he's going into the Anniversary Cup heats so that's our next plan. Then he might have a few days off after that and go for something else."

Weblec Star gets the choccies with cup win

After two exciting Heats, the \$7,750 Easter Cup Final over the middle distance at Angle Park produced a wonderful race on April 14.

Race favourites were Heat winners Mallee Magic for Tony Rasmussen and Weblec Star for Neville Loechel along with the Lisa Rasmussen trained Victa Reid who was unlucky in the heat and was backed into clear favouritism from the inside draw as the green light was turned on.

As the start was affected Weblec Star from box 7 exploded from the boxes to clear the field as they entered the front straight the first time with Victa Reid also getting a nice start from the inside to move to second. Sebon Panther for Tony Nobes was handy on the inside and Sutton Sandy for Angela Modra was also up there challenging while Mallee Magic was checked early and was caught up in the second half of the field.

Into the back straight and Weblec Star was looking very hard to catch as she raced clear from Victa Reid who held second. Sebon Panther was in third while Lashes Monelli for Tim Aloisi looked to make ground along the rails as Mallee Magic moved to the outside to give chase. Off the back straight and not much had changed as the greyhounds gave their all with Weblec Star still going strong chased hard by Victa Reid, Sebon Panther was battling on well as both Lashes Monelli and Mallee Magic closed in for third spot.

As they raced down the front straight to the winning post Weblec Star stretched away from her rivals going on to win by an increasing 3.50 lengths in a solid 34.19 for the 595m journey. Victa Reid held on for second as Lashes Monelli charged home into third with the upcoming Heats of the Distance Championship over the 730m looking well within her grasp. Sebon Panther battled on well just ahead of the luckless Mallee Magic.







Greyhound of the Month for March was Fantastic Victor for trainer Ossie Chegia in a tight month of voting the son of Fernando Bale and Fantastic Dotty came out on top, just ahead of Mr. Ticket, He's All Purpose and Victa Grosso.

He had five starts for the month with three wins and two thirds showing speed and stamina in all his events. He started the month of with a blistering 34.06 win at headquarters over the 595m before the Heats of the Group 3 Murray Bridge Cup. He won his Heat in good fashion before a solid third placing in the Group 3 Final. He came back to Angle Park for a third over the 595m before a slick 30.22 win over the 530m in Free For All company at headquarters.

At the end of the month Fantastic Victor's record stood at 58 starts for 25 wins and 16 placings and earnings around \$80,000.




The Run of the Month for March was Came And Went for trainer Troy Murray after he set the fastest time over the 530m at Angle Park for a locally trained greyhound.

On Monday, 7th March the son of Barcia Bale and Hillary stepped out in Grade 5 company as a very short priced favourite and after a slick beginning he quickly raced to the lead. With split times of 5.10 and 17.48 a quick time was on the cards as he raced away from his rivals. He stopped the clock at 30.05 in winning by 7.50 lengths, showing he was right back to his best which took him to the Final of last Octobers Group 1 Adelaide Cup.

ANGLE PARK'S 50 YEAR ANNIVERSARY AND \$50K TO THE WINNER NEXT FRIDAY 29TH APRIL

After consultation with Greyhound Racing Victoria, Greyhound Racing SA is very appreciative that they have swapped their Friday night meeting on April 29th with Angle Park's Thursday night meeting on April 28th. This will mean that Angle Park can celebrate our 50th Anniversary with a big night planned on a Friday night along with increased prizemoney of \$50,000 to the winner for the Anniversary Cup Final on the night.

The night itself will be very much like an Adelaide Cup atmosphere with plenty of entertainment for families as we celebrate 50 years at Angle Park.

There are three Heats on tonight, Thursday 21st April, for next weeks Final, with the first two placegetters and two fastest thirds qualifying for the feature event. The Box Draw will be conducted oncourse tonight after the running of the final Heat.

The feature Anniversary Cup Final, offering \$50k to the winner will be a high quality line up of sprinters with the night also featuring the SA Distance Championship Final worth \$10k to the winner with two Heats also run tonight with the first four from each Heat qualifying.

Other changes will be the Gawler Friday meeting on 29th April will now be run on Thursday, 28th April in the twilight timeslot.

GRSA appreciates the support of GRVIC and Sky Racing in regard to these changes.

BREEDERS 2022 PRELUDE (2) HEATS ON MONDAY NIGHT

GRSA advised previously that the Breeders 2022 Prelude (2) Heats at Angle Park that were programmed on Monday, 18th April have been rescheduled and will be run on Monday 25th April with the Final on Monday, 2nd May. This avoided a clash with the Gawler Future Stars series.

With the change, this will still give greyhounds that qualify for the Breeders 2022 Prelude [2] Final on 2nd May, 10 days until the Group 3 Howard Ashton Heats on Thursday, 12th May.

regularly for Thursday night we are looking at drawing from a different pool of greyhounds.

Once a fortnight we run the Saturday morning meeting at Angle Park where between one to four 530m events are run on the 10 race card. These greyhounds are Time Graded greyhounds [1-4 wins and 5 + wins] and would normally not compete on a Thursday night. We have decided to program Heats on the Saturday for these greyhounds [maximum 2 Heats] into a Final on the Thursday night [5 days later]. The Heats would be at the normal Time Graded prizemoney however the Final on the Thursday will be budgeted Grade 6 or Grade 5 money. The Heats and Finals will be 6 dog fields and non penalty. BREEDERS SUPPORT PROGRAM – IMPORTANT UPDATE FROM JULY 1

At the most recent ICG meeting our local breeding numbers were discussed. After considering how many litters are currently being bred, the panel decided to make an alteration to how many Breeder Rebates will be available each financial year.

For any Breeder Rebate application lodged (at Litter Registration time) from July 1 2022 to June 30 2023, GRSA will only rebate two Litters fully and if there is a third litter, this will be at a half price rebate. If a Breeder has a fourth litter there will be no claim available. It will be up to the Breeder to determine which 2½ Litters they would like the Breeders Support Claim for in the 12 month period. Please contact Racing Manager, Shaun Mathieson at GRSA for further information.

Below are the current Breeders Support Conditions -

Details regarding the Breeders Support Program for litters registered in SA. It is crucial that GRSA receives receipts for actual and verifiable expenses relating to litters whelped for items below or else no support payment can be provided: Claims will be a Maximum of \$2,000 with FSI and Pup payment in addition.

Stud/Sire Fee 50%, up to \$2,000 rebate (Commercial) (receipts required)

Owned Sire Fee Set amount of \$250

This section maximum of \$2,000

NOMINATIONS FOR SATISFACTORY TRIALS

Recently we have had several trainers nominating online using the Qualifying Trial meeting for Satisfactory Trials.

The online Qualifying Trial meetings are for trainers to nominate their greyhound which they wish to improve on the Order of Choice for the upcoming meeting only. Trainers, whom have a greyhound that is required to complete a Satisfactory Trial, are required to contact the offices of GRSA and provide the relevant details. By contacting the office, you will be advised of any further requirements that are needed for the Satisfactory Trial.

QUALIFYING AND SATISFACTORY TRIALS FOR MURRAY BRIDGE

Murray Bridge qualifying and satisfactory trials are held every Wednesday night at approximately 5.15pm (between the end of the straight track trials and the beginning of the one turn track trials). Qualifying will be for the following Friday/Sunday meeting (drawn the following week).

Nominations close at 12.30pm on Wednesday (for online nominations 11.50pm Tuesday).

COMMENTS ON NOMINATIONS MARKED "ONLY"

A few years ago the Grading Review Panel agreed that some trainers were using the comments box to influence the grading of fields in particular Grade 5 Only for all their greyhounds.

The panel previously resolved that "Only" would be disregarded over all distances and the grading left to the Grader. [Masters Only or Juvenile Only will be accepted as this is for a specific type of race]

If trainers put "Only or no start or leave me out" then the grader will grade as normal and if a greyhound would be graded into a mixed event based on race wins then he will leave them out based on the trainers request. The more information provided to the Grader allows for him to accommodate those requests.

WINNING GRADE 6 RACES IN ORDER

GRSA reminds trainers to win their grade 6 events in order at a specific venue.

For the venues that allow two Grade 6 wins trainers need to win a Grade 6 over one distance and then a Grade 6 over the other distance. If a greyhound wins a Grade 6 and then a Grade 5 then they will lose their Grade 6 over the other distance at that venue.

RE-GRADING FOR ALL TRACKS AND DISTANCES

Re-grading will occur for all tracks and distances for Grade 3 or higher greyhounds.

A trainer can apply for a re-grade after two unsuccessful nominations over the corresponding distance. If having met this criteria the responsibility is on the trainer to apply for a re-grade prior to the close of nominations. Only one distance will be considered for a re-grade per meeting.

DAISH IRRIGATION & FODDER VOUCHERS FOR MURRAY BRIDGE

The Murray Bridge GRC has been able to secure some \$100 vouchers from their sponsor Daish Irrigation & Fodder to be used on Heat and Final series' over the next 12 months.

PANNUS

I acknowledge GWIC for this helpful information -Pannus, or chronic superficial keratitis, is a condition seen in greyhounds that affects the surface of the eye.

If left untreated, it can cause visual impairment. Pannus is treated with prednefrin eye drops prescribed by a veterinarian. Prednefrin eye drops contain Prednisolone, which along with its metabolites, is a prohibited substance. The use of prednefrin eye drops must be registered to avoid a positive result for a prohibited substance during swabbing.

Like in NSW, GRSA now make allowance for racing greyhounds being treated for Pannus. Participants that have a greyhound being treated for Pannus must notify GRSA by completing a Pannus notification. GRSA will then record

this on our databases to indicate the greyhound is being treated for pannus. Please refer to the GRSA website for more details or contact Animal Welfare.

MUZZLES

When the new Greyhounds Australasia Rules are released, there will be a general ban on the use of barking muzzles.

There is provision for an exemption to this general ban; however, the circumstances will be strictly monitored and controlled, effectively reducing use to exceptional circumstances only. GRSA will advise further, closer to the new rule release about the implementation of this new rule and the exemption process.

LOCAL RULES 2022 AND ANIMAL WELFARE POLICY 2021 ARE NOW IN FORCE

Please take the time to familiarise yourself with the new Local Rules 2022, on the website.

These are now in force. Also remember the Animal Welfare Policy 2021 that is also in force and available on the website.

COVID-19

The 14th of April saw COVID-19 restrictions significantly eased. From that date, you no longer need to wear masks within our facilities or QR Code (contact trace) check-in.

Progressively, we will roll back our now familiar signage.

Progressively, we will roll back our, now familiar, signage about masks and check in. Also, you will see less notices from GRSA, about COVID-19 transmission, in line with SA Health advice. However, the pandemic is by no means over. It is expected that our highest days of transmission will occur over April and coincide with the start of the flu season. Our experience with COVID-19 is that it is a disease you should not take for granted. While it is true that some people are hardly affected, many are significantly affected and need some medical assistance. Do not ignore the signals your body gives you. Further, the RAT (home) test, while convenient, can return false negative or positive results. If you have symptoms, it is better to seek a PCR test. The current isolation times for both positive cases and close contacts is 7-clear days from test to release (test is day-0 and release is day-8). GRSA continues to encourage you to wear a mask as a personal choice, as well as maintaining an up-to-date vaccination status.

Change to interpretation of first offence for Marring and Failing to Pursue

At a recent Industry Consultative Group meeting, the matter of Stewards interpretation of first offence for Marring and Failing to Pursue was raised.

Since 21st February 2018, greyhounds have been unable to complete a satisfactory trial at the track at which the offence took place until the expiry of the 28-day suspension period which, in reality, extended the penalty period. Effective immediately, greyhounds will be permitted to complete satisfactory trials at the track at which the offence took place within the suspension period, to enable the greyhound to resume racing at that track at the completion of the suspension period. Please contact Stewards to seek clarification.

Catching Pen Policy

Participants are reminded of GRSA Catching Pen Policy, in particular the following:

• Handlers must wait until ALL greyhounds are in the catching pen and then attempt to catch, DO NOT walk in front of incoming greyhounds.

Stewards have been made aware of recent occasions whereby participants have entered the catching pen prematurely. Please be aware that it is an offence to do so, and Stewards will be reviewing vision from catching pen

NOTES OF INDUSTRY CONSULTATIVE GROUP (ICG) MEETING - HELD IN THE BOARDROOM OF GRSA, 55 CARDIGAN STREET, ANGLE PARK

ON FRIDAY 18 MARCH 2022 AT 10.00AM

The meeting commenced at 10.04am.

1 APOLOGIES: Nicole Massey

The Chairman advised the group that following an intensive recruitment process, Bodelle Francis had been appointed as Chief Executive Officer and will commence in the role on 27 April. The Chairman noted the high calibre of applicants with Bodelle being deemed the most suitable with both her racing and hospitality experience as well as what the Board believes is the best cultural fit. On behalf of the Board, the Chairman thanked Gavin Bosch for his dedicated effort in the Acting CEO role and also thanked the senior management team for their efforts over the last couple of months. The Chairman advised that Matt Corby will assist in the handover to Bodelle.

The panel noted the resignation of group members, Kurt Donsberg and Scott Feltus.

2 NOTES FROM PREVIOUS MEETING

The Minutes from the ICG Meeting held on Monday November 1, 2021 were noted as a true and correct record.

3 BUSINESS ARISING FROM PREVIOUS MEETING

3.1 Updates from Minutes

The RM noted the current delays with materials for the synthetic lures for participants. The SPM advised that the new style of lure will be more expensive than sheepskins however there may be the potential for GRSA to subsidise the cost.

The RCM provided an update on barking muzzle exemptions following the recent Integrity and Welfare Committee [IWC] meeting. He advised that the new GA rules presented several options for participants including applying for an exemption as well as for GRSA to source and make available an approved type of muzzle. Some panel members raised concern with outdated council permits which suggested noise is to be controlled by barking muzzles. The RCM advised he wouldn't be concerned regarding any such clauses.

The RCM provided an update regarding the treatment of pannus as approved by the IWC. He noted participants would be able to apply to be on a register. Some panel members questioned if those greyhounds registered for pannus would be banned from breeding. The RCM committed to confirming if there would be any restrictions on breeding with dogs with pannus and would subsequently formulate a policy that took breeding into account.

Action: Risk and Compliance Manage to provide clarification around breeding from pannus affected greyhounds.

The RCM advised that the IWC were not inclined to expand the TIRS to trials due to the lack of on-track veterinary presence and lack of tracking. Some panel members disagreed with the scheme not covering trials and noted that GRSA staff were present, and dogs were trialling on a prepared surface it warranted the scheme being made available at trials. The SPM suggested the upcoming digital transformation could assist with roll out of the scheme to trials as there would be the ability to track and view footage of the dogs. Some panel members noted the risk of potential preexisting injuries and trialling. It was noted that trials were somewhat unregulated and race events were conducted in a far more controlled environment. The COS suggested the introduction of regulated trials would be beneficial to industry however GRSA currently lacked resources to be able to do this. The Chairman requested a paper be presented to the Board recommending increased protocols at trials events as well as any recommended updates to the TIRS. Panel members noted under the NSW scheme, participants were required to repay any subsidised payments should the greyhound return to racing following

claimable injury and the potential for this to included under the SA scheme. The RCM noted that the SA subsidy was relatively low compared to other states and there was a definite opportunity to reassess entire scheme.

Action: Management to prepare a paper to the Board detailing recommended increases to protocols at trials as well as any required changes to the Track Injury Rebate Scheme.

The COS provided an update regarding the provision of water to dogs during race meetings. He suggested the decision to provide water would be left to trainers and Stewards would take application for particular dogs post-race to be taken out for water. He noted the risks with providing water in kennels. Panel members suggested there would be issues with removing a dog from kennels during the meeting. The group suggested this wasn't a major issue. Panel members requested when delays to last races occur, that the option of emptying out greyhounds in these last races be made available prior to their race.

The COS spoke to the request to have mobile phones during the parading and boxing of greyhounds. He noted that a handler needs to be in control of dog and operating a mobile phone would pose a risk, if this would to be allowed it would require an additional person which also poses risks. He suggested that vision of greyhounds trackside, parading and to boxes can be obtained without being on trackside of fence. It was suggested Facebook live or similar such as webcam could be utilised to allow owners to view. Panel members suggested there would be additional benefits to vision to be made available generally. It was requested that this be brought to the Marketing Manager's attention for their input to solution.

Action: The Marketing Manager to investigate options to have trackside, parading and boxing vision made available to owners and trainers.

Panel members advised a proposal in regards to puppy auction had been submitted to the Acting CEO for presentation to SMT.

The SPM advised that the issues with the air conditioning in Chasers has been noted and that a contractor will be conducting an allvenue air conditioning audit and will assess any issues.

3.2 Sustainable Breeding Levels

Panel members suggested larger SA trainers were accepting fewer dogs from interstate. The Chairman noted his intent to raise this topic at GA and reinforce that SA will not accept excess interstate dogs. The RM noted that SA currently has more sustainable breeding levels than previous years. He suggested local breeding required to be slowed somewhat, with potential to limit to two rebates to curb behaviour. Panel members suggested "super breeders" were a potential issue and that we didn't want to see smaller breeders discouraged by the removal of the rebate. The RM noted the intent to not complicate the rebate process. Members suggested retaining the first two rebates and the subsequent third payment halved. It was suggested this change would be implemented from 1st July, 2022.

3.3 Limited Monthly Starts

The RM noted this was a strategy to manage overracing, however he didn't believe this was a widespread issue. The COS referenced WA research into number of starts by distance. Members questioned if there was a mechanism that could be triggered by Stewards should they observe over racing of dogs. It was noted that the Acting CEO will raise at the next GA CEO's meeting. The RM noted the importance of this discussion and the benefit of minutes being released to participants to make them aware of potential changes which could have a positive effect on their habits.

4 AGENDA ITEMS

4.1 Stakemoney Interstate Benchmarking

The panel discussed stakemoney and benchmarking with other states. The RM suggested there was a perception from trainers around Thursday night that wasn't accurate in that racing on a Thursday was too strong so trainers would not nominate. Members suggested the home and away payments assisted, and it was his belief there was no need to change at this point.

4.2 Minimum Bet Laws

The Chairman noted minimum bet laws will form part of future negotiations of Integrity and Contribution Agreements. Members noted the importance for this to change within agreements. The Acting CEO noted that there was unanimous agreement that minimum bets were required.

4.3 Trialling on Saturday/Sunday Mornings

Some members provided their support to retaining the current schedule and times. The group were in agreeance.

4.4 Satisfactory Trialling - Interpretation

The COS advised he had consulted other states and noted there were varying interpretations with majority allowing trialling within the 28 days to occur. The Group agreed to allow a STAT trial for Marring and FTP to take place at the venue where the offence occurred inside the 28 day period. Implementation date to be advised to industry.

4.5 Digital Transformation and Broadcast Enhancement (IsoLynx)

The SPM provided an overview to the project and data that will be made available following the installation. He noted there will be far greater consistency of measuring dogs over multiple tracks and distances with the use of robotic cameras. He further noted the huge potential for use of data in future. Including uses for trials. The Chairman noted the advantage to SA is its ability to install at all four tracks, providing benefit to punters with increased information available and definite welfare advantages.

4.6 National Track Maintenance and Preparation Project (GA)

The SPM provided background to the project. The Group noted the update. Members of the panel were pleased with a standardised approach.

4.7 Diagnostic Equipment for Track Maintenance Staff

The Group noted the update.

5. OTHER BUSINESS

5.1 Non Airconditioned Trailers (Judi Hurley)

Panel members suggested there shouldn't be any restrictions on the use of non-airconditioned trailers in the winter months. The RCM highlighted the current Animal Welfare policy in regard to transport of greyhounds and the common sense measures within the policy. He advised the IWC does not want to force trainers to retrofit air conditioners on trailers. He noted non-airconditioned trailers would not be allowed to be used on hot days and trainers wouldn't be penalised. The Group agreed that a concrete rule regarding use of trailers in hot weather needs to be implemented.

5.2 Lisa Rasmussen Items

Lisa Rasmussen suggested confusion existed with the current Gawler Thursday morning trial session schedule and requested these be kept consistent. The RM suggested management wouldn't have an issue with this and could amend. Panel members raised concern with the Murray Bridge straight track trials and suggested holding straight track trials prior to circle at 4pm (during daylight savings). They suggested there were too many trial sessions at Murray Bridge. The RM indicated that any changes to the Murray Bridge trial schedule would be guided by the ICG. The COS suggested three trial sessions per week was excessive and has the potential to be reassessed to ensure it is more economical. Lisa Rasmussen advised she would like to present an alternate trial schedule to the Murray Bridge committee prior to any changes being implemented. It was noted any changes would be made in conjunction with the RM obtaining information on current booking numbers.

The RM noted Lisa's suggestion of altering nominations closing time for the Murray Bridge straight track and separating it away from Angle Park Monday night on the same day. He provided the group information regarding the nomination and grading process and noted he would be hesitant to split nomination closing times. He suggested trainers nominate for both meetings.

The COS advised it was difficult to decide on opening the kennel house early with high humidity as this could not be determined with enough notice. He requested input from the group as to what they believed was an appropriate level of humidity to warrant an early opening and at what point in time the recording would be

taken from. Members suggested the issue should be relieved with improvements to air conditioning in the Angle Park kennelhouse. Lisa Rasmussen requested, should the situation occur again, fans be made available outside of the kennel house. Management agreed to this.

5.3 Christine Costa Item

Christine Costa suggested a formal review process be undertaken following the Angle Park redevelopment. She advised about camber and rain causing channels and excess water near rail. The Chairman questioned the group as to their thoughts on the relationship with camber at Murray Bridge and Ange Park. Some members disagreed and believed the camber was fine. Some members suggested they were pleased with the track following the redevelopment. The Chairman noted the Board's appetite to review all available data regarding track preparation in relation to any injuries. The IM noted the challenges to be able to address any perceived issues when information is anecdotal and outside of GRSA's control. The COS suggested trainers needed to report injuries outside of race meetings to ensure Stewards were aware. The Chairman committed to ensuring this topic remained on the radar.

5.4 Syndication

Members questioned the status of syndication. The Chairman advised that this was a difficult topic due to ASIC regulations and rules. The Acting CEO provided an update to the group as to what was occurring interstate. He noted the topic would remain on GRSA's agenda however currently there were too many hurdles to overcome. It was noted the topic would be further discussed at the upcoming GA CEO's meeting.

5.5 Political Parties Racing Policy

Members questioned with the upcoming election, whether the Board were aware of a Labor racing policy. If Labor were to win he would be meeting with Racing SA and the Minister as soon as possible thereafter. Katrine Hildyard has provided support to GRSA in past couple years, will continue to build relationship with both parties.

5.6 New GRSA Website

Members questioned the status of the new GRSA website. The Chairman advised the project was expected to be completed in approximately two months. He noted the developers were experiencing delays in obtaining OzChase data.

5.7 TAB Digital On Course

Members questioned the status of TAB digital on course rollout. The Acting CEO provided an update noting the digital on course process had stalled however GRSA were still conversing with SA Bookmakers to ensure that a bookmaker was available on course in the meantime.

5.8 Expanded Form Guide

The group questioned the source of the expanded form guide information available on the GRSA website. The RM advised that it was contracted from NSW, that three different form analysts to SA meetings. The group raised concern with the quality of the form noting on numerous occasions the form analyst had misreported the gender of the dog and incorrect times of the winner and winning margins which also flowed through to the Advertiser form guide. The RM committed to providing this feedback to the provider.

5.9 Mt Gambier Racecallers

Members questioned the absence of local race callers at Mt Gambier. The RM advised this was due to local callers being cost prohibitive and was triggered by TAB Radio. They will be in attendance for their Cup meeting.

Distribution of WAP Payments between Trainers and Owners

GRSA would like to remind all participants that receive a WAP that the payment is the equivalent of prizemoney. If you are currently responsible for distributing prizemoney to another party then the same approach applies to WAP payments.

From GRSA's perspective the position in relation to third parties is reflective of OzChase records and is as follows:

- If GRSA have been notified of an ownership split [which is recorded in OzChase] then you DO NOT need to
 make a payment to owners for the WAP because GRSA will do this automatically; however
- If you ordinarily forward on payments to owners on your own accord, then you DO need to do the same for the WAP.
 Each remittance will include the name of the dog for which the WAP is being made.

It is not uncommon for GRSA to receive requests for more information in relation to how the WAP is calculated for their particular dogs(s). The example below is provided to assist in the general understanding of the calculation.

In this example, the owner/trainer would receive a WAP of \$71.43, calculated as:

 $$1,000 \div $700,000 \times $50,000 = 71.43

Participants should note that:

- WAP is not payable for any prizemoney received in relation to feature races [where total stakes are above \$5,000];
- Trainers' fees and other bonus payments are not included in the calculation of the share of the WAP; and
- It is a requirement that a greyhound has to have raced and received prizemoney during a month to be eligible to receive the WAP payment for that month.

New GRSA website


The new Greyhound Racing SA website will be launched in the coming month.



Memorable feature win in SA Launching Pad

The final of the SA Launching Pad series at Angle Park on March 17 was a fitting finale to a great series with Charlee's Misty for trainer Ed Burrett booking her spot in the 2022 Launching Pad series for SA at Sandown.

Only new to SA, Charlee's Misty only had her first start in the state in the heats the week prior where she ran an encouraging second after being purchased by Ed from NSW. The daughter of Fernando Bale and Flighty Egyptian made full use of her inside draw as the start was affected, railing hard to the first turn to challenge for the early lead. There was a five way drive for the lead with Charlee's Misty joined by first reserve, Nikita for Don Turner, Clear View for Tara Rasmussen, Springvale Rex for Gavin Harris and widest of all was Fantastic Faith for Ossie Chegia. Race favourite, Lot Of Poise for Tony Rasmussen was back near last and in traffic after a slow beginning.

As they raced into the first bend Charlee's Misty asserted her authority on the race and pushed hard to lead with Nikita following through while other runners received checks to varying degrees due to such tight racing. As the field settled themselves into their racing positions into the back straight Charlee's Misty scooted away with the lead quickly followed by Nikita, second reserve Paul Keeping for Jack Trengove took advantage of the tight racing and scrambling for positions and moved to third just ahead of Fantastic Faith. Off the back straight the field was basically in single file with Charlee's Misty proving very hard to catch. Turning for home and Charlee's Misty was going nicely in the lead and kicked clear with Nikita being challenged for second place by Paul Keeping who made ground along the rails. Down to the winning post and Charlee's Misty came clear for a strong win in a slick 30.83 in winning by over 4 lengths from Paul Keeping who ran home well for second just ahead of Nikita



who battled on into third just ahead of Fantastic Faith.

It was a great feature win for Ed, who only has 2 dogs in work and helps soften the disappointment from last September when he had one of the favourites for the SA Oaks, Zipping Decoy after her brilliant win in the heats but unfortunately was scratched just days before the Group 3 final. Charlee's Misty ran 4th in the first heat at Sandown on March 31 behind star Wow She's Fast before finishing 7th the following week in the semis.

Springvale Maddi wins Gawler Future Stars

Springvale Maddi is half owned by Gavin Harris who is the trainer of the second place getter Springvale Rex. The other Gavin



Harris owned greyhound in the race was Springvale Max. Maddie, Rex and Max are all from the same litter of pups and all owned by Gavin Harris. The Springvale litter are definitely a group of greyhounds to keep an eye on.



GAP kennelling fee payment process change

Please note that as of 1st August 2021 the GAP kennelling payment process has changed for a trial period of three months.

The changes are as follows:

Instead of making a weekly payment of \$33 per dog, the new kennelling fee will be a flat amount of \$50 per dog, irrespective of the time period the greyhound will spend at the GAP kennels.

Participants who would like their greyhounds placed in the GAP kennels will be requested to pay the \$50 at the time when the placement form is filled in and the \$60 placement fee is paid.

This means that for greyhounds that are to be kennelled with GAP an upfront payment of \$110 will be requested. After that, participants will not need to make any additional payments for their dogs in the GAP kennels. Noting that prior to foster care dogs spend an average of 4 weeks in kennels, this change is expected to generate a saving of \$82 per dog for participants.

Latest updates from GAP


As previously advised, GAP have been increasing the number of assessments in the monthly schedule.

QUALIFYING AND SATISFACTORY TRIALS

Angle Park qualifying and satisfactory trials are held every Tuesday night between 6.50pm and 7.15pm. Qualifying will be for the following Monday meeting (drawn Thursday). Nominations close at 12.30pm on the Tuesday (for online nominations 11.59pm Monday).

Gawler qualifying and satisfactory trials are held every Thursday morning from 7am. Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm Wednesday the day prior.

Murray Bridge qualifying and satisfactory trials are held every Wednesday night at approximately 5.15pm (between the end of the straight track trials and the beginning of the one turn track trials). Qualifying will be for the following Friday/Sunday meeting (drawn the following week). Nominations close at 12.30pm on Wednesday (for online nominations 11.50pm Tuesday).

ANGLE PARK

SINGLE TRIALS

A reminder to trainers that single trials can be booked with two greyhounds however you need to advise when booking of your intention to do this. If you wish to put three or more into this trial then a field trial will have to be booked.

BOOKING NUMBER FOR TRIALS

Participants wishing to book trials are required to ring 8243 7172, this phone line will only be used for trial bookings and will queue participants. By having this one number with participants queuing makes this process to be a more efficient way of booking trials.

There will be NO trials accepted through the normal administration number. To be fair to everyone GRSA will only accept bookings using the new number or alternatively logon to trialbooker.com, create an account and book your own trials.

POLICY FOR TRIALLING AT ANGLE PARK, GAWLER AND MURRAY BRIDGE BEFORE THE RACE MEETING

Policy Background

This policy is to detail the procedure for trainers seeking greyhounds to trial before race meetings. This policy is effective from 2 May 2019.

Race Meeting Trial Policy

This policy is in place for the following race meetings:

Angle Park Monday, Gawler Wednesday and Sunday, Murray Bridge Tuesday and Friday.

Two fields from the boxes with a maximum of four (4)

greyhounds. Trials may be conducted at any time during the race meeting from immediately after kenneling until after the last race, at Stewards' discretion.

The following lists the order in which greyhounds will be selected in the event if more than eight (8) greyhounds are nominated:

- 1. Reserves at the meeting that do not obtain a start
- 2. Trainers that have greyhounds engaged and are located more than 100km in distance from the track
- 3. Satisfactory trials

Procedure/criteria

- For Angle Park Monday night, the trainer is to contact GRSA between 9am and 10am on Monday to nominate. Should the Monday be a public holiday bookings are to be made between 8am and 9am on the scratching number.
- For Murray Bridge Tuesday & Friday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times.
- 3. For Gawler Wednesday, the trainer is to contact GRSA between 3pm and 4pm the day before. Should any of these times fall on a public holiday bookings are to be made during scratching times. For Gawler Sunday, the trainer is to contact the scratching number on Sunday between 8am and 9am.
- 4. Other than reserve greyhounds, trainers will be restricted to trialling one (1) greyhound unless nominations determine otherwise.
- 5. Stewards will allocate the box for the greyhound.
- Trials will be 515m, 530m & 531m in distance as first preference. Other distances considered depending on nominations.
- 7. Greyhounds currently under suspension are ineligible to trial unless they are undertaking a satisfactory trial to be cleared.
- 8. Greyhound registration cards must be produced at kennelling time.
- Trainers with other greyhounds engaged can utilise the extra kennel space until such time they are ready to leave.
 - Trainers with no other greyhounds engaged will be permitted to leave with Stewards permission.
- In the case of race at Murray Bridge, trials will only be available on the track that is prepared to race that day i.e. Friday meeting on the u-shaped track, trials will be on the u-shaped track only.

Please note: If there are 12 races at Angle Park, Gawler or Murray Bridge there will be NO trials.

The Angle Park Vet Clinic and/or swab kennels cannot be used to accommodate any additional greyhounds due to operational requirements of the Clinic and Stewards.

It is vital that trainers nominate to trial at these race

meetings. If you are unable to nominate at these times, please contact GRSA as soon as possible as permission may be given at GRSA's discretion to accept bookings outside these times.

Exceptions to this policy

Thursday nights are kept available for interstate greyhounds to solo trial in a lead-up to SA Group races as well as local greyhound's trialling for Group racing interstate.

Upon request, local greyhounds will be allowed to solo trial in a lead-up to a feature race and they will take one of the eight (8) kennels available for trialling greyhounds ahead of the policy and sit separate to the four (4) dog trials. Races considered to be a feature are: Adelaide Cup, Gawler Cup, Oaks, Derby, Howard Ashton, Brian Johnstone, SA Sprint, SA Distance Championship, SA Anniversary Cup, SA Country Cup, National Finals and any interstate Group race

Local greyhounds will be permitted to trial on a race night, where they are in preparation for a feature event, nominated for a meeting and the race does not stand up. This will include all distances and also take precedence over the policy. If a greyhound qualifies for a feature final and requires a trial in between, this will be conducted as a solo trial and will sit separately to the four (4) dog trials.

MOUNT GAMBIER SATISFACTORY TRIALS

Trainers are advised of a change to the booking of Satisfactory Trials at Mt. Gambier. Mt Gambier hold trials on Tuesday and Saturday mornings with Satisfactory trials ONLY being conducted on Tuesdays and need to be booked with Barry Shepheard from the Club on 0419 824 512.

At Race meetings Satisfactory trials can be done when less than 12 races. When there are 12 races these can be considered, however, the trainer will not be able to kennel and must take their greyhounds home straight after the trial. These race day trials will also need to be booked through Barry at the Club. GRSA administration staff will NOT accept these bookings and trainers will be directed to contact Barry Shepheard.



How do I register an account to book public trials online?


Visit www.trialbooker.com, click on the "register an account" link and fill in the appropriate details.

How do I book a specific trial online?

As soon as you have pressed the Book button, those trials are booked and yours to keep. You then customise the distance, number of dogs, and type for each trial, and confirm them

Field Trials

Existing field trials will appear in each block. To book a dog in an existing field trial simply click the Book 1/2/3 button.



If there are no available field trials of the distance and type you require then feel free to create one yourself. Simply book a slot as-per-normal and select Maiden Field or Performed Field, as shown below.



Note: booking a dog or several dogs in a field trial counts as 1 trial towards your 4 trial maximum.

When do trial bookings commence each week?

Bookings for meetings will commence at 11.30am the working day prior to the trial session (henceforth known as "booking opening time").

Is there a limit to how many trials I can book online?

Yes: 4. If you wish to reserve more than 4 trials a session then you must phone the office as per normal. For example, in the screenshot below, it indicates that you can book 3 more trials using TrialBooker without phoning.

Can I book trials for other licensees? No—under no circumstances may you book trials for anyone other than yourself using TrialBooker. Dogs must be brought in and paid for by the person whose name they were booked under. If you wish to share a non-field trial with another trainer you must book over the phone.

How can I book a trial if I don't have access to a computer?

You can still book trials by calling the office after booking opening time.
